Journalist murder 4 PBCP men arrested at Dumuria

Dumuria police yesterday arrested four persons in connection with journalist Nahar Ali murder.

The arrested were identified as Goshta Bihari, 30, Nagendra Mondol, 23, Dipankar Mondol, 28, and Nepal Mondol, 31.

Nahar Ali had strained relations with members of the outlawed Purba Banglar Communist Party (PBCP) and a section of policemen of Dumuria thana because of his several stories carried by Dainik Anirvan against crimes, said his

The arrested belonging to PBCP were placed on a three-day remand vesterday.

Meanwhile, journalists of Dumuria have announced a sevenday programme in protest against murder of Nahar Ali.

Inqilab reporter assaulted in Khulna

A journalist was assaulted allegedly by Awami League activists at Picture Palace Crossing in the city yesterday.

Police said Muniruddin Ahmed, staff reporter of the daily Inqilab, Khulna office, came under attack while he was performing his professional duty in the area.

Meanwhile, city BNP at a rally condemned the attack and demanded exemplary punishment to those involved in the incident.

On the other hand, Awami League and its youth front Jubo League declared Muniruddin Ahmed persona non grata in the city for his alleged indecent remarks about Prime Minister Sheikh Hasina.

One gets life-term for killing girl in Bagerhat

UNB, Bagerhat

A court here on Monday awarded a man life-term rigorous imprisonment for murdering a girl.

Additional District and Sessions Judge M Aftabuddin also fined the convict, Rabiul Sardar, Tk 5,000, in default, to suffer an additional six months' RI.

According to the prosecution, Rabiul, hailing from village Joymonirkhol in Mongla upazila, strangulated his 9-year-old cousin, Lovely on October 7, 1996.

In another judgement on Monday the same court awarded eight people 10 years' RI each in a launch dacoity case.

The convicts are: Zakir Hossain, Harun Hossain, Rafigul Alam, Jahangir, Alamgir, Mahedev Biswas. Shahidul Alam and Jalal Hossain.

The prosecution said the convicts committed piracy in 'ML Al-Ansari' launch on December 3, 1997.

9 JCD leaders & workers get 4yrs' RI in Rajshahi

Nine leaders and activists of BNPbacked Jatiyatabadi Chhatra Dal (JCD) were sentenced to four years rigorous imprisonment and fined Tk 10,000 each.

Judge of the tribunal dealing with cases under Public Safety Act Narendra Chandra Das gave the verdict on Sunday.

According to the proceedings of the case, the accused along with their associates ransacked the local Awami League office, beat Chhatra League upazila unit president Shariful Islam and snatched his wrist watch on May 20, last year.

Bagha upazila AL president Abdus Samad filed a case in Bagha thana the same day under Public Sefety Act against 24 leaders and activists of the JCD.

Police submitted charge sheet against them and the judge found nine of them guilty after examining the witnesses. Fifteen were acquit-

ted of the charges. The convicts are Shahidul Islam, Selim Arif, Shahbaj, Siddique, Badsha, Rabiul, Scruzzaman Russel

and Latif.

Prime Minister Sheikh Hasina will inaugurate a new ferry service over the river Meghna connecting Harinaghat river port of Chandpur with Alubazar port of Shariatpur

The commissioning of the ferry service will open up a new vista in the country's communications network as it would reduce the distance between the Chittagong Sea port with Mongla port by 130 kilometers.

Talking to BSS, the Minister of State for Shipping Mofazzal Hossain Chowdhury Maya, Bir Bikram, said the Chandpur-Shariatpur ferry service project was taken up at the initiative of Prime Minister Sheikh Hasina for easing the traffic pressure on the Dhaka city as well as opening a new route connecting the southeastern region with the southern districts.

He said Bangladesh Inland Water Transport Authority (BIWTA) has taken a five-year project at a cost of Tk 6 erore for dredging and construction of landing platforms.

Maya said under this project, two row-row ferries would be procured with assistance from government of the Netherlands at a cost of Tk 109 SEE PAGE 11 COL 3

Resentment is growing among people in the port city due to police inaction after assault of two journalists of daily Purbakone by Mamunur Rashid Mamun, a cadre of Jubo League, youth front of ruling Awami League. The two newsmen were assaulted at the newspaper office on the night of

April 18. Police are yet to arrest Mamun though a case was filed against him with Panchlaish thana under the Public Safety Act (PSA) in this connection. There are also about two dozen criminal cases and warrants of arrest

against him, sources concerned said. Mamun, aWard Commissioner, moved freely and had visited Chittagong Circuit House several times to meet a minister who was blamed by residents

for allegedly sheltering him, the sources claimed. But in police record, Mamun was shown as 'absconding'.


The sources claimed that he was not arrested from the Circuit House as green signal' was not received from Dhaka. Interestingly, police got 'green signal' on April 22 (Sunday), the day he left

for Dhaka, a source in the police administration said. On the night of April 22, CMP police made 'raids' at his residence and at his 'special room' at 'Harbour View', a posh hotel near GEC crossing but

could not arrest any of his armed cadres. Police however said hunt is on and messages have been sent to Dhaka to arrest Mamun.

It is alleged that the hotel room is under his possession. He meets his cadres and other people there.

Shell hopes to complete South Sangu drilling next month

Shell Oil is expected to complete work in the troubled South Sangu gasfield in the Bay of Bengal in mid-May, more than one year behind schedule.

Sources said the company currently slowed down its drilling work, as it reached the 'unpredictable' high-pressure zone. It has reached a depth of 3700 metres and now looks forward to hitting the prime target of 4600 metres in mid-May. Shell expects to discover oil at that depth, the sources informed.

After beginning the South Sangu drilling with a budget of 11.5 million dollars in late 1999 with a target to complete it by three months, Shell discovered an extension of the Sangu gasfield in January 2000.

Until early April, it continued drilling there hoping to strike an oil field. At that time, due to technical and unprecedented geological

difficulties, the drilling string of Shell's rig got stuck. As a result, Shell had to abandon the expensive string. "It is now drilling a well parallel

to the abandoned original well. Contraband items

Satkhira police seized contraband items worth over Tk 2.50 crore from Bhomra Land Port on Sunday.

The contraband goods were

bound for Dhaka in two trucks. According to police, the seized goods are 12,000 kilograms of Indian three-piece instead of 2,400 kg loincloth as declared earlier.

Police said, some customs officials are involved in the smuggling.

They said that the goods were imported by Messrs M&SB Traders of East Jurain, Dhaka by forged documents.

"This is a crucial time for the operation, as the two wells are close to each other. A hasty operation would increase the risk of breaking into the original well and cause an explosion. That's why Shell is proceeding very slowly, the source added.

Shell started re-drilling the gas field in an alternative way in mid-2000 and expected to complete it within a few months. The new drilling does not cost Petrobangla anything additional, as the whole drilling operation was insured.

South Sangu is the first operation of Shell Oil in Bangladesh after it acquired 50 per cent of Cairn's interests in the country in 1999, including the gas-producing offshore Sangugas field.

Khaleda tells govt Quit instead of 'instigating' anarchy

Opposition leader Khaleda Zia yesterday asked the government to quit immediately dissolving parliament instead of instigating anarchy in the country.

"Hand over power to a caretaker administration forthwith conceding popular demand, shunning conspiracy, killings and fascist action,' she said to the government while hailing people for observing hartal for a second consecutive day.

The BNP chief accused the government of letting loose "state terrorism and perpetrating killings. She observed that the government became desperate in the face

of mass movement and was "killing people frequently like birds." Khaleda alleged the government was also harassing opposition

leaders and workers by arrest, repression and filing false cases. In her statement, the former

Pakistan's military rulers warned political leaders vesterday not to travel to the southern city of Karachi for a banned pro-democracy rally on (PPP). May 1, saying that if they did they would be arrested. "We are not going to allow other

political leaders to travel to Karachi to take part in the rally and if they defy that order we're going to arrest them," Brigadier Mukhtar Sheikh, told Reuters. "We will not allow the rally

because political rallies are banned in the country and we fear that politicians are going to exploit the situation," he added.

Karachi is the Sindh provincial capital and Pakistan's largest city. Opposition politicians earlier meetings.

said that they would still attempt to hold the rally, part of a campaign to demand the military government step down and restore democracy, and that they had sought official permission.

Koizumi poised to Jayalalitha barred from become next PM

Dealing a blow to Japan's political elite, maverick reformer Junichiro Koizumi defeated a former premier to win the ruling party presidency yesterday, guaranteeing his election as the next prime minister.

The 293-155 vote by party members over former Prime Minister Ryutaro Hashimoto capped a stunning upset by Koizumi, who was hoisted to the pinnacle of the Liberal Democratic Party by an overwhelming show of support by rank-and-file members in the primaries.

The election of Koizumi reflected growing public disgust with the political establishment and the sour economy, and the LDP's desperate attempt to revamp its stick-in-themud image ahead of upper house Parliamentary elections this sum-



"This election was held against an unprecedented headwind,' Koizumi said in accepting the post. "I promised to change the party and SEE PAGE 11 COL 1

contesting election AP, Madras

A popular southern Indian politician appealing a corruption conviction was prohibited yesterday from running for the Tamil Nadu state assembly and rioting broke out.

Jeyaram Jayalalitha, a former movie star, had filed nomination papers to run in four assembly districts and election officers in three of the areas rejected applications that had been filed by her or her party members. Indian law prohibits people convicted of a crime that carries a sentence of

more than two years in prison from running for office. Legal opinion had been divided, however, on whether the ban would be applied to Jayalalitha. Her three-year sentence in a land deal corruption case, stemming from her previous term as the state's highest elected official, has been suspended while she appeals her conviction.

Her supporters rioted when she was convicted. Shops and buses were damaged in Madras, the state capital, shortly after Tuesday's news that she would not be allowed to seek office from two constituencies. Indian law allows politicians to run from more than one district, and one

more election officer was still to be heard from. KS Jaya, the election officer for Krishnagiri constituency, made a simple announcement yesterday, saying, "Ms. Jayalalitha's nominations have been rejected under the powers bestowed in me by the 1997 Directive of the Election Commission."

Islamabad should sign CTBT: Benazir

Pakistan's exiled former premier Benazir Bhutto said yesterday Islamabad should sign the global

pact banning nuclear weapons tests. Bhutto told Reuters in an email interview received via her media office in Islamabad that Pakistan should have signed the Comprehensive Test Ban Treaty (CTBT) in 1998 after it declared itself a nuclear power.

When asked if Pakistan should sign the CTBT, Bhutto said: "Yes, betterlate than never."

Police arrested one Pakistani national on Sunday at Mawna Square under Sreepur upazila on charges of his alleged involvement in a fraud.


Police said the arrested person had claimed to be Nur Hossain of Model Colony of Karachi although he could not produce any passport to verify that.
