## BNP to ask Speaker to declare SQ Chy's seat vacant

BNP will soon send a letter to the Speaker asking for "appropriate action" against Salahuddin Qader Chowdhury MP, who was expelled from the party on May 10 on charges of breaking party discipline and acting against its interests.

The main opposition party will apprise the Speaker of SQ Chowdhury's expulsion from the party and request him to refer the matter to the Election Commission for vacating his Chittagong-7 seat.

Sources said the party high command is yet to instruct the leaders concerned to draft and send a letter to the Speaker. "The tenure of the present parliament has almost ended, but we must have to write to the Speaker to refer the case of Salahuddin Quader Chowdhury to the Election Commission," said a senior BNP leader.

Maybe, the tenure of the parliament will end before the issue is resolved, but there is no reason to keep silent, he added.

Parliament membership of the expelled BNP leader would be

cancelled as per the provisions in article 71 (1) of the Constitution and the BNP constitution as well.

## Fazlul Karim made judge of Appellate Divn

Justice Fazlul Karim of the High Court Division has been appointed a judge of the Appellate Division of the Supreme Court, highly placed sources said yesterday.

His appointment by the President on recommendation by the Prime Minister will be made public by a gazette notification today. He will take oath tomorrow, the sources added.

Justice Karim was the third judge of the Death Reference Bench in Bangabandhu murder case.

## Shazneen case Proceedings adjourned till June 3

Mojibur Rahman, ASP of CID, first prosecution witness as well as complainant in the Shazneen rape case, was cross-examined in the Special Court for prevention of Women and Children Repression, Dhaka yesterday.

After one hour cross-examination by the lawyers for accused Minu and Parvin, Judge M Shah Alam Miah adjourned the proceedings till June 3 as the witness fell sick in the dock.

During the cross-examination, Mojibur Rahman said that he investigated the Shazneen murder case impartially. The high officials of CID supervised during the time of investigation into the murder case, he added.

## 'Border disputes should be resolved as per Mujib- Indira Accord'

Speakers at a seminar yesterday felt that all border disputes with India need to be resolved immediately in line with the Mujib-Indira Accord to prevent fresh conflicts as well as maintain a tranquil border between the two neighbours.

They also felt that military training should be made mandatory for the general public, which could put Bangladesh in a better position to preserve its territorial integrity.

They all lauded the recent action of the Bangladesh Rifles (BDR) in repulsing the intrusion into the Bangladesh territory by the Indian Border Security Forces (BSF) and said it was an unwarranted action by a big and friendly neighbour.

Nearly one hundred speakers took part at a daylong seminar on "Recent Border Dispute: Clashes between Bangladesh and India", organised by the Centre for Strategic and Peace Studies (CSPS) at the CIRDAP auditorium yesterday.

Major General (rtd.) Ezaz Ahmed Chowdhury, former Director General of Bangladesh Rifles, read out the keynote paper while CSPS Executive Director Major General (rtd.) Syed Muhammad Ibrahim, Bir

Pratik, moderated the seminar. Chairman of the Centre Commodore (rtd.) Ataur Rahman summed up the seminar proceedings.

Major General (rtd.) Ezaz said that the resolving of the long-standing problem of border demarcation may help avoid such disputes in future.

"An effort should be made to make the people of Bangladesh and India realise the importance of resolving the border problem in the interest of maintaining harmony. Border conflicts generate unnecessary bitterness," he said.

Several speakers said the recent intrusions were not expected of a large neighbour like India and held it responsible for failing to maintain good relations with all its neighbours.

Abul Ahsan, a former foreign secretary and the first Secretary General of SAARC, pointed out that India has borders with all the South Asian countries, but it has bitter relations with everyone.

Major General Golam Dastagir, another former BDR chief, said that it was an absolute fallacy to propa
