

Hearing on writ challenging PSA begins

Hearing on the first writ petition challenging constitutional validity of the Public Safety Act (PSA) began in the High Court (HC) yesterday.

A Division Bench of the HC comprising Justice MA Aziz and Justice Mohammad Shamsul Huda is hearing the writ filed by Barrister Abdur Razzaq on behalf of Afzalul Abedin and others, all activists of Islamic Chhatra Shibir.

They were arrested in a case filed against them under the PSA at Dinajpur late last year.

Razzaq challenged validity of the PSA passed by parliament as a finance bill, certified by the Speaker and cited a Bangabhaban statement that it was assented to by the President as it involved the question of monetary expenditure, but not as

PM addresses Brussels conference Dhaka's 4-pt proposal to improve lot of LDCs

UNB, Brussels

Prime Minister Sheikh Hasina tabled a 4-point proposal seeking debt waiver, increased aid from the rich nations and other special measures to improve economic status of the world's 49 least developed countries (LDCs) representing 600 million people.

"We're standing at the crossroads of the future development of LDCs. If we take the right course, this could be the start of a new journey to end injustice, inequity

stagnancy, deprivation and ever-growing marginalisation of the LDCs," she said as a weeklong summit meet open here yesterday morning to determine fate of the poorer nations in the globalised

economy.

The LDC-111 Conference got off to a formal start at the Paul Henry Speak Building of European Parliament in the Belgian capital. The Bangladesh prime minister placed the proposals before the

Border along 4 southeastern districts Smugglers transact goods worth over Tk 100cr a day

be named.

On the other hand, electronic goods, versailles, aluminum, kerosene and Hilsha fish are smuggled out into India through the same routes.

The recent Indo-Bangla border tension could not put any brakes on the illegal trade even for a single day, said an official at Bouara in Comilla.

During a visit last week, small groups of goods transporter were seen carrying baggage loaded with various Indian goods and crossing the border at Bibir Bazar, Choudhogram, Bouara and Shashital points in Comilla.

"The smugglers have no day or night; they can continue their operations under any circumstances," a BDR officer told The Daily Star at

Bouara Bazaar, adding that such clandestine operations by the illegal traders in this belt are unbounded.

This zone covering four bordering districts of Brahmanbaria, Comilla, Feni, and Khagrachari has as many as 50 places known as illegal trading points. Besides, the government has only two customs stations and one corridor for legal cattle trading.

On average, Tk 1 crore is being deposited with the public exchequer a month as import duties collected from various consignments at the two customs stations- Akhaura in Brahmanbaria and Bibirbazar in Comilla, said a senior customs

Mamata breaks silence, makes allegations

Dramatics continued yesterday at the 7C Harish Chatterjee Street, the residence of Mamata Banerjee and the Trinamool Congress headquarters. After making the media wait for more than seven hours, the Trinamool supremo finally came out of a self-confinement. She looked devastated.

"I have to accept the verdict of the people," was the way she began.

When prompted a little to explain the cause of such a debacle, Mamata said, "Everybody was involved in a conspiracy to destroy the Trinamool Congress - the state government, the Election Commission and even the central government. It was expected that the state administration would be against us. However, I am surprised at the way the central government played an anti-Trinamool role. The BJP and its allies got back at me and my party for quitting the NDA. Along with that the EC also did not play an impartial role."

Time and again she lamented that she had misunderstood the behaviour of the masses. "I am really surprised at the way the voters behaved. If they had been against us why did the party leaders get such a huge reception

Jayalalitha to form govt despite criminal record

An Indian governor yesterday invited an actress-turned-politician to form the government in Tamil Nadu state, despite controversy over her criminal record.

According to a statement put out by the office of Tamil Nadu Governor Fatima Biwi, Jayaram Jayalalitha, 53, who heads the All India Anna Dravida Munnetra Kazhagam (AIADMK) party in Tamil Nadu, would be sworn in as the chief minister.

The AIADMK and its allies won a sweeping victory bagging 80 per cent of the state assembly seats during the May 10 provincial elections.

"Jayaram Jayalalitha met the governor today intimating her election as the leader of the AIADMK legislative party," said the statement.

"The government has invited her to form the ministry at the earliest and asked her to send the list of persons to be appointed as ministers with their portfolios," added the statement.

According to sources, with the governor's invitation, Jayalalitha could be

BSF cordoned off 30 enclaves after Roumari clashes

NAIMUL HAQ, Back From Lalmonirhat

The Indian Border Security Force (BSF) reportedly cordoned off 30 enclaves north of Lalmonirhat following the Roumari skirmishes on April 18 and 19.

According to local people and other sources, the BSF dug more than 150 bunkers around the landlocked enclaves inside the Indian territory, where more than 10,000 Bangladeshi live.

"The BSF mobilised heavy artillery around the enclaves and were digging bunkers," said Sudhir Mia, a resident of the Dahgram-Angarpota enclave.

"My cousins live in Chit Sirampur. On the night of April 20 we received news from a villager there that the BSF have moved inside their enclave and forced the

It's time for post-mortem

Electoral battle in five Indian states, including West Bengal, is over. There were surprises indeed, not so much in the outcome - broader predictions made by most opinion and exit polls proved more or less right - as in the margin that separated the victor from the vanquished.

The elections brought the best news for Sonia Gandhi and her Congress, the principal opposition party. The Congress stormed back to power with two-thirds majority in Kerala, inflicting the worst electoral defeat on the ruling Left Front led by CPI (M). It was set to regain the reins in Assam in the north-east humbling ruling AGP and its ally BJP and in federally-ruled territory of Pondicherry where the poll produced a hung assembly.

PP Quamrul withdrawn from another case

Mohammad Quamrul Islam, Metropolitan Public Prosecutor, Dhaka was withdrawn from the Fazlul Haq Murder Case pending with the Second Additional Metropolitan Sessions Judge's Court, Dhaka for his negligence in conducting the case.

Earlier, PP Quamrul was withdrawn from the Jalal Ahmed Shafi Murder Case on the same ground.

The solicitor of the ministry of Law, Justice and Parliamentary Affairs, withdrew Quamrul from the case on May 10 following an application by Mohammad Selim Reza, the complainant of the case on May 7.

In the application, Reza said that his brother Fazlul Haq was shot dead at his Gulshan residence by a group of armed men on March 3, 1998. Later he filed a murder case with Gulshan thana accusing 20 people including Abul Bashar, the notorious criminal in the area.
