FEMA to involve local people Campaign to help prepare an accurate voter list

Fair Election Monitoring Alliance (FEMA), a non-government organisation dealing election affairs since 1995, yesterday launched a campaign to mobilise people to help prepare an accurate voter list in the country.

The aim of the campaign, as FEMA officials put it, is to make people aware of ensuring their respective names in the voter list that will be displayed at union level shortly by the Election Commission (EC) for perusal by political parties and the voters as well.

"FEMA aims to include all the adults in the voter list through the campaign," Abul Ahsan, chairperson of FEMA, told a press briefing at the National Press Club. He also said the campaign will help people understand how to be included in the voter list if he or she has been

missed out or dropped from the existing list for some reason.

The EC has already completed the printing of voter lists with a total of 7,48,23,984 voters in the country, but there are scopes to include the names of voters who were dropped from the list, FEMA sources said. Fake voters can also be excluded from the list.

The FEMA campaign titled "Let Us All Make the Voter List Actual" will try to include the grassroots people by involving local elite and politicians and other professionals in its activities. FEMA staff will help the local people and provide them with posters and guides in this regard.

Eminent journalist ABM Musar Maj Gen (ret'd) Ibrahim, FEMA Vice Chairperson Munira Khan and Secretary General Feroz M Hassan also spoke on the occasion.
