

9 HC judges call on President

Ctg port worker leaders invited for talks

The government has invited the leaders of 22 workers' associations of Chittagong Port to sit for talks on Thursday to avoid possible standoff at the country's main import-export gateway.

Twenty-two workers' associations, including ruling party-backed Collective Bargaining Agent (CBA), of the port at a meeting Sunday night had threatened to launch the tough action programme from Friday if their six-point demand is not met by Thursday.

State Minister for Shipping Mofazzal Hossain Chowdhury Maya urged the leaders to sit for negotiation when a delegation apprised him of their demands. Maya assured them of fulfilling the demands in phases.

Musharraf accepts Vajpayee's offer for peace talks

Pakistani military ruler Gen. Pervez Musharraf yesterday formally accepted India's offer to hold peace talks over the disputed Kashmir region and other issues saying good bilateral relations were important for economic development.

"I accept your invitation to me and my wife to visit India with great pleasure," Musharraf said in a letter to Indian Prime Minister Atal Bihari Vajpayee.

"We wish to see a stable prosperous India at peace with its neighbours," the letter said.

"Pakistan has always sought to establish tension-free and cooperative relations with India, so that our two peoples may be able to devote their resources and energies to the task of economic and social development," it said.

Musharraf's letter came four days after Vajpayee broke a two-year lull in high-level talks between the two rival nuclear powers by

inviting the Pakistani leader to India. While announcing the peace invitation, India at the same time said it was ending a six-month cease-fire in Kashmir a move that drew sharp criticism for Pakistan. The Himalayan region is claimed by both nations. Two of the three wars fought between India and Pakistan since independence in 1947 were fought over Kashmir.

In his letter yesterday, Musharraf said he looks "forward to sincere and candid discussions... to resolve the issue of Jammu and Kashmir in accordance with the wishes of the Kashmiri people." Jammu Kashmir is what the state is called in India, which controls two-thirds of the disputed region.

Musharraf said Pakistan is also "ready to discuss all other outstanding issues between our two countries as well."

It was not immediately clear

when the meeting between Vajpayee and Musharraf would take place. Nor was it clear if representatives of Kashmiri militant groups, which are fighting for either independence or merger with Pakistan, would attend.

Reuters adds: General Musharraf said the disputed territory of Kashmir would be central to his promised talks with India, but he remained open to discussing other issues.

Musharraf, in an interview with the BBC of which extracts were broadcast yesterday, paid tribute to what he called the vision and courage of Atal Behari Vajpayee in calling for the talks.

"I am very flexible. I have been saying that the core issue is Kashmir and let there be no doubt in that, but there are other issues also and I have no reservations at all. I have no problems in discussing other issues also," Musharraf said.

Flag meeting BSF assures BDR of dismantling groyne on Mahananda

The Border Security Force (BSF) yesterday assured the Bangladesh Rifles (BDR) that it would dismantle the groyne built on the river Mahananda, keep open the 'Tin Bigha Corridor' for 24 hours and ensure electricity there.

The assurance came during a flag meeting between the sector commanders of BDR and BSF at Tetulia Dukbunglow here in the morning.

The BSF also informed the BDR that it would develop tea garden outside the zero line of the border. The two sides also agreed to withdraw additional soldiers from their respective border areas and maintain friendly atmosphere.

BSF Rangpur sector commander Colonel Ferdous Ahmed led the Bangladesh side while BSF was represented by DIG of Shilguri sector Ajit Singh and DIG of Kuchibigarh sector M I Khan.

Besides, battalion commanders of greater Rangpur and Dinajpur districts Lt. Col. Abdul Kadir, Lt. Col. Salek, Lt. Col. Hassan, Major Zahid (acting) were present in the meeting.

Nuruzzaman tells court Khaled Mosharraf was not involved in jail killing incident

Cross-examination of ATM Nuruzzaman, third prosecution witness in the Jail Killing Case, by defence lawyers, was completed yesterday in the Special Court adjacent to Dhaka Central Jail.

Judge Ahmed Jamil Mostafa adjourned the hearing till June 4.

Four national leaders Syed Nazrul Islam, Tajuddin Ahmed, Captain Mansur Ali and AHM Quamuzzaman were murdered in the Dhaka Central Jail on November 3, 1975.

During the four hour cross-examination, Nuruzzaman told the court that jail killing was not done under the leadership of Brig Khaled Mosharraf.

He further said the names of 'meal culprits' involved in the jail killing were mentioned in the FIR of the case. He said he gave a judicial statement as a witness before a magistrate on October 20, 1996.

Nuruzzaman said Brig Khaled Mosharraf advised him (the witness) to file FIR on the incident on November 4, 1975.

The witness said that the upsurge under the leadership of Brig Khaled Mosharraf and Shafayet Jamil was not aimed at capturing power and the four national leaders were not killed with the help of the then jail authorities.

Nuruzzaman said he was promoted to the post of Inspector General (IG) in 1973 during the rule of the Awami League Government.

He further said that he neither committed any offence under the Penal Code nor assisted the five killers in murdering the four leaders inside the jail.
