## BNP wants army to carry out combing operation

BSS, Dhaka

BNP leaders yesterday demanded that the army be engaged in the combing operation to recover illegal arms and arrest identified terrorists to help create a conducive environment for free and fair polls.

If the army is not used to improve the law and order situation, fair polls cannot be held, they observed. They said if required arms can be recovered through issuance of public notice.

Briefing newsmen at the Banani office they said the controversial Election Commissioner should be relieved of his duty immediately for free and fair polls. They said newsmen and polls observers should have access to all polling centres and offices of the Returning and Assistant Returning Officers across the country.

Reazuddin Ahmed, press advisor to BNP chairperson, member secretary of Election Steering Committee Haris Chowdhury and Mofazzal Karim spoke at the briefing.

BNP leaders charged the AL terrorists with using legal and illegal arms across the country and said some of them have already been arrested. They said one of their cadres was arrested in Barisal with AK-47 rifle. Besides, they said, son of one of their ministers was arrested with a consignment of arms, and arms have been recovered from a car of AL leader Shamim Osman's convoy by members of the army. They said

arms have been recovered also from a car of JSD leader Hasanul Huq Inu.

They said several BNP leaders, including Col (Retd) Oli, Salahuddin Kader Chowdhury, Giasuddin Kader Chowdhury, Khondker Mahabub Uddin Ahmed, S A Khaleque, Hafez Ibrahim and Iqbal Hasan Mahmud came under attacks from AL men in different places, including Chittagong, Sirajganj and Dhaka.

BNP leaders demanded immediate transfer of SP of Sirajganj and posed the question as to whose interest he was serving through imposition of section-144 in Sirajganj.

They also protested the arrest of nine BNP men and harassment of many others at Bagerhat. They demanded their immediate release.
