**JU admission  
Forms to be distributed  
from November 1- 22**

Distribution and submission of forms for admission tests of 2001-2002 session of Jahangirnagar University (JU) will begin from November 1 and continue till November 22, official sources said.

The decision was taken at a meeting of the JU Central Admission Committee yesterday. Vice Chancellor Prof Abdul Bayes presided over the meeting held at council room of the Administrative Building.

Admission forms will be available at Agrani Bank Branches at JU, National Museum and Farmgate. The admission forms of all four faculties will be sold at Tk 200 each.

The university has seats for some nine hundred students in 24 departments under its four faculties- Arts, Science, Social Science and Life Science.

The admission tests will be held from January 5 to 10 and results will be published on January 31, 2002. The viva-voce of the successful candidates will be held between February 9 to 11. Admission from the merit list will take place from March 3 to 10, and from the waiting list from March 18 to 28.

Classes of the 2001-2002 first year honours classes is most likely

to begin on April 18 next year. Enrollment in vacant seats that will be left over will take place from May 11 to 16, sources added.

Meanwhile a section of teachers and students of the university brought out a silent procession on the campus yesterday to protest attacks on minority community across the country. The JU teachers under the banner of 'Shikhhak Samaj' organised the procession.
