4000 MT of rice to be distributed under VGF programme

UNB, Dhaka
Disaster Management and Relief Ministry on Tuesday allocated some 4,000 metric tons of rice for distribution among destitute people in Rajshahi division under VGF programme.

The ministry allocated the grain against two lakh VGF cards, which is in addition to 2,000 mt sanctioned against one lakh VGF cards for eight districts of the division, according to a PID handout.

Each VGF card-holder of flood and tornado affected families of the northern region will receive 10 kg of rice during the Bengali months of Kartik and Agrahayan.
