Govt urged not to export gas

Speakers at an open discussion on the Dhaka University campus yesterday threatened to launch tough action programmes if the government takes any step to export gas.

They urged the government to set up gas-based industries including power plants, fertilizer and other agro-industries in the country instead of exporting gas.

They said any decision to export gas to India through pipeline would be tantamount to betraying the nation.

People did no give the BNP-led four party alliance a mandate to sell out natural resources of the country to a foreign country, they said.

Organised by the 'Publicity cell to resist oil and gas looting', the discussion was held at the DUCSU cafeteria.

SURR withdraws indefinite strike at JU

The Students' Unity for Resistance to Rapists (SURR) withdrew its indefinite strike yesterday following requests from the general students and teachers of the Jahangirnagar University (JU).

However, the organisation issued a one-week ultimatum to the authorities to meet their sevenpoint demands. It threatened to launch a tougher agitation programme if the authorities fail to meet their demands by November

Appreciating the good gesture of the SURR leaders, the JU Vice Chancellor said he would look into their demands.

The announcement of withdrawal of strike came from a rally held at the Social Science Faculty Chattar in the morning. The strike

continued for 69 days. Addressing the rally, the SURR leaders accused some top officials of the university of buying time in the name of talks.

Meanwhile, eleven JU teachers observed that the authorities are mainly responsible for creating a stalemate on the campus.

In a statement signed by the 11 teachers, they said, "The authorities have created the deadlock by allowing an alleged rapist to sit for examination and by expelling some leaders of SURR.'

To restore a congenial atmosphere, they said, the authorities must withdraw expulsion order on SURR leaders, introduce antisexual harassment act and take steps to ensure a campus free from rapists and terrorists.

Cargo transport Concern over surcharge hike

Bangladesh Fruits, Vegetables and Allied Products Exporters' Association has expressed concern over hike in insurance surcharge on cargo transport by air.

Bangladesh Biman imposed an additional Tk 2.85 insurance surcharge against every kilogram of cargo transport in view of the US airstrikes on Afghanistan.

The exporters' association in an emergency meeting yesterday discussed the impact of the surcharge and demanded immediate withdrawal of the surcharge hike.

The meeting was presided over by Mohammad Mansur, acting chairman of the association. General secretary Syed Salahuddin Mamun, joint secretary S M Jahangir, and treasurer Abdur Rob

Bhuiyan was also present. Protesting the decision, they said that this new charge would hamper vegetable export as this is totally dependent on air transportation.

The meeting was told that a Biman flight on Dhaka-Doha route yesterday left Dhaka without taking any export cargo due to hike in insurance surcharge.

They observed that the surcharge hike would hit the vegetable export hard if the charge was not withdrawn soon.
