Govt criticised for removing Prof Azad Chy from DU

Immediate-past vice-chancellor (VC) of Dhaka University Prof AK Azad Chowdhury has reprimanded the government for the process it followed in removing him and appointing a new VC.

"Why will an elected VC be removed through application of a century old law and another one be appointed on a temporary basis for four years," Prof Chowdhury questioned, while addressing a press conference at his residence on Tuesday.

The government has followed a British law dating back to 1897.

"Is this the reward for my relentless endeavour for development of the university?" he asked the government, referring to the academic developments carried out during his tenure.

"I don't lament for myself, but for the post of the VC and the university," Prof Azad said.

Newly appointed Vice-Chancellor of the Dhaka University Prof Anwarullah Chowdhury yesterday pledged to root out terrorism from the campus.

"I will take stern and punitive actions against troublemakers irrespective of their party affiliations," Prof Chowdhury told reporters at his office yesterday.

The university authorities will identify and take academic actions against terrorists as part of shortand long-term drives, and lawenforcement agencies take legal actions.

"All students are equal to me irrespective of their political choice and ideology," Prof Chowdhury assured.

All bona-fide students will be rehabilitated in their residential halls shortly, and coexistence among activists of all student organisations on the campus and in the halls ensured, he continued.




