





MPs demand Obaid's release on parole

Several lawmakers of the ruling party yesterday demanded immediate release of AKM Obaidur Rahman MP, now detained for the Jail Killing Case, on parole for participation in parliamentary

proceedings. Taking floor on the point of order immediately after resumption of the House in the afternoon, the lawmakers also demanded an explanation from the home minister as to why the veteran leader of the Bangladesh Nationalist Party (BNP) was not released despite the Speaker's ruling.

Mashiur Rahman, Abu Yusuf Mohammad Khalilur Rahman and Joynal Abedin Faruk of the BNP and Shah Mohammad Ruhul Quddus of the Jamaat-e-Islami spoke on the point of order. "The delay in releasing Obaidur Rahman is tantamount to contempt of the Speaker and the House," said Mashiur Rahman.

Earlier, Speaker Jamiruddin Sircar asked the home ministry to take proper steps to release Obaid on parole for participation in par-

lamentary proceedings. A member of the BNP standing committee, Obaidur Rahman was elected MP on a BNP ticket from Faridpur-2 constituency. He was arrested in the Jail Killing Case, now pending with the court, during the previous Awami League

'US, Bangladesh working for establishing peace'

US Ambassador Mary Ann Peters Two call attention notices paid a courtesy call on the newly appointed Foreign Minister M Morshed Khan at his office yesterday morning.

Later, briefing newsmen at his office, the foreign minister said they discussed the existing friendly relations between the two countries. Khan stated that people of the two countries have been working together for establishing peace across the globe.

The foreign minister said the people of Bangladesh stood by their American brethren during the need of the hour. He pointed out that there had been no specific agenda for yesterday's meeting.

Replying to a question whether Bangladesh troops would be deployed in Afghanistan, the minister said that the decision will be taken when such proposal comes.

But the minister unequivocally stated that the present government would do nothing that "goes against the interest of the people." "We will not take any decision that goes against the interest of the people of Bangladesh," he categorically said.

On the alleged exodus of minorities to India, the foreign minister said that there are reports of some criminals fleeing to India.

Emerging from the meeting, Mary Ann Peters said they talked about the existing relationship between the two countries and how the two governments could work together to strengthen the relationship.
