

Fakhruddin takes over as BB Governor

Dr Fakhruddin Ahmed yesterday took over as the eighth governor of Bangladesh Bank

According to a notification of the Banking Division Ahmed has been given a three-year contract with effect from November 24 2001, says a press release.

Ahmed obtained his Ph.D in Economics from the Princeton University, USA in 1975.

He was an officer of the erstwhile Civil Service of Pakistan of 1963 batch. He was Joint Secretary, ERD, Ministry of Finance from 1975 to 1978. Prior to his present assignment, he was Country Director as Regional Manager, South Asia Region of World Bank from 1997 to 2001.

During his tenure in the World Bank he served as Country Principal Officer, Principal Country Programme Officer, Chief Economist, Agriculture and Rural Development Operations, Operations Advisor and Country Director, Most of his work experience has been in economic management and poverty reduction issues in South Asia and East Africa region.

Life long state security for Hasina, Rehana

AL for tougher programmes if govt scraps the Act

Awami will go for tougher programmes if the government scraps the 'Father of the Nation's Family Members Security Act, 2001.

AL General Secretary Zillur Rahman said this while talking to The Daily Star last night after a joint meeting of the party's Presidium, Central Working Committee, Advisory Council and lawmakers in the city yesterday.

AL President and Leader of the Opposition in Parliament Sheikh Hasina chaired the meeting, held at Al 's election office at Dhanmondi.

At the meeting, Sheikh Hasina urged party leaders to revamp the party and build up movement against "unabated repression on Awami League leaders and workers and people by the ruling alliance", sources said.

On Wednesday, AL leaders held an emergency meeting and called an eight-hour hartal in the city on Sunday, protesting the government's move to scrap the Act under which Sheikh Hasina and her younger sister

Sheikh Rehana are enjoying life long state security.

Sheikh Hasina, who had earlier promised not to call hartal in the country nay more, was not present at Wednesday's meeting

At yesterday's meeting, senior party leaders explained under what circumstances they decided to call the hartal. In response. Hasing said there is no use of saving her

life when lives of people of the country are no more safe under the rule of the alliance government, meeting sources said. Besides senior party leaders, some 40 out of 58 AL

MPs also took part in the deliberations. The meeting however did not take any decision

hether the party will join the parliament session. The leaders agreed that there was no reason for party lawmakers to join the parliament session while the ruling alliance continued "oppression on party leaders and workers across the country"

Nov 13 gunfight on campus DU expels 4 JCD, 2 BCL activists

Dhaka University has temporarily expelled six students and declared them persona non grata on the campus for their involvement in gunfights at Jagannath and Zahurul Haq halls of the university on November 13.

A DU press release said that the decision was taken at a meeting of the Disciplinary Committee yesterday following submission of a probe report. Vice Chancellor Prof. Anwarullah Chowdhury presided over the meeting.

The university formed a probe body headed by the newly appointed proctor Dr Nazrul Islam after photographs of the armed men brandishing firearms on the campus on November 13 were published in national dailies on November 14.

The expelled students are Mainuddin Babu of the Social Welfare and Research Institute, Shahbuddin Munna of the Library and Information Science Department, Mithu, Farhad, Faysal and Sumon.

Of the expelled, Mainuddin Babu and Mithu are activists of Awami League's student front Bangladesh Chhatra League (BCL) while the four others belong to ruling BNP backed Jativatabadi Chhatra Dal (JCD), sources said

Jubo League leader, **AL** activist murdered in Netrokona, Ctg

A Jubo League leader and an Awami League activist were murdered in Netrokona and Mirersarai on Wednesday night.

The victims were identified as Swapan Joarder, president of Jubo League Netrokona district unit and Ashrafuddin Choudhury alias Morshed, an activist of Mithanala union unit of AL under Mirersarai upazila of Chittagong district.

Our Netrokona Correspondent reports: Swapan was shot dead by unidentified assailants at Taribazar in the district town at midnight Wednesday.

Witnesses said, the incident occurred when Swapan was talking to two persons in front of the AL

district unit office. The assailants reached there riding a motorbike and shot the Jubo League leader. He was taken to Mymensingh

The government has decided to scrap the two 'black laws'--Special Powers Act (SPA) '1974 and Public Safety Act (PSA) '2000 -- in the second session of the Jatiya Sangsad (JS). Sources said the BNP govern-

ment has already started the process to scrap the two laws as per its election pledge. The Prime Minister's Office has given necessary instructions to the ministries concerned for taking appropriate measures in this regard.

Besides, the government has also instructed cancellation of all

BNP insiders said the second session of the JS would be very important as a number of vital issues including scraping of the black laws and finalisation of women's reserved seats in the parliament will be tabled.

Talking to The Daily Star, a senior BNP leader said the government would implement all of its election pledges in phases as quickly as possible

The BNP government's 100-day programmes also promise cancellation of the two black laws.

Sources said repeal of the SPA and PSA is complex as thousands of cases filed under the laws are still pending. Some 8000 cases were filed under the PSA. So, the government is considering introduction of another law to settle these cases.

They said the home ministry following instruction from the Prime Minister's Office prepared a draft bill and sent it to the law ministry. But the ministry informed the home office that thousands of cases filed under the two laws are now SEE PAGE 11 COL 1

Businessman murdered, alleged mugger beaten to death in city

A businessman was murdered and an alleged mugger was beaten to death in the city yesterday.

A gang of miscreants slaughtered Anwar Hossain, 40, a pharnacv owner, while he was returning home in the early hours of yesterday. Anwar closed his pharmacy at

Lalkuthir Sishmahal in Mirpur area about 12:30 am and started for his residence at nearby Harirampur. On the way, some local youngsters led by one Tapan called him to a tea stall

One shot dead as **BNP** factions clash at N'ganj

A violent clash between two rival groups of the ruling BNP left one person killed and five others injured in Fatullah industrial area yesterday afternoon.

The incident occurred at 2.00pm

when an armed group led by Lavlu of Mission Para attacked a BNP activist. Abdul Karim. 35. son of Abdul Aziz at Kotalerbagh, leaving him fatally injured, sources said. Karim died on the way to the local hospital.

Witnesses said the gang dragged Karim down from the rickshaw he was travelling in and shot him in front of a large number of people. They left the scene by blasting crackers.

Lavlu was also injured in the forehead when the Karim group opened fire in retaliation and was taken to a local hospital in a critical condition. The injured four others belong to both groups.

Police rushed to the spot and

brought the situation under control. Yesterday's clash was the

second one in the last two weeks. The first clash also between the factions of the BNP left one schoolboy killed in DIT area in the town.
