

HC issues rule on govt

A High Court division bench issued a rule on December 12 asking the government to explain within four weeks under what authority Manjurul Ahsan Munshi, a loan defaulter, was elected member of parliament.

The bench comprising Justice Hamidul Haque and Md Iman Ali passed the order on a petition filed by Manjurul Islam, a voter of Comilla-4 constituency.

The petition said the ruling BNP MP was elected from Comilla-4 constituency, although he was declared a loan defaulter by a court in Chittagong prior to the October 1 election.

The rule was issued on the secretary of Parliament Secretariat, Election Commission and the MP.

Former law minister Abdul Matin Khasru appeared for the petitioner in the court.

Interim procedures for non-immigrant US visa

UNB, Dhaka

The US Department of State has put in place interim visa procedures for non-immigrant visas, which would be effective immediately.

The main impact of these interim procedures will be to delay processing of some non-immigrant visa applications. As a result, many business, tourist, temporary worker, exchange visitor and student visa applications will be affected.

The persons in the United States bearing expired non-immigrant visas planning a temporary visit to Bangladesh particularly over the Eid and Christmas school breaks and requiring a new visa to enter the US may wish to defer their travel plans or should be ready for considerable delay in the processing of their non-immigrant visa.

The procedures only apply to new visa applications and persons with expired visas who are applying for new visas will also be affected.
