Three killed in separate incidents

Three people were killed by the assailants in separate incidents recently in Bogra.

Police said an unidentified young man, 25, was strangled and the body was left in a crop field on Friday night at village Fulbari in Sadar upazila. Locals found the body on Saturday noon and informed the police who sent it to morgue for autopsy. On Thursday following a trifling matter Lipi Khatun, 28, daughter of Kalu Pramanik was beaten to death by her husband Jalil and his parents at village Hindukandi in Shariakandi upazila. In yet another incident rickshawpuller Sahfiqul Islam, 22, of village Sonka in Sherpur upazila was robbed and killed by the extortionists while returning home on Wednesday night. Separate cases were filed with the police.

Wife chopped to death by husband

UNB, Barguna

A wife was chopped to death allegedly by her husband at Agathakurpara village in Taltali upazila of Barguna on Thursday.

The victim was identified as Selina Begum, 31, wife of Waliullah. Locals alleged that Waliullah chopped his wife to death in an attempt to harass his rival Gahar Ali. There was a longstanding rivalry between the two over capturing khas land, they added. Police arrested Waliullah when he went to the police station to lodge a case in this regard.

Youth killed allegedly by father

A youth was allegedly killed by his father at Mastor village in Kalai upazila of Joypurhat on

The deceased was identified as Shahjahan, 16, son of Dola Miah, born of his now divorced first wife. Shahjahan was residing with his mother. Police said Dola Mia of Jontun village in the same upazila came to the house of his former wife at Kalai village and called out Shahajahan from his house. Later, his body was recovered from a bamboo cluster of the village on the following morning. Reasons behind the murder could not be known immediately. Police arrested Dola Miah in this connection. Police said Dola Miah left his first wife and his son 14 years ago and married twice later.

Old man succumbs to his injuries

An old man who was injured in an attack by his stepbrother on December 1 succumbed to his injuries at Khulna Medical College Hospital on Friday night.

The victim was identified as Chan Mollah, 75, hailed from Narail. Police said stepbrother Hamid Molla along with his accomplices attacked Chan Molla over a land dispute leaving him injured critically. Chan was first admitted to Narail Sadar Hospital and later shifted to Khulna Medical College Hospital in a critical condition. Hamid went into hiding soon after the incident. A case was filed with the police.

Valuables worth Tk 3 lakh gutted

Valuables of three shops worth over Tk 3 lakh were gutted in a devastating fire at Nizra

Jangal bazaar in Sadar upazila of Gopalganj on Friday night.

Witnesses said the fire originating from an oven of a sweetmeat shop soon engulfed the sweetmeat shop, a pharmacy and a grocery shop. Local people brought the blaze under control. Owner of the sweetmeat shop Akbar Mollah fled from the scene

Two alleged rapists arrested

A woman was raped in Station Road area of Sadar upazila in Jamalpur and two persons were arrested in this connection on Friday.

The victim hailed from Mymensingh was a divorced woman and mother of three children. Police said the victim along with another woman named Jakia Sultana came to Jamalpur to visit her relatives. While they were waiting in the station area Ranzu Miah. owner of a video shop took the woman to his shop with the help of Jakia and raped her.

Hearing the victim's screaming night guards of the town rushed to the spot and rescued her. Later, police arrested Ranzu Miah and Jakia and a case was filed.

Valuables worth Tk several lakhs looted

Pulse cultivation on 23, 920 hectares

An intensive scheme has been taken up to bring 23,920 hectares of land under pulse cultivation in four upazilas of Magura in the current season.

DAE has arranged supply of quality seeds, fertiliser, pesticides and other necessary agricultural inputs to the growers at fair prices to make the programme a success.

69 addicted people nabbed

Seven of the injured were admitted to Sirajganj General Hospital and other local clinics. A case was filed with local police in this connection and police arrested accused Kayes Uddin.

hats and bazaars. The richer section of people go to different supermarkets to buy warm clothes, but the low income group and poorer section gather at roadside shops to collect warm clothes to protect themselves from the biting cold of the winter.

Now a pullover is being sold between Tk 50 and 75 or more at footpath. But the rate is higher in

Abul Kasem, a winter clothes trader told this correspondent that they have been earning a good profit this year by selling old warm clothes.

Winter clothes are usually available at Basha Bari Market, Habib Market and at different footpaths of

Cold wave claims 6 in Thakurgaon

Pabna unit of Jatiyatabadi Lawyers' Forum faces feud

Grouping and lobbying over appointment of different government posts, including the post of government prosecutor and public prosecutor has resulted a severe internal feud in the pro-BNP Jatiyatabadi Lawyers' Forum in

Pabna. Since the BNP-led four-party alliance government took over power, incidents of formation of new committee by a group, expulsion and counter expulsion, statement and counter statement have attracted public attention in Pabna.

The grouping and lobbying has been going on for 20 such posts. In addition to the posts of government prosecutor and public prosecutor, 20 posts also includes the posts of special public prosecutor and assistant public prosecutor.

The district judge is yet to nominate lawyers for the posts while the list of the nominees is scheduled to

send the names to the Law Ministry within 31 of this month.

Some of the top leaders of the forum are now staying in Dhaka for lobbying. When asked Mirza Azizur Rahman, president of the newly formed committee of the forum admitted that initially there had been a bit misunderstanding among them. He, however, said that at present there is no conflict among them.

Activities of both the committees of the forum have been suspended and they have decided to confirm the appointment for the

posts through discussion, he said. District judge Md. Abdus Sattar Bhuyan said that he along with his colleagues has already started preparing a list of lawyers on the basis of their qualification. The district administration has also invited applications for nominating lawyers for the posts.

Unabated drug smuggling in tea garden areas

Checking of illegal drug smuggling in the tea garden areas of Moulvibazar and Habigani districts has apparently been failed due to lack of adequate manpower in the local Narcotics Control Department

Concerned sources said there are six circles of the department in the two districts where the number of posts is 38.

The main task of the department is to ensure proper distribution of liquor among the licensed shops for the tea labourers and check illegal production and trading of drugs and liquor in 119 tea

They said departmental activities apparently remained standstill, as there are allegations of massive irregularities in checking
