'Govt's 100-day programme heading for cherished goal'

UNB, Dhaka

A high-level meeting here yesterday reviewed the progress of implementation of the government's 100-day programme.

The meeting was told that the 100-day programme announced by the prime minister to speed up the pace of development activities was heading toward its cherished goal, said an official handout. Presided over by principal secre-

tary at the Prime Minister's Office Dr Kamal Siddigui, the meeting was also informed that the progress of implementation of work in all sectors had been expedited. It viewed that continuation of the present trend would help fulfil the prime minister's political commitment to the nation.

After a threadbare discussion on the programmes of different ministries, the meeting expressed the view that the 100-day programme could be implemented in time. It was told that as per the direc

Gas, fuel & power prices to soar from New Year's Day

Prices of electricity, gas and all sorts of petroleum products will significantly soar from January 1, 2002 that would trigger a sharp rise in the prices of essentials and other products, energy and mineral resources ministry sources said.

The government has come up with the decision to increase petroleum prices following a recent proposal by the Bangladesh Petroleum Corporation (BPC).

With the rise in fuel prices, each litre of octane will sell at Tk 30, petrol at Tk 28 and diesel and kerosene at Tk 17 instead of the existing rates of Tk 25, Tk 23 and Tk 15.55 respectively.

The government would also increase the domestic and commercial electricity tariff by Tk 0.10 and Tk 0.25 per kilowatt hour respectively as per a World Bank formula. The tariff for farm users would remain unchanged.

The prices of gas will also be increased by at least five per cent against a recommended hike of 10 per cent. For domestic users, the tariff for a single burner

oven will be Tk 300 and that of a double burner Tk 350. With such tariff hike, prices of other utility services would also increase sharply, officials concerned and

experts said The BPC has also proposed an increase in jet fuel (JP-1) price by Tk 4 per litre and furnace oil by 100 per cent to Tk 23 and Tk 13 respectively.

The immediate past Awami League government increased prices of petroleum products by 20 to 23 per cent that fuelled street protests by the then BNP-led opposition alliance, now in power.

Recently, the prices of petroleum products have been increased in neighbouring India, Sri Lanka and Pakistan

As for the power sector, the current rate of per unit of electricity is Tk 2.15 for domestic consumers, Tk 3.50 for small industries and Tk 4.65 for commercial use. The rate is Tk 1.75 for the farm users, which has remained unchanged for the last seven years. Except for the farm rate, all other rates would go up Tk 0.10 in case of domestic users and Tk 0.25 for commercial ones.

Two fire incidents Woman burnt alive, 150 shanties gutted

A woman was burnt alive and two other persons were injured in two fire incidents in the city yesterday. At least 150 shanties were gutted

in one of the incidents at a slum.

Jainab Bibi, 35, was killed when the electric motor she was operating caught fire and gutted a small factory and some adjoining warehouses near the Ansar camp at Mirpur Section 1 at about 9:30 am, police said.

Garments cut piece used to be turned into cotton at the factory. Waste paper and other goods were stored in the warehouses

Mirpur police recovered the body and sent it to Dhaka Medical College Hospital for autopsy.

Fire brigade personnel who doused fire said property worth Tk seven lakh were gutted in the incident.
