Outlaw gunned down in Jhenidah

An outlaw was gunned down at a village in Shailakupa upazila of Jhenidah Saturday

According to a delayed report, gunmen stormed into the house of the victim, Tuku, 35, an activist of the outlawed Biplobi Communist Party, at Jadabpur village at dead of night. They dragged him out of his house and killed him on a nearby road. Tuku, wanted by police in the Mintu and Gani murder cases, was believed to have been killed by his rival group. A case was filed.

AL activist succumbs to injuries

An Awami League (AL) activist of Shailakupa upazila in Jhenidah, who was injured in a clash with BNP men a day after Eid, died in Magura hospital on Sunday.

Police said Dulal, 45, of Kushabaria village, and 39 people were injured in the clash between supporters of AL leader and BNP over a minor dispute. In another incident, Railway police recovered a decomposed body from Mobarakganj Railway Station on Sunday. It was sent to Jhenidah hospital morgue for autopsy.

Bank official killed in road accident

A bank official was killed in a road accident at Khasbagauri in Panchbibi upazila in Joypurhat on Joypurhat-Panchbibi road on Monday.

Police said Akhteruzzaman, 45, a Sonali Bank official, was critically injured when a lorry hit his motorbike while he was returning from Panchbibi to Joypurhat. He was rushed to Joypurhat Modern Hospital where he died from his injuries. Police seized the lorry, but the driver fled the scene.

UP chairman of Bheramara UZ arrested

A Union Parisad (UP) chairman of Bheramara upazila in Kushtia was arrested from Kuchiamora Bazar Sunday night in connection with a clash.

Police said Abdur Razzak, chairman of Bahadurpur union and local Awami League leader, was arrested following a case filed against him after the clash between two rival groups of people on Saturday. The chairman who also faces 10 other cases, was produced before court and then sent to jail the following day.

Armed pirates kidnap hatchery employee

Armed pirates from the Sundarbans kidnapped a hatchery employee from Jatindranagar village in Shyamnagar of Satkhira on Friday and demanded a ransom of Tk two lakh.

Locals said a gang of terrorists, numbering 15, picked up Muhib Gazi, 30, from the hatchery of Abul Kashem and demanded Tk two lakh for his release. They threatened to kill him unless their demand for ransom is met within a week. On the same day, sea robbers looted equipment of solar power generation and other valuables from a trawler of another hatchery in the neighbourhood.

Pabna lawyers boycott judge court

Lawyers boycotted Pabna Judge Court Tuesday following a disagreement with the judge over fixing of dates for hearing of 15 important criminal cases.

Court sources said the lawyers boycotted the court as Judge Abdul Matin went on vacation without announcing next dates for hearing the cases as requested by Pabna Bar Association president Zahir Ali Quaderi and general secretary M A Matin. The lawyers also held an emergency meeting demanding appointment of a new judge.

Seven policemen including ASI closed

Seven policemen, including an ASI of naval police posted at Shibalaya thana in Aricha ghat, were closed for releasing a truck carrying smuggled goods.

The cops were identified as Shamim, Majed, Rabiul, Keramat, Hashmat, Babul and ASI Rowshan Ali. Official source said the cops seized the truck along with illegal Indian goods at Arichaghat Sunday night and released it following an underhand deadline. As the matter brought to the notice of the district police administration, they closed the

Extortionists attack sex workers

Five sex workers were injured in an attack on a whorehouse in Magura town by extortionists early Monday.

Police said Iqbal, son of Bakufakir of Niznanduali village, went to the brothel to extort toll from a sex worker, Rokeya, on Sunday, but Rokeya turned down his demand. Angered by the refusal, Iqbal along with his 10 associates attacked the brothel, leaving the five sex workers injured and their valuables ransacked.

Two activists of UPDF arrested

Two activists of United People's Democratic Front (UPDF) were arrested along with arms and ammunition from Baroitali in Guimara of Khagrachhari on Tuesday.

Acting on a tip-off, armymen raided the area at about 3 pm and caught Pijush Chakma, 28, and Usha Marma, 23, and recovered a 3.3 rifle, two revolvers, one SBBI gun, 259 rounds of bullet, seven magazines and other valuable documents from their possession. The arrested, who claimed themselves as UPDF activists, were handed over to police along with the arms and ammunition. Meanwhile, UPDF activists allegedly abducted a PCJSS worker, Chinu Chakma 35, from a house at Shantipur village in Dighinala upazila Monday. PCJSS leader said the UPDF activists also beat up another man, Bimol Kanti Chakma, during the incident.

BKB loan from Magura farmers

Bangladesh Krishi Bank (BKB) has taken up a programme to distribute loan amounting to Tk 15.17 crore among farmers of Magura this fiscal.

BKB sources said the loan is being distributed among the farmers for crop cultivation, poultry and fish farming, purchasing irrigation equipment and bullocks, and launching small business. The bank distributed Tk 5.6 crore in last five months of the current fiscal through its 17 branches. It also realised Tk 12 crore outstanding loans from the farmers during the period.

438 uplift projects progressing

Some 438 development projects are being implemented in Bogra at a cost of Tk 41.89

The projects include construction of 160 kms of roads, 60 metres of bridges and culverts, union parishad bhabans and upazila land offices in addition to a small water supply project and development and maintenance of rural infrastructure. The government has so far allocated Tk 39.84 crore for the projects and work on 91 projects has already been completed, officials said

340 killed by man-eaters in Sundarbans in 10 years

Three hundred forty persons were killed and more than 900 injured in attacks by man-eaters of the Sundarbans in

Most of the victims were fishermen, Bawalis, wood cutters and honey-collectors who entered into the forest in large number to earn their living. Most of the injured lost their physical ability to work as was learnt from different sources of both east and west wings of the Sundabans Forest Division (SFD). At least 400 of the injured were suffering from physical deformity.

According to officials of different Range offices of SFD, men-eaters lie in wait in the areas of forest where honey collectors, wood_cutters and Bawalis move about and around. Their careless movement into different places of the forest gave wide scope to tigers to attack. Tiger attack their prays, particularly when collectors of honey look at

Many bodies of persons killed by tigers could never be recovered. Besides, total number of cows and goats killed by man-eaters stood at more than 1,500 in the villages djoining the Sundarbans during the last 10 years.

Of course, many tigers were also killed by angry villagers during the same period, said officials of the Sundarbans Forest Division (SFD). Angry people use guns and other deadly weapons when a tiger enters into

As per rule, forest guards must be informed when man-eater enters into locality. It is the bounden duty of forest guards to subdue a man-eater by using tranquiliser music for sending it back to forest. But forest guards are never given this chance, said a Forest Ranger who expressed grave concern over rise in loss of human lives due to attack by man-eaters.

Cold wave paralyses life in Sirajganj

Unprecedented cold wave during the last few days has almost para-

lysed life in Sirajganj town. Severe cold wind coming from the Himalayas has made lives of the dwellers, specially the homeless people of this small town miserable. At least five elderly men died and many were attacked with various cold related disease.

Intensity of cold worsens after mid-day which turns extremely unbearable in the evening. Everyday, fog clouds the town until 8 to 9 am and vehicles ply in the streets with their headlights still on. Although the sun appears for a while at around 10 am, but it soon disappears to the dismay of the dwellers. On Friday morning, drizzles

made things even more worse. Destitutes try to combat this bitter cold wave through heat generated from burning heaps of straws and old rubber tyres. On the other hand, second hand warm cloth sellers are making best

somely by raising the prices two and even three times Diseases like fever, cough, cold and dysentery have also alarmingly increased. The only government

use of this situation earning hand-

hospital is crowded with bronchitis and asthma patients. But the hospital is short of oxygen and do not have the "lobolizer machine." As a result distress and sufferings of the patients know no bounds. The owners of medicine pharmacies are also making good use of this abnormal situation have doubled prices of life saving "salbutamol inhalers."

Severeness of cold in this small district town situated near the Jamuna river side is usually bitter than other areas of the country. The situation usually deteriorates in January and February. Observers feel that this cold will worsen further during next few weeks. Cultivation of winter crops, particularly potato is facing damage from this unnatural

Although some voluntary organisations have come forward with warm clothes for distribution among the destitutes, but this is extremely meagre compared to requirements. Authoritative sources believe unless the government and the rich section of the country come forward with arrangement for distribution of sufficient warm clothes for the homeless people in this area, possibility of loss of life from this bitter and severe cold may not be ignored.

People here are crowding winter garment shops. Sellers display varieties of warm clothes in shops Many vendors are also selling garments including old ones, on footpaths and in public places. A large number of makeshift shops have also sprung up on S S Road in Jam-e-Mosque, Station Road, Court premises and Bahirgola areas. But prices are comparatively high this year, local residents said "People of low-income group are flocking shops which sell old warm garments", said Sukur Ali, a resident in the district headquarters.

Housewife killed

Five killers get life term in Chittagong

The second Additional Metropolitan Sessions Judge Shamim Muhammad Afzal last week sentenced five persons to life term imprisonment for killing a person.

The convicts are Morshed Khan, Saleh Ahmed, Muhammad Amin, Mujahar Ullah and Muhammad Akter, court sources said.

According to prosecution story, the convicted persons chopped to death Asraf Hossain, son of Abdul Gaffar of Mia Khan Nagar at Bakolia on May 20, 1992.

In sequel to previous enmity the accused called the victim out of his video shop and chopped him with sharp weapons indiscriminately. At one stage they confirmed his death by shooting from firearms.

Later, Chandgaon police filed a case in this connection and submitted chargesheet against the accused. The judge examined seven

witnesses and necessary documents and found the accused Assistant Public Prosecutor

Kamal Amrohi Chowdhury stood on

behalf of the state while Advocate Nittyalal Khastagir appeared for the accused.

Meanwhile, the third Assistant Metropolitan Sessions Judge Mahamudul Kabir sentenced Muhammad Monju to ten-year RI for possessing illegal arms.

Police arrested Monju redhanded on December 12, 1997 with one pipe-gun during toll collection from different stalls of Bijoy Mela at outer-stadium.

Later, Kotwali police filed a case against him under the Arms Act.
