Foreign Minister Morshed Khan and Foreign Secretary Shamsher Mobin Chowdhury returned to the capital yesterday evening from Kathmandu to be available during talks between the two prime minis-

After arrival by a special flight of British Airways, Blair will be taken to the Bangabhavan in a motorcade for a courtesy call on President Badruddoza Chwdhury. Blair will be taken to Dhaka Sheraton where they will be staying

Formal talks between the two prime ministers will begin at 8 pm at the official residence of Khaleda Zia. The British dignitary will then be treated to a working dinner in which Foreign Minister Morshed Khan, Foreign Secretary Shamsher Mobin Chowdhury, British High Commissioner Dr David Carter and seven other dignitaries will attend.

Britain is organising and leading the ISAF, set up under a UN Security Council Resolution passed last month.

The ISAF, created under Chapter Seven of the UN Charter, is different from the traditional Peacekeeping Force formed under Chapter Six of the Charter.

Chapter Seven calls for Enforcement Action involving highrisk exposure and action to prevent human rights violation, safeguard distribution of relief materials and check outbreak of factional fight, if it so happens. Chapter Six covers routine peacekeeping work.

Bangladesh earlier extended support to the US-led coalition against terrorism. On September 18 last year, it also offered use of strategic facilities including airport and seaport by the coalition force, if needed, to fight terrorism.

the cases suspected last year have been examined at the Centre for Disease Control in Atlanta, USA, and Mohakhali in the city. The results are yet to be known. Some 475 cases of wild polio

were found in the country in 1998, 322 in 1999 and 197 in 2000. The paralytic poliomyelitis virus that causes the disease enters a

child through mouth and reproduces in the intestine. The virus incubates between five and 30 days before it attacks its host. Only one per cent of the infected

become paralysed while the rest would not even realise that they were attacked. The virus attacks and destroys certain nerves in the spinal cord causing paralysis. About 80 per cent of the virus are discarded from body through excreta.

## **Persecution of Simi**

All the walls of the house, including the kitchen, bedrooms, dining room, corridors, staircase and the balcony were adorned with Simi's artwork. She had a special interest in pottery painting and finely painted earthen nots could be found everywhere in the modest house.

The events that led to her death are both tragic and terrifying. She had been under attack for months, a systematic and brutal verbal abuse that was meant to and ultimately did break her spirit. The persecution of Simi, homicidal in its tenacity and single mindedness, was led by a group of young men. Doel, Khalil, Tofazzal and Ripon may have been at the top of the pack but there were others as well. In fact they had been at it for months. They taunted, teased and humiliated Simi till she snapped.

Yet her fault was simply the timing of her work. Simi came home late from work and that was good enough for the able bodied men to bay for her blood. That is also what Sub-inspector Bashar told Simi and her family when they protested to him that she was being harassed. According to the family, he took the side of the abusers. He told them that returning late from work wasn't a good thing to do.

Ripon, Khalil, Doel, Mofazzel and some others in the area for her death. She said the harassment she had undergone felt like 'worse than being raped'. She said her death would symbolize her protest against harassment of women. She was choosing death so that, other women would not have to experience what she had.

A day after her death, SI Bashar returned to Simi's house and told Zarina Begum. that he hoped they wouldn't lodge any complaint against him. The government however took

firm action on this and arrested Bashar for abetting a suicide. They have also launched a manhunt for the gang members. SI Bashar is now being interrogated but none of the other criminals have been apprehended yet. Simi's class friend. Quamruzzaman said that Simi

Local sources also noted that, Doel's mother Lutfunnahar Lata has hired some local goons to remove all the posters, which demanded justice for the 'killing of Simi'.
