4 terrorists held from Adamjee area

Persecution of victims **Top lawyers form body** to extend legal aid

Frontline lawyers have recently formed a committee to extend legal aid to the victims of persecution.

The move by the lawyers came amid recent incidents of alleged human rights violation across the country

The 151-member committee named "Supreme Court Legal Aid Committee" was formed recently with Barrister Shawkat Ali Khan as its chairman and Barrister Amir-ul Islam, Barrister Shafig Ahmed and Supreme Court Bar Association President Abdul Baset Maiumdar as co-chairmen.

However, one member of the committee told The Daily Star vesterday that the move was not directly linked with the Awami League's initiative to provide legal assistance to its leaders and workers.

Of relevance, the Awami League took a resolution at its Central Working Committee meeting on October 23 about formation of legal aid committees at central, district and thana levels.

The move was aimed at providing legal assistance to AL leaders and workers against whom the alliance government was filing 'false' cases.

Talking to The Daily Star, AL presidium member Abdul Jalil welcomed the lawyers' move. He hoped that AL leaders and workers who were being subjected to harassment and repression would largely be benefited. He, however, said that in line with the October 23 decision, the AL has already instructed the party-

profiling lawyers' unit to render lawful support to its party men who have been persecuted across the country.

Barrister Amir-ul Islam explained that victims of ersecution and violence would get free legal consultation from this committee.

When asked whether the move correlates with the AL initiative in any way, Barrister Islam said, "Our committee will render legal support to the persecuted political workers irrespective of their party affiliations. Naturally, if the AL workers are harassed, they will also get the support. The same way, the victims belonging to the Communist Party or Gano Forum or any other party, and journalists, intellectuals and human rights activists are equally entitled to the legal aid."

"Since July, the incidents of persecution and violence have climbed and we woke up to the cause," he replied to another question.

After the formation of the legal aid committee at central level, they would form such committees in every district, he continued

About the longevity of the committee, Barrister Islam said, "We're contemplating to give it a permanent shape and would not limit its scope of service to any definite duration.

Judgement in the triple murder case will be pronounced here on January 15, according to a source in the special court. Cross-examinations of prosecu-

tion witnesses concluded on Tuesday. A total of 26 witnesses were cross-examined. Kamal Ahmed, Insaf Ali and

Abdul Khaleque of Sonadanga residential area were murdered by the armed cadres of Ershad Shikder at Skid Ghat in July, 1997. Their bodies were later dumped

into the Bhairab river. The three were killed for protesting drug trafficking at the Skid Ghat, said Noor-e-Alam, the bodyguard of Shikder, Noor-e-Alam, one of the

accused in the case gave his confessional statement before the court. The accused in the triple murder case are Ershad Shikder, Jamai

Faruque, Liaquat Lashkar, Iddris Jamai, Yusuf Mannan, Nasir Khan, Noor Islam, Basir Hossain Babu, Noor-e-Alam, Joinal, Moktar, Barek Commander, Noor Mohammad and Shajahan. Four out of 14 accused are being tried in absentia.

Ershad Shikder has so far been awarded death sentences in sever out of 13 murder cases.

Bangladesh at risk due to porous border

Bangladesh still remains at risk of wild poliovirus transmission though it has a modern mechanism to check its spread, official sources

Poliovirus transmission

said. According to officials of the Extended Programme of Immunisation (EPI), wild poliovirus transmission threat prevails because of the country's proximity to areas in India with high prevalence of the disease that perma-

nently paralyses children under 15 years of age. Movement of population across the border at the 'danger zones' also heightens the risk.

"Most of the tea pluckers in Sylhet gardens come from the other

side of the border in India and there is every chance that the virus transmission may take place through such 'migration'," said a senior epidemiologist of the EPI. According to a report of the

World Health Organisation (WHO) regional office in New Delhi, 197 cases of wild polio were detected and clinically confirmed in India in 2001. The majority of the cases were detected within 50 km of the northeastern Bangladesh border.

Three consecutive years of polio-free status is required before Bangladesh can be declared free from it. WHO said. But the latest threat of wild polio attack and possible failure in detecting it in time may stand in the way of the country's achieving the status.

"We had 121 suspected cases of wild polio last year. But this could not be confirmed as excreta specimen of the patients were not collected in time (within 14 days of onset of paralysis). But the existence of wild polio across the border poses a big threat to our achievement," said Dr Md Mahbubur Rahman, line director of Child Health and Limited Curative Care.

The last case of clinicallyconfirmed wild polio was detected in the city's Mirpur area on August 22 last year in a victim named Dolly. Since then, no wild polio cases have been detected, EPI sources said. Meantime, the 121 potentially

Austrian state radio said Waldheim, 83, fell and suffered a facial injury Tuesday at Going, a ski resort in the western province of Tyrol.

A doctor ordered his transfer by helicopter to Innsbruck's University Clinic, where spokesman Johannes Schweighofer confirmed that Waldheim was being treated.

Schweighofer said Waldheim was in "good" condition but refused to provide details.

Indian troops build-up along Pak border 'complete'

India said yesterday it had completed its troop build-up along the Pakistan border, but still hoped diplomacy and international pressure could avert a showdown with its nuclear rival

Defence Minister George Fernandes told Reuters in an interview the situation along the frontier, where both sides are daily exchanging fire in some places, remained tense.

"But at other levels efforts are being made to defuse the situation through diplomatic intervention," he said, adding foreign governments had weighed in to press New Delhi's demands that Pakistan close down anti-Indian militants on its soil.

U.S. President George Bush has personally phoned Indian Prime Minister Atal Behari Vajpayee and Pakistan President Pervez Musharraf to urge talks and to ask Pakistan to act.

And British Prime Minister Tony Blair is due to visit India and Pakistan from tomorrow in a bid to ease tensions

Fernandes said the two leaders may talk on the
