## GQ Chy's remark Dhaka traffic set to get a new face soon

The bad news -- with the disappearance of about 1,000 rundown vehicles from the city roads, general commuters are facing tremendous hassles in moving around

The good news -- within a week or two, some 50 modern and spacious Volvo buses received from Sweden would start plying the city roads. Sixty more Volvo buses, specially designed for everyday urban commuting, would follow the first fleet soon.

The flip side of the scaled-up drives to contain pollution and traffic jam in the city is the dearth of public transports facing the commuters, though the traffic situation has improved significantly since January 1.

The decision to withdraw these vehicles from services was made apparently without thinking of an immediate replacement, sources said. That is just the beginning of changes in the whole

commuting scenario of the capital.

Officials of the Bangladesh Road Transport Authority (BRTA) said they have already received many applications for permission to introduce new buses on various routes in the city. For the route-6 from Pir Jangi Mazar to Gulshan, a case in point, the BRTA received ten appli

cations to introduce modern chair coaches.

Motor importers and distributors now see a huge rush for modern vehicles. Many investors are purchasing modern minibuses, which will ply the city roads and bring a change in the road communication within the next two months

About 1,000 buses, tempos and other public transports plying 15 routes in the city are more than 20 years old, and as per a government decision, these vehicles would be scrapped.

"Thanks to money, investors are coming forward to fill the vacuum we have created in the market," said a

BRTA official on condition of anonymity. Asked how they could then issue fitness certificates to vehicles outliving their longevity for over 20 years, the official said the certificate is issued on the basis of visual inspection because Bangladesh is yet to set any standard for vehicular fitness.

Thousands of commuters are also suffering due to the government's decision to ban rickshaws on some major thoroughfares and its failure to introduce public transports, thus resulting in problems for not-so-well-off commuters who depend on cheap transports such as rickshaws, tempos and buses

#### Industrialist Alam murder

### Police arrest two sons, suspect family feud led to killing

Police arrested two sons of murdered industrialist Mohammad Alam late last night after preliminary investigations by the Detective Branch indicated that family feud over inheritance might have led to the gruesome murder of the late industrialist.

Industrialist Mohammad Alam was brutally murdered at his Alambagh residence Tuesday night along with three housemaids

Detective Branch (DB) of police, which is investigating the murders, arrested Nur Alam alias Babul and Jahir Alam alias Khokon, Alam's two sons from his first marriage, late last night. Besides, two housemaids, Farida and Henowara, who confessed before police to have been Alam's mistresses, were also arrested.

Detectives suspect the two arrested sons of the deceased of masterminding his murder as part of a

blueprint to grab the huge property of the deceased

basis of information provided by Farida, who told police that the strained relation between Alam and his sons deteriorated when Alam recently stopped giving them

She told police that Khokon along with his elder brother Babul and a local group of terrorists masterminded the killing of his father. The three maids were chopped to death, as the killers did not want to leave any witnesses, she said

#### **Buses stay off** Dhaka-N'ganj route

Buses and minibuses on the Dhaka-Narayangani route are not operating for the last two days.

All buses have suspended their services because of the new rule by the government since January 1, resulting in an enormous problem to about 50,000 regular passengers on the route.

There are about 300 buses and minibuses regularly plying the Dhaka-Narayanganj new and old Only 30 air-conditioned buses

and 22 BRTC double-deckers are the only means of travelling to Dhaka, with thousands of people now depending on the said buses

## Fresh bid to gobble up **Gulshan Lake**

Another attempt to grab part of the Gulshan Lake is on in clear violation of laws governing preservation of water-bodies and open spaces in the city.

A five-katha area of the lake along Gulshan Road no. 35 between Gulshan and Banani TNT Colony has been demarcated by sinking bamboo poles into the lakebed. A signboard bearing the names Sultana Akhtar and

Sajjadur Rahman Bhuiyan as owners has been put up claiming possession of the area by right of purchase. Local people said the signboard and the poles were installed about four days ago. Residents of Gulshan to the east of the lake as well as fishermen dwelling in slums to the west however said

they did not know anything about the so-called owners of the demarcated water-body, which has been earmarked for the lake in the Rajuk Master Plan.

### 'National convention' on gas denounces export option

#### Countrywide protest announced

A declaration adopted at a 'national convention' here yesterday said export of gas through pipeline would be against the interest of the country and the people and announced a programme to launch a countrywide movement to resist the move.

It also gave the government a deadline till March 20 to cancel the two committees formed to assess the gas reserve and its utilisation.

The committees have been formed with "agents" of multinational companies to hand over the gas resource to them through "conspiracies", the declaration said. It demanded utilisation of gas in

different sectors including power

and industry for the country's development, instead of exporting it. Political leaders, noted intellectuals, former officials and hundreds of representatives from professional groups attended the convention, organised by the National

Resource for National Interest, held at the Osmany Memorial Hall. The declaration said the committee will hold demonstrations in districts and upazilas, which will culminate into a "people's march" towards Bibiyana gas filed in Sylhet on March 20. There is a proposal to the government for pipeline export

of gas from the Bibiyana filed. The declaration was read out by Prof. Anu Mohammad of

Jahangirnagar University. Besides intellectuals, professionals, officials and political leaders, the convention was addressed by representatives of 52 district committees of the National Committee.

The convention also decided to

form units of the Committee in rest of the districts soon.

After the day-long convention, a big procession was brought out. The processionists carrying banners and chanting slogans against gas export paraded different city streets.

Speakers at the convention said despite ideological differences, the major political partiesAwami League, BNP and Jatiya Party have "joined the same league" to export gas by depriving the people.

Committee for Protection of Oil-Gas They called upon all patriotic forces to build a united resistance against the move

The characteristics of Awami League, BNP and Jatiya Party are different but they are of the same view on the issue and are "conspiring" to export gas, noted educationist Professor Sirajul Islam Chowdhury said

# **Bus-truck collision kills** ten in Tangail

At least 15 people were killed and 45 others injured in separate road accidents in Tangail, Rajshahi and Thakurgaon yesterday.

Eight of the dead were identified as bus driver Swapan, 40, truck driver Rafique, 30, Nurul Islam, 40, Jobber, 40, Shamim, 45, Moniruzzaman, 40, Raihan, 30, and Azim, 35. The identity of two others could not be known.

Of the injured, 20 were admitted to MMCH.
