Khaleda for Indo-Pak dialogue

Prime Minister Khaleda Zia, now attending the 11th SAARC summit in the Nepalese capital of Kathmandu. vesterday underscored the need for holding dialogue between Pakistan and India to defuse prevailing tensions between the two countries.

The Bangladesh leader made the request at a meeting between her and Pakistan President Pervez Musharraf at her suite at Hotel Soaltee Crown Plaza.

Briefing newsmen after the 45minute long discussion, a spokesman of the Prime Minister said the meeting was held in a friendly and cordial atmosphere during which the two leaders focussed on a host of issues including the trade imbalance, enhancement of exports, stranded Pakistanis in Bangladesh and the Afghan situation.

Chittagong Port 50 pc cut in container loading charge likely

The container loading charge for exportable goods at the Chittagong Port is likely to decline by almost 50 per cent

With the decision taking effect from February 1, it will bring the loading charge from Tk 920 down to Tk 500 and almost halve the expenditure of about Tk 6 crore a year, sources said

The decision was made at an hour-long meeting of the Chittagong Port Authority (CPA) with different port users, including Bangladesh Steamer Agents' Association (BSAA) and C and F Association, which was held at Bandar Bhaban here yesterday afternoon.

Dhaka places 8-pt plan at SAARC Summit million dollars to boost regional which is holding its 11th summit after a delay of over two years. The eight-point specific propos-

als include utilisation of new ideas and techniques generated by information technology, implementation of studies by South Asian think-tanks leading to concrete action and the plan of Action of the Male Environment Ministers Meeting and recommendations of the two SAARC studies on environment, implementation of the SAARC agenda on poverty eradication without any further loss of time, strengthening social issues, encouraging greater involvement of non-state actors and adoption of a Regional Investment Agreement.

The prime minister said the impact of events of September 11, 2001 has effectively demonstrated that no country can live in isolation. "Real security for all of us lies in promoting sustainable growth, reform and development. That is what SAARC really stands for."

Tensions between India and Pakistan have drastically slowed progress within the regional body, which was initiated by Bangladesh and held its first summit in Dhaka in December 1985.

"SAARC has a special place in my heart," she told the summit. "Its guiding motivation is rooted in the wisdom of its founding and chief architect, late president Ziaur Rahman.

The prime minister called for the establishment of a regional investment agreement with a minimum capital of 500 million dollars that diplomats said could help guarantee the security of capital inflows within the region.

Petrobangla have been deducting eight per cent from the oil companies' monthly bill as charge for supplying the gas using a eight-kilometre local gas pipeline. Originally, Shell and Cairn are contractually obligated to set up a new pipeline leading to the national grid. But to fulfil the prime obligation of meeting the deadline for Sangu gas production, the oil companies started using the local pipeline belonging to the Bakhrabad Gas Transmission Systems.

But Shell-Cairn had been arguing that deduction of eight per cent of the monthly billing was actually exorbitant and unacceptable. They pleaded with Petrobangla to rationalise the pipeline rental charges. But with Petrobangla stern on its stance, the oil companies sought international arbitration

"As per our calculation, we will get around 38 million dollar from Petrobangla plus interests if we win the case," the Shell source said.

Previously, during the visit of former US president Bill Clinton, Petrobangla was asked to pay the dues of US oil company Unocal for purchase of Jalalabad gas.

Most city ward commissioners allegedly patronise gangs

Ward commissioners of the Dhaka City Corporation (DCC), responsible for social welfare and development work, are allegedly indulging in criminal activities in their areas. Sources said most of the ward commissioners patronise separate gangs to unleash criminal offences.

Besides firearms dealing and drug trafficking, the ward commissioners have also close links with killers, land-grabbers, muggers and extortionists

Sheltered by the commissioners, a large number of criminals have carried out criminal activities over the years. Several criminals were arrested and punished in some cases, but their godfathers always got off scot-free.

At least five ward commissioners have been killed by their rivals since the last DCC election, and several other DCC election hopefuls were 7&8

killed in the last few years. The most recent victim was Khaled Imam, a BNP leader and former commissioner of Moghbazar

popularity conspired to kill him to cleanse the contender, both police and his family members believe. They also believe the intra-party rivalry might have led to his murder.

Another ward commissioner and BNP leader Shawkat Ali Mister was gunned down in front of his Mirpur residence three months ago, following a brawl with some local miscreants over the share of money.

Nowadays, the position of ward commissioner holds allurements to the DCC election aspirants because of its money-spinning advantage. The affiliation with the ruling party can also make a ward commissioner even more powerful.

With the exception of issuance of character certificates, ward commissioners have virtually no official

Since the last election to the DCC on 30 January in 1994, most of the commissioners did a little for their voters. Although their tenure and Navatola. With good prospects

expired three years ago, they are still getting various facilities by dint of their position.

The DCC is yet to set the official tasks of ward commissioners even seven years after the last election.

The main official task of a ward commissioner is to maintain close links with political high-ups and to win tenders through manipulation. "Bidding is their main business by which they obtain contracts for various development works from the Nagar Bhaban," said a Nagar Bhaban official.

The official, on condition of anonymity, said, "A ward commissioner earns a lot of money by manipulating bidding through their political leverage," he added.

They frequent the Nagar Bhaban for bidding purposes and usually reach an understanding for sharing of development works among themselves.

Shell-Cairn's dues STAR REPORT the mid-1990s. Shell sources said Petrobangla owes Shell and British Prime Minister Tony Blair has requested the

government to clear the pending oil and gas bills against Anglo-Dutch oil giant Shell and its British partner Cairn.

Petrobangla owes Shell-Cairn an undisputed amount of US\$ 52 million as bills for purchasing offshore Sangu gas since May last year, sources said. Ironically, Petrobangla itself gets over Tk 1200 crore from its consumers and affiliates.

The British premier raised the issue of the pending bills during talks with Prime Minister Khaleda Zia last Thursday, sources said.

Finance Minister M Saifur Rahman, present during the talks, tried to assure Blair of payment of the dues and said these have been left unattended by the previous government.

He also told the British premier that the government would honour its contractual obligations with the oil companies.

Meantime, Petrobangla sources said the payment has been deferred by the Bangladesh Bank because of the fragile foreign exchange reserves although all processes for releasing the money have been completed.

The debate in the cabinet sub-committee on local government over the structure of the upazila system dragged on.

The committee yesterday had a preliminary discussion about the entire structure of the local government system after a report on upazila it placed in the last cabinet meeting on December 31 last year was returned for further discussion. sources said.

The previous recommendation in this regard was placed in a report way back on July 30, 1992.

Presided over by LGRD and Cooperatives Minister Abdul Mannan Bhuiyan, yesterday's meeting was attended by Law Minister Moudud Ahmed, Communications Minister Nazmul Huda, Industries Minister MK Anwar and Information Minister Dr Abdul Moveen Khan.

Health and Family Welfare Minister Dr Khandaker Mosharraf Hossain, another member of the subcommittee, could not attend the meeting as he was outside Dhaka

Officials said the BNP government in its previous tenure had formed a local government commission headed by Barrister Nazmul Huda, which after 8 months

of exhaustive discussion, submitted a report suggesting a four-tier local government system comprising Gram Shava, Union Parishad, Thana Development Coordination Committee and Zila Parishad.

Briefing newsmen after the meeting, LGRD and Cooperatives Minister Abdul Mannan Bhuiyan said the 6-member Cabinet sub-committee would examine both the reports and submit a complete report for further strengthening the entire local government system.

"We are now discussing about the local government tiers and its structures," he added. Communications Minister Nazmul Huda, who was

included in the committee on December 31 last, said, " Our aim is to make the local government a more skilled,

effective and viable body and we will present a complete system to the nation as per the Prime Minister's order."

Huda said the Upazila system was introduced by the autocratic Ershad regime under the presidential form of government and was intended purely for voting purposes.

He said that under the present parliamentary form of government, reintroduction of Upazila system would definitely create a serious conflict between the MP and the Upazila Chairman.

Sources said the cabinet sub-committee in its December 31 report has recommended major changes to the upazila structure to narrow the scope for conflict between the MP, Upazila Chairman, Zila Parishad Chairman, and local and district administrations.
