Some of BNP's actions to date do not reflect the wisdom or foresight of a democratically matured political party. Not that the forerunners of BNP were any wiser.

One has to only consider a situation where no less an individual of the status of senior secretary to the government receives orders transferring him to different position as many as three times within a span of 45 days or so. This is simply nothing but playing with human dignity.

Price hike of gas, fuel and electricity

Price of electricity, gas and all sorts of petroleum products have been increased from the 1st January, 2002 as per government decision.
