## Banks under new strap

### Fresh BB lending rule to hinder bank growth, industrialisation, fears banking circle

A new stricture of the Bangladesh Bank (BB) to bridle the freedom of commercial banks to give large loans has created a sharp repercussion in the

The move would virtually stifle the growth of commercial banks and stymie industrial activities as well, top bankers reacted.

The contention was created when the BB through a circular has set a new standard of sanctioning large loans by the commercial banks that has narrowed their freedom in loan activities.

The BB has informed most of the banks that they have large loans above the ceiling as per the new rule and so, they will not be allowed to seek fresh permission from the central bank to sanction new large loans. They can only

seek BB's seal of approval for the renewal of existing large loans. The new rule prescribes that the banks with net classified loans of up to five per cent will be allowed to sanction a maximum of 56 per cent of the total loan and advances as large loans. Earlier, they could lend up to 80 per cent.

The banks with net classified loans of above five per cent to ten per cent can now lend 52 per cent of their portfolio as large loans against the previ-The banks with net classified loans between ten and 15 per cent can lend

up to 48 per cent as against the previous 60 per cent of their portfolio. For the next slot of up to 20 per cent, the allowable large loan is 44 per

cent instead of the previous 50 per cent.

Surprisingly, the worst-performing slot with over 20 per cent net classified loans does not suffer because of the new policy. They retained their current 40 per cent large loan limit.

The BB has also directed the commercial banks to reduce their amount of large loans to fit into the new slab.

According to the existing rules, banks have to seek permission of the BB for approval for any loan exceeding 15 per cent of their capital.

"So, with the fresh restriction, the new banks having comparatively small capital base will be in a big trouble," said the managing director of a ten-year old private bank requesting anonymity. "Most of these banks have capital of around Tk 20 crore and they will not be able to give loans over Tk 2 crore."

Another managing director said his bank had already finalised a number of new loan deals, which will be jeopardised because of the new rule.

"This will effectively put a lid on our growth," he said. Meanwhile, a BB source said the new rule was made to encourage banks to give loans to small- and medium-sized projects for diversified

But bankers have debated it by saying small industries will not grow overnight, and the country lacks infrastructure for such development.

While the good banks with low classified loans have been punished by the new rule, the worse performers were left untouched, which contradicts the policy of nurturing the better and punishing the worse, they pointed out.

### 4 terrorist gangs in Tejgaon Medical College area hold people hostage

At least four top terrorist gangs allegedly sheltered by different political parties have joined hands to continue drug trading, toll collection and other criminal activities in Begunbari, Nakhalpara, Tejkunipara and Karwan Bazaar areas of the city, local people said.

More than five lakh people of the areas are passing their days in mounting tension as criminal activities of the gangs continue unabated. In view of apparent police inaction in this regard, local people had appealed to the home minister through national dailies to take effective steps to put an end to the situation. But no such step was still

Sources said Phensidyl peddlers Monowara, Patash Hannan, Selim and Sobhan control one gang at

Banshpatti and its surrounding areas. One of the gangs is controlled by Nazrul. VP Jahangir and Nirob, while Solaiman, Ataullah, Anni Babu, RC Babu and Afsar control one gang and Alauddin controls the other gang in the areas. Former Freedom Party leaders and Jubo League men allegedly have links with Alauddin

At present, the gang leaders are in touch with some influential leaders of the ruling coalition, sources claimed. The gangs realise toll from house owners, businessmen and small traders. Many residents have already left the areas failing to meet their (gangs) illegal demands. "They left to avoid harassment and attacks on their families by the gangs," claimed an elderly man.

Of the gang members, Afsar, Soaliman and Anni Babu allegedly 'recruit new members.' Alaluddin's

brother Raiib and some of his accomplices are members of gangs.

Alauddin is one of the 23 top terrorists, as announced by the authorities recently. The authorities also announced award for their Since the BNP-led coalition

people have been keeping away from their houses and small factories in the areas fearing attacks by the gangs for refusal to pay toll. Earlier, local hoodlums in collu-

#### **Bail petition** of Pintu rejected

The Metropolitan Sessions Judge's Court, Dhaka, yesterday rejected the bail petition of ruling party MP Nasiruddin Ahmed Pintu.

Pintu was arrested on December 26 last year on charge of attempted snatching of auction documents of a bankrupt company's property on December 23.

Judge Ahmed Jamil Mostafa passed the order following a criminal appeal, seeking bail by the defence lawyers.

In its order, the court mentioned that the charges brought against Pintu were primarily proved and the case was at a primary stage of investigation. So, the petition for bail is rejected. The same court on January 3

#### **HC** declares Mockbul's detention legal

### Syndicate active again for control of Eid cattle markets

An organised group of bidders, mostly backed by the ruling BNP, have formed a syndicate to bid for the lease of the 17 temporary cattle markets in the city for the Eid next month, raising prospects of a huge loss in revenue earnings for the DCC.

In the process, the group has also prevented others from dropping tender schedules.

The lack of competitive bidding has thus resulted in a drastic fall in the projected revenue earnings compared to the usual average amount earned every year by the Dhaka City Corporation (DCC) from leasing out these

According to DCC official sources, as soon as the bid was invited, the corporation sold 389 tender schedules to individuals for Tk 300 each. But until the last date for submission of tenders on Tuesday, the DCC received a total of only 68 bids at eleven different offices of the corporation

To the surprise of the officials, the bids were strikingly manipulated in favour of a specific price convenient for the syndicate, DCC sources said. According to figures provided by the Estate

worth Tk 55,14,811 for the city's 17 cattle markets as against Tk 1,28, 39,672 that it earned from their lease Out of the 17 cattle markets, six alone account for this

startling difference as the highest bids so far for their lease are shockingly less than last year's

The Nayabazar cattle market, one of the six markets in question, was leased out for Tk 60 lakh last year. This year however, the highest bid so far has been Tk 25 lakh only. Five other cattle markets have similar cases of gross underbidding.

Although the DCC would again have to invite bids for at least these six cattle markets, sources there feared that the syndicate is too strong for DCC to change anything. The DCC would have to pick the bids and send them for scrutiny by the Tender Committee, of which DCC's chief executive officer is the convenor. Finally, the mayor would have to approve and award the leases

According to a trader, who leased some temporary cattle markets in previous years, the entire syndicate is controlled by ruling party men most of whom have no

to the highest bidder.

### Bypolls to 5 JS seats | DCC allows shops today: AL boycotts

By-election to five parliamentary seats vacated by the President, the Leader of the Opposition and a senior Awami League leader takes place today with the AL boycotting it.

The Election Commission (EC) has tightened security in the five constituencies -- Narail-1 and 2 and Barguna-3, Munshiganj-1 and Faridpur-4-- to ensure peaceful voting and high turnout of voters. Members of the armed forces will be deployed to assist the civil administration in maintaining law and order during polling Voting will take place from 8 am

to 4 pm without any break. The government announced public holiday in the five constituencies AL President and Leader of the

Opposition in Parliament Sheikh Hasina, who won in four constituencies in the general election, vacated

seats, retaining Gopalganj-3 seat.
As the ruling BNP's AC Badruddoza Chowdhury was elected President, Munshiganj-1 seat from where he was elected MP fell vacant. Al. presidium member Abdur Razzag who had won two seats vacated Faridpur-4 seat.

The main opposition party AL, which had boycotted the first byelection to six seats vacated by top BNP leaders who had won more than one seat in the October 1 general election, claimed that the atmosphere is not congenial for participating in any polls now. They attributed this to government's 'repression and attacks' on opposition activists across the country.

"The candidates nominated by AL have individually boycotted the by-polls as they found the government has made all arrangements to defeat them by manipulating the byelection," a senior AL leader told The SEE PAGE 11 COL 5
