White paper released

Hasina, most ex-ministers linked to 40 cases of graft

The government yesterday released a white paper on some 40 cases of graft, irregularities and abuse of power allegedly committed during the rule of the past Awami League government.

This is the first ever official release of such white paper on graft and other irregularities allegedly committed by a government in Bangladesh.

Former prime minister Sheikh Hasina and almost all senior ministers of her cabinet were found involved in 'irregularities and financial mismanagement' allegedly committed between 1996 and 2001.

Mohammad Nasim, Amir Hossain Amu, Shah AMS Kibria, ASHK Sadique, Anwar Hossain Manju, Abdur Razzak, Prof. Rafiqul Islam, Mosharraf Hossain, Mohiuddin Khan Alamgir and Moulana Nurul Islam are among those linked to alleged graft and irregularities.

Many government officials as well as different local and international private organisations have also been implicated in the white paper.

The government may engage international investigators to probe the foreign links to the grafts, a government spokesman hinted yesterday.

The cases of financial irregularities, abuse of power and graft placed in the paper include the purchase of eight Russian Mig-29 fighter bombers, installation of over two lakh telephone lines across the country and two lakh personal handy phones in the city, construction projects of Bangladesh-Singapore submarine cable, set-up of power plants at different places, food imports from India and recruitment in the Ministry of Food, and purchase of dredging rigs by the Bangladesh Water Development Board. Allotment of plots by Rajuk in the city's Gulshan and Uttara areas, printing and distribution of textbooks, the 1996 share market scam, purchase of Volvo buses for BRTC, purchase of diesel generators for Dhaka WASA under suppliers' credit, Bangabandhu Jamuna Bridge project and population census project

Police arrested five Bangladeshis and detained three Indian teachers at an Islamic school for suspected involvement with Tuesday's attack on policemen guarding the US cultural center here, a top govern-

"We are verifying their links with Pakistan's spy agency and a Dubaibased mafia don, but we can't disclose details at this stage," Sourin Roy, chief secretary of the West Bengal state government, told reporters in Kolkata

The arrests were made in Basirhat, a town close to the India-Bangladesh border on Tuesday night, said Roy. They were to be produced in a court later yesterday.

Five Indian policeman were killed and 20 were wounded when motorcycle-riding assailants fired from automatic weapons as they drove by the American Center at 6:30 am Tuesday. One of the contract guards on duty at the center

Police said they arrested the five Bangladeshis and detained the three Indian religious teachers on the outskirts of Basirhat, 65 kilometers north of Kolkata for suspected links with Pakistan's Inter-Services

Meanwhile, the US cultural center reopened yesterday but the bloodshed and new heavily armed police commandoes in front of the building were expected to dissuade

Try all graft cases without state interference, vendetta: AL

Awami League (AL) yesterday released a list of corruption cases against BNP leaders including some present and former ministers and said it wants trial of all corruption charges 'without state interference and political vendetta'.

The government is trying to 'suspend or withdraw' cases filed against leaders of the previous BNP government (1991-96) and repressing AL leaders and workers in the name of corruption charges, top leaders of the party alleged at a press conference at the National Press Club yesterday

The press conference was held about an hour before the government released a 'white paper' on alleged corruption during 1996-2001 AL rule. Publication of the 'white paper' is a "manifestation of politics of ven-

geance", AL General Secretary Zillur Rahman said.

Zillur bitterly criticised the BNP government's "double standard" in a sharp departure from its pre-polls pledge of stamping out corruption from the

This has taken the people by surprise, he said. He said AL did not believe in politics of vengeance and refrained from publishing 'white paper' on 'corruption' during BNP's previous rule. The

Bureau of Anti-Corruption had proceeded with corruption cases on its own and their trial continued as per normal legal procedures, he claimed. AL leader and economist AMA Muhit placed a four-point demand at the press conference. These are continuation of the cases against BNP leaders
