Fresh study needed to clear confusion over gas reserves

CPD dialogue in city suggests

Fresh scientific study should be undertaken to clear confusions over the country's gas reserves.

Experts, academicians, intellectuals, politicians as well as representatives of donor agencies and international oil companies yesterday shared the observation at a dialogue titled, "Energy Sector of Bangladesh: what are the knowledge gaps?"

But, they could not reach consensus on any other aspects of gas resource, including whether Bangladesh should export gas through pipelines

The Centre for Policy Dialogue (CPD) arranged the dialogue in the city.

State Minister for Energy Khandakar Mosarraf Hossain said the actual amount of gas in the country cannot be determined without drilling. The minister, who attended the dialogue as chief guest, however, lamented the financial constraints to go for such an expensive exercise. "Where is the money to do it?"

Trade talks between Bangladesh and India scheduled for January 30-31 in Dhaka have been postponed for the second time after the Indian side said 'it would not be possible for them to attend' the meeting. However, the reason for India's refusal to attend the commerce secretary

"Now we will sit and fix a new date suitable for both the sides," a high

official of the commerce ministry told The Daily Star. Earlier, the meeting scheduled for December 26-27 last in Dhaka was postponed at the last moment as the Indian side declined to attend it due to

difference of opinion over its agenda. The scheduled talks were considered very crucial for Bangladesh against the backdrop of a trade gap of over one billion dollars in favour of

In this context, Dhaka wanted to focus on the huge trade gap at the bilateral talks. But Delhi insisted on taking up all bilateral issues and demands

lying unresolved for long. Dhaka also wanted to have a new bilateral trade agreement with a wider scope as the present one expired in October last year. The agreement was signed in 1980 for three years with the provision for to renewal

Sources pointed out that Bangladesh expected a 'goodwill gesture' from India on its long-standing demand for zero-tariff access of 25 categories of products to Indian market. But India insisted on tariff concessions on a reciprocal basis and demanded duty concessions from Bangladesh on 90 items. India even proposed that it could agree to Bangladesh's demand if it

Pintu freed on bail

Pintu was arrested on December 26 last year on charge of attempted snatching of auction documents of a bankrupt company's property on December 23.

Magistrate Shafiq Anwar passed the order upon a bond of Tk 10,000 with two guarantors

Prime Minister Khaleda Zia yesterday declared January 19, the birthday of late president Ziaur Rahman, as the National Teachers' Day.

"The day will be observed every year to uphold the dignity of the teacher community and improve teacherstudent relationship," she said while inaugurating a language centre at Bangladesh Institute of Administration and Management (BIAM) in the city. The prime minister also declared reintroduction of

the pension allowance scheme for non-government teachers. She distributed medals, grants and pension allow-

ance among eminent academics and teachers at the function jointly organised by the Education Ministry, Non-government Teacher-Employee Oikya Jote and

The PM lamented that the cordial teacher-student relationship that prevailed in the past in the country was now absent. "We want to restore that relationship." she

Recalling the initiative and contribution of late president Zia, Khaleda said he wanted to bring about a radical change in the education system. She said shaheed president Zia had formed a

National Education Commission to introduce a modern and suitable education system in the country. She also recalled his contribution to spreading mass literacy and education for elderly people in a bid to remove illiteracy.

Zia rebuilt, expanded and established many educational institutions, she said. "But he neither changed the name of any educational institution nor allowed naming any after him during his lifetime. She said the teacher community remembers him for

his contribution to the spread of education and their welfare. The education ministry accepted their proposal to declare his birthday as National Teachers' Day, she added. The prime minister said she had asked the authori-

"It appears that it was an explosive device but we are unable to comment further while the Pakistani authorities are urgently investigating this matter.

Hasina shrugs off graft charges

Leader of the Opposition Sheikh Hasina yesterday dismissed allegations of graft labelled against her and claimed that her government ran the administration honestly and saved public money.

Referring to the government's white paper on alleged corruption during the 1996-2001 AL rule,

Hasina said, "They have brought five allegations of corruption against me. It is unfortunate that in this country, corruption charges are brought if one runs the government with honesty and tries to save public money."

Hasina, also president of Awami League, was addressing as chief guest the annual general meeting of Dhaka Union of Journalists (DUJ) at the Jatiya Press Club in the city. She also mentioned filing of two

graft cases accusing her of making the country lose Tk 700 crore in the purchase of eight MIG-29 aircraft for the Air Force and Tk two crore in appointing a lobbyist for readymade garments' access to the US market. The cases were filed with Tejgaon thana in the city. Hasina claimed that a minister in

Khaleda Zia's cabinet who was defense attaché at Bangladesh mission in Russia had looked for commission in the Mig purchase. "But we went for state-to-state

negotiation for the best bargaining price, leaving no scope for commission. Now they have brought charge against me.

"I challenge that none could buy the Migs in lesser price than we paid. I made the state gainer by 165 million US dollars by procuring the Migs at 124 million US dollars, lowering the rate from 289 million
