# **MBBS** doctors at union levels soon, says PM

#### UNB, Dhaka

Prime Minister Khaleda Zia yesterday said her government would take an initiative to appoint MBBS doctors at union level to provide more effective healthcare to the rural people.

"This time also, we, according to our election commitment, are activating the union health centres to reach health services more efficiently to the doorsteps of villagers. Medical supplies will also be increased in phases also for upazila health complexes," she told physicians at a convocation ceremonv

Addressing the Eighth Convocation of Bangladesh College of Physicians and Surgeons at the Bangladesh China Friendship Conference Centre Khaleda further said more specialist physicians in different disciplines would be appointed to district hospitals.

Some 700 physicians got fellowship at the convocation. Of them, 20 specialists from home and abroad were given honorary fellowships.

Urging the medical doctors to serve people, particularly the poorer section of society, with sincerity and dedication, she asked them to think carefully as to what extent could primary healthcare be made easily accessible to those who live below the poverty line.

"You will also have to think about how the specialist physicians could come forward for the treatment of the poor for complex diseases," the PM told the health specialists and surgeons.

She also suggested to them to work out how they could at individual or collective level help the destitute people apart from the government effort. SEE PAGE 11 COL 4

## Trial of Shipu murder begins **Deposition of witness** Ishtiague recorded

The trial of the Iftekhar Ahmed Shipu Murder Case began at the Third Additional Metropolitan Sessions Judge's Court, Dhaka yesterday.

Judge Mollah Mostafa Kamal recorded deposition of Mohammad Ishtiague Ahmed, the first prosecution witness as well as the complainant of the case.

The court adjourned the proceedings of the case till February 3. Ishtiaque Ahmed will be crossexamined by the defence lawyers on that day.

Ishtiaque in his statement said that three people -- Ziauddin Ahmed Jewel, Naimuzzaman Zobaver and Shafiul Alam -- went to his brother Shipu's mobile phone shop on the 2nd floor of UAE Moitree Market in the city's Banani area at about 7.15 pm on May 24, 2000 and asked the manager of the shop Abul Kalam

Azad about Shipu and his whereabouts. The witness told the court, the three people claimed that a few days ago, they bought a Nokia mobile set from that shop but it was out of order and they ordered the manager to show another set.

The manager showed another set worth about Tk 18,000 and they then tried to leave the shop without paying its price but the manager intercepted them and requested to pay the price, the witness added.

At this, they became angry and at one stage Shafiul Alam shot the manager in the left leg with his (Alam) pistol. Hearing the sound of calling bell (emergency), Shipu, victim of the case, made an attempt to go to the spot but Shafiul Alam shot him (Shipu) and then the three people fled the scene. the witness

# Huge arms dump explosion kills over 580 in Lagos

More than 580 bodies were pulled from a Lagos canal early yesterday after a massive crowd stampeded as it fled a huge arms dump explosion in the city, a distraught witness said

"I have counted more than 580 (bodies), I am looking for my children. I have been here since the morning," said Shola Odun, a printer

"One man here lost six of his children. He found them. He is dying," Odun added.

Black Africa's most densely inhabited city -- home to more than 10 million people -- was shaken repeatedly late Sunday by the massive explosions, set off by a fire at a military armoury.

An AFP photographer at the scene said he had witnessed more than 140 bodies being pulled from the water in the canal in the Isolo district during the time he was at the site, close to the area where the arms explosion happened.

AP adds: Rescue workers pulled more than 200 bodies from a canal yesterday after a series of large explosions at a munitions depot shook Nigeria's commercial capital, destroying homes and businesses over a wide area

The government has rejected an Awami League request for deployment of Ansar at the residence of the party chief and Leader of the Opposition in Parliament Sheikh Hasina.

"We paid the government Tk 82,728 for deployment of one section of Ansar at the opposition leader's Dhanmondi house called Sudha Sadan as advised by the office of the Adjutant of Ansar, said AL's Publicity Secretary Abdul Mannan

But he regretted that the office of the District Ansar Adjutant in a letter yesterday refused to make the deployment claiming that additional security force was not needed for the opposition leader's house, which was now being guarded by a group of policeman.

Mannan told The Daily Star last night that his party sought for the deployment of Ansar in the wake of the rising threat on the life of Hasina and paid the required money only as the authorities had accepted their demand.

Five injured in the accident were identified as Khairul, Papia Akhter, Zafar, Sujan and Ruma, They were admitted to Ashokathi Hospital.

In Manikganj, all the nine passengers of a three-wheeler (Nasiman) were seriously injured when the vehicle overturned and fell into roadside ditch at Tepra.

One of the injured Asaduzzaman, 11, died soon after admission to Sadar Hospital while Khorshed, 35, Majed, 35, Ziar Rahman, 25, Barek, 20, Maksudur Rahman, 42, Jasim are being treated at the hospital

## Attack on US office in Kolkata Pak national confesses his involvement before death?

The Indian government claimed that a Pakistani man, shot by police, confessed before dying yesterday that he participated in the attack on a US cultural center in Kolkata last week.

Home Secretary Kamal Pandey told a news conference that police in the small eastern state of Jharkand had shot two Pakistani men after raiding a "terrorist hide-out" in the town of Hazaribag at dawn yesterday.

One of the men, identified by police as Mohammed Salim, was killed in the shootout, said Hazaribag Police Chief Deepak Kumar, speaking by telephone from the town 290 kilometres south of Patna, capital of Bihar state

The other man, identified as Mohammed Idris, alias Mohammed Zahid, died in the government hospital after confessing to police that he was a Pakistani citizens and had fired on policemen guarding the American Center in Kolkata on Jan. 21, Kumar told The Associated Press.

He said both men had lived as shoe merchants for four months in a rented house that was surrounded by police at 2:30 am after receiving a tip. Kumar said the men were told to surrender, but did not respond and

were shot when they tried to escape at 6:30 am by opening fire.

He said an AK-47 assault rifle, which police believe may have been used in the Kolkata attack, was recovered in the house, along with 22,000 rupees in cash.

Kumar said that Zahid confessed he was the passenger aboard the motorcycle that drove past the American Center during a police shift change and that he had done the firing. Four policemen were killed and 18 other people, mostly police, were wounded. Kumar said the driver of the motorcycle, whom he identified as "Sadaquat" was still at large.

Police have arrested six people, including three Bangladeshis, in connection with the Kolkata attack, but had not said any of them were the gunman or the motorcycle driver.

In New Delhi, Home Secretary Kamal Pandey, confirmed the police account at a news conference, saying that "admitted he was a resident of Khanewal, in Multan district, Pakistan and had opened fire at the policemen guarding the American Center."
