### Sheikh Hasina's errors?

To the best of my knowledge, this is the third time a Contempt of Court petition has been brought against the Opposition Leader Sheikh

Previously in the high profile case brought by the Former President of the Supreme Court Bar Association, Habibul Islam Bhuiyan, as reported in 51 DLR (AD) 68, the Appellate Division said that it expected more circumspection, understanding, discretion and judgement on the part of the Prime Minister because of the high office she held.

In deciding whether there was contempt, the Court merely pointed out a famous dictum of a very highly regarded Judge of the House of Lords, Lord Atkin, which said, "even the wrong headed are permitted to err therein"

It is very clear that the Chief Justice only went in this path in order to prevent the Executive and the Judiciary from coming each other at loggerheads and also to preserve harmonious co-ordination and co-operation between the two wings of the State.

But now since, Sheikh Hasina is not the Head of the Executive, we can expect that the Court will take this matter with utmost importance and deliver a judgement to show the people that no one gets away with making such comments towards the Judiciary. We are eagerly awaiting the judgement from the High Court.

There are thousands of NGO offices located in almost all the residential areas of metropolis Dhaka. So far no regime has announced any corrective measures to shift these offices and business houses on roads, not earmarked for business activity, to other areas.

I do not sympathise with the present opposition political leaders who are brutalised by the police while trying to hold public gathering, obstructing the street in front of or near to their party office ignoring request from the police.

The political leaders, whoever in the opposition, and their followers, while in a protest gathering or procession, keep on prodding the police until they start beating them up. Their intention is to earn public sympathy by being victims to police atrocities. They have not yet got the message of the changed attitude of the general mass toward atrocities committed by the police.

I can still remember the day when, in 1973, two students were shot dead by the police in front of the National Press Club while protesting against the US policies in Vietnam. The news of the loss of lives of two students spread through Dhaka City like a wild fire. The City came to a stand still in no time. A shadow of deep sadness covered the whole City. These days when people get killed on a street by bomb blast or gunshot, the life becomes normal, even at that very place of occurrence, with in half an hour or less. Watching so many killings and brutalities day after day, to the credit of the political parties, the people of this country have lost the very human perception of getting shocked. The politicians would do better if they pay heed to this reality.

No doubt, hartal is a democratic right, but not the picketing at all. Nobody has the right, whether an Ex-Minister or a sitting MP, to make people observe hartal by putting them under the duress of picketing. They may ask people observe hartal, but who will pay heed to their call should depend on their own will. It's the duty of the police to save people from picketing.

Bangladesh has become a country of endless political agitation. In spite of hundreds of agitation and sacrificing dozens of lives in those agitations during the last 30 years, we have not yet been able to see the light at the end of the tunnel. We now want to

Mr. Zakaria's letter regarding Pakistan (January 26). Why is it "regrettable that we could not retain the geography created by our forefathers..."?
