## JS session from today: AL to stay out STAFF CORRESPONDENT

The eighth Jatiya Sangsad goes into its second session at 10 this morning with the main opposition Awami League (AL) sticking to its decision of staying out of the House.

President AQM Badruddoza Chowdhury is scheduled to address the opening sitting of the session, highlighting the policies and programmes of the BNP-led coalition government.

The second session will run trough March 18, according to a decision of the parliament's Business Advisory Committee (BAC) taken at a meeting yesterday. Chaired by Speaker Jamiruddin Sircar, the meeting also discussed different agenda of the session that may linger, provided fresh issues come up for disposal.

According to the parliament secretariat sources, the House would be adjourned immediately after the newly elected president addresses the House. The House

# Auto-rickshaws keep off roads, BRTA vows more stringent steps

**Breath of fresh air** 

Dhaka city dwellers yesterday had less toxic air to breathe thanks to the absence of pollutants-spewing two-stroke three wheelers. However, many office goers had to dig into their purse with little alternatives available to commute

Protesting a government decision to slap a ban on the movement of autorickshaws and tempos having no fitness certificates, most threewheelers remained off the city roads yesterday at the call of the Dhaka Auto-rickshaw Employees Union

As a result, the city thoroughfares were free of traffic jam in absence of some 60.000 three-wheelers.

Meantime, Some 13 associations of auto-rickshaw and tempo owners, drivers and employees are likely to announce today an indefinite strike from a rally at the Paltan Maidan.

Despite all the threats, the Bangladesh Road Transport Authority (BRTA) has asked owners of two-stroke auto-rickshaws to update their documents by February 18; otherwise, they cannot ply the city streets.

The move is part of stringent measures to check air pollution and ease traffic jam in the city.

Top BRTA officials said the two-stroke auto-rickshaws have to have fitness certificates, route permits and tax tokens and display the foolproof stickers on the windshield. Auto-rickshaws found without proper documents would be impounded.

## Salauddin succumbed to his injuries When death descends Siamese twins die at ICU

Grief and a sense of loss descended on the Intensive Care Unit (ICU) of the Dhaka Shishu Hospital (DSH) last night, as both the Siamese twins died vesterday.

One of the twins died yesterday morning. The baby surviving on a life-saving apparatus died from acidosis (presence of acids in the blood beyond normal limits). As reported from the ICU at 11 last night, the ventila-

About the baby who died in the morning, Prof. AFM Masood, the paediatric surgeon who led the operation on Tuesday, said, "The baby died at 10 in the morning from acidosis. Normally, the pH should be 7.3, but it continued to decline. As a result, acids rose beyond the tolerable limit."

The Asian Development Bank (ADB) indicated yesterday it might take interest in financing viable regional projects in the energy sector, identified by South Asian Regional Initiative/Energy (SARI/Energy), sources said.

The two-day fourth semi-annual meeting of the USAID sponsored SARI/Energy ended in the city yesterday, working out a training schedule for 2002 for selected people in energy sector in Bangladesh, India, Nepal and Bhutan.

Energy sector officials and experts from US, Bangladesh, India, Nepal Bhutan, Sri Lanka and the Maldives took part in the meeting. They discussed, among many

regional energy issues, a prefeasibility study for power wheeling between Bangladesh, India, Nepal and Bhutan.

Since its launching in Kathmandu in December '99, SARI had one meeting in Delhi and another in Colombo. ADB's S Chander, principal

## NCTB has to print 26 lakh more books

The secondary-level students are already into one month of the current academic year and yet the National Curriculum and Textbook Board (NCTB) has not met its deadline to print and distribute the textbooks among the students. It has now ordered fresh printing of 26.50 lakh additional books just yesterday, a day before the deadline ends. The NCTB initiated printing of

fresh books after it detected a

serious shortfall of textbooks that caused scarcity in the market. As it

appears today, the situation would remain unchanged for at least another month.

Sources said 70 printing companies were given the task to print 39 categories of books of class IV to IX. The printers are supposed to deliver the books within a week and would get about Tk 60 lakh for the job.

Now the printers say they would start distribution of the books within a week. But according to NCTB procedures, the printers have to buy paper before obtaining print orders. SEE PAGE 11 COL 7
