#### Bill to repeal **PSA** may be tabled in **JS today**

The government is likely to introduce in the Jatiya Sangsad a bill seeking repeal of the controversial Public Safety Act (PSA), as the parliament returns to session at 4.30pm today after a two-day weekly recess.

As approved by the cabine earlier, the planned bill empowers the government to selectively withdraw cases filed under the law with 'political motives'. Otherwise, all ongoing cases under this act will continue until their disposal.

#### PCP leader gunned down in Rangamati

A leader of Pahari Chhatra Parishad (PCP) was gunned down allegedly by the activists of United People's Democratic Front (UPDF) in Gagrabazar area under Kawkhali thana of the district, yesterday, police said.

The victim was identified as Bhubon Moni Chakma, 26, son of Padma Mohan Chakma of Chowdhurypara under Gagra union.

Local people said the gunmen opened fire on Bhubon Moni while he was standing in front of a shop at

## Hole in the net!

### DCC says its coffer is empty, but does not collect tax from lakhs of holdings

The Dhaka City Corporation (DCC) is deprived of holding tax from lakhs of holdings in its 360 square kilometre area, according to figures published in the annual report 2001 of the Bureau of Statistics

There are nearly 1,80,000 households registered with the DCC's Revenue Department and it collects about Tk 100 crore as holding tax between July 1 and June 30 every financial year. But the Bureau report showed there are 11,07,474 holdings in the area.

Sources at the DCC said if half of these new holdings come under taxation, the DCC's revenue earnings would go up by crores of taka annually. Due to procedural complexities and 'unwillingness' of the mayor to abide by the City Corporation Ordinance and reassess holding tax for more than 10 years, these new households are escaping tax.

Not all the holdings come under the DCC taxation. If a multistoried housing complex is built on a plot and retained by a single owner, the plot owner pays tax for one single unit. But thousands of apartments built over

the years under separate ownership have not been taken into account by the DCC.

Over the last 10 years, multi-unit complexes have been built on 'single unit plots' and sold out to individuals. The practice is still continuing at a very high pace. But due to absence of assessment and monitoring, the DCC's Revenue Department has failed to keep track of

the tax evaders. Sources said that in thousands of cases, when a house owner showed willingness to register his name as holding tax payer, zonal tax inspectors offered them 'convenient' assessment in exchange for bribes, depriving the DCC of huge amounts of tax.

Complexities in the assessment procedure have led to irregular practices to such an extent that the DCC is now struggling hard to cope with its expenses. It is now in such a financial crisis that its senior officials do not know how to pay the staff this month's salary and the Eig bonus, sources said.

#### SSC candidate beaten to death at Khilgaon

A school boy was beaten to death by a garment employee and his accomplices at a playground at Khilgaon Chowdhurypara in the city yesterday.

Russel Ahmed, 16, an SSC candidate from Khilgaon High School, was beaten up mercilessly by Malek, a garment employee and his accomplices following a row over playing cricket yesterday morning. The attackers left the spot,

leaving Russel in a pool of blood. Russel was admitted to Dhaka Medical College Hospital (DMCH) at about 10 am and then shifted to a

private clinic at Shahjahanpur. He succumbed to his injuries at the clinic in the afternoon.

Khilgaon police recovered the body and sent it to the DMCH morgue for autopsy.

Russel's father filed a murder case with Khilgaon Police Station. Police arrested Malek's father Abdus Sobhan, mother Hamida Begum, and two aunts-Tohida Begum and Jarina Begum-in connection with the

Police could not arrest Malek and his accomplices till writing of this report last night.
