Law soon to 'wipe out' polybags from Mar 1

The government has decided to enact a new law to ban production, marketing and use of all types of polythene shopping bags in the country from March 1.

Official sources said the Ministry of Environment and Forest has already prepared a draft of the law and is expected to place it in tomorrow's cabinet meeting for approval.

The enactment of the proposed new legislation is being pursued on an urgent basis as production and marketing of polythene shopping bags has continued unabated despite a ban on marketing and use of thin polybags in Dhaka City already in place since January 1.

Officials said producers continued massive production and marketing of slightly thicker bags that have flooded the markets

Sources said the Environment Ministry in its draft of the law will be proposing amendments to the existing environment-related laws and adding new articles to permanently stop production, marketing and use of polybags all over the country.

The ministry in the draft proposes both jail and fine for production, marketing and also use of polybags with a maximum 10-year jail term for production and marketing along with a huge fine, and a token fine of maximum Tk 500 for use of polybags. The draft law has also proposed setting up mobile courts for summary trial on the spot.

After cabinet's approval, the draft will be sent to the Law Ministry for formulation of the law and placed in the current session of the Jatiya Sangsad.

However, there will be no restriction on other polythene as well as plastic products. Also polybags produced solely for export will remain outside the purview of the ban

A study of the Environment Ministry said around 129 million polybags are produced in the country daily. Since polythene bags are not biodegradable, they remain intact in the ground for a very long time and destroy soil fertility.

Gasping for air ... Lone asthma hospital limping: Most

Eighty-five-year old Nurul Haq has been suffering from chronic obstructive pulmonary disease (COPD) or acute asthma for the last one year and a half and his condition has deteriorated this winter

patients don't get treatment

Now he cannot breathe normally and has to depend on life saving drugs and oxygen mask almost regularly for survival.

Nurul Haq is one of the large number patients, mostly above 70, who suffer like him and almost two thirds of them go without proper medicare, said doctors at the Institute of Diseases of the Chest and Hospital (IDCH) at Mahakhali in the city. It is the only hospital for treatment of asthma.

Experts say about seventy lakh people in the country suffer from asthma. They suffer badly during the winter, as cold 'triggers narrowing of smaller windpipes of the lungs, resulting in breathing problem." There are other factors also, but cold is the major one.

Patients at the IDCH now do not get required drugs, mostly inhalers, from government supply and have to buy those on their own.

The Asthma Centre run by the Asthma Association of Bangladesh with government support arranges a limited supply of 'short priod' inhalers. A small number of poor patients at the hospital are given those free of

Nurul Haq, who hails from Faridpur district, was brought to the hospital on Wednesday as his condition turned critical. For temporary relief, he was given oxygen, hydrocorticone injection and nebuliser solution to enable him to breathe.

"In fact, there are no emergency treatment facilities at the hospital for those who suffer from acute asthma or COPD. Life saving drugs are also not available regularly at the intensive care unit of the hospital," said one doctor seeking anonymity.

He went on, "Asthma and COPD patients regularly require preventive steroid drugs like Asmacort, Beclofort, Beclomin, Seritide, Decomit, Tylade, Intal and solutions Respolin and Nebuliser. But we get no supply of the drugs from the government
