The ministry also recently asked the ISPs to pay a new range of yearly fee' according to the usage of satellite bandwidth -- Tk 50,000 for using 64 kilobits per second (kbps) of bandwidth, Tk 100,000 for 128 kbps, Tk 200,000 for 256 kbps and Tk 300,000 for 512 kbps. ISPs
