# Kabul mission plan dropped

The government has dropped a plan to open a resident diplomatic mission in Kabul, sources said.

Rather, it now wants to oversee developments in Afghanistan through any of its missions in Islamabad, New Delhi or Tashkent.

Foreign Secretary Shamsher Mobin Chowdhury talking to The Daily Star said: "A resident mission in Kabul is not in our mind now. We will operate there through a non-resident mission.

He however declined to name any particular country where the nonresident mission would be set up, but said it could operate from any of the neighbouring countries.

Besides having large missions in the Indian and Pakistani capitals, Dhaka also has a sizeable diplomatic presence in the Uzbekistan capital of Tashkent.

The opening of a fully-fledged embassy in Kabul received serious consideration following Bangladesh's keen interest in the reconstruction and rehabilitation process of the war-ravaged country.

Dhaka had ambassadorial representation in Kabul till late 1980s, when it closed its mission following the Soviet invasion and consequent destabilisation of the country.

However, many feel that absence of a mission in Kabul will discourage businessmen and NGO's in exploiting the opportunity of participating in the reconstruction process of Afghanistan

Bangladesh has bright scope of exporting raw jute and jute products besides tea to Afghanistan.

# Students vacate CU halls for fresh entry

Resident students of Chittagong University (CU) yesterday vacated all the six male halls as per an agreement reached between the authorities and the Bangladesh Chhatra League (BCL) Tuesday. The authorities had earlier

asked resident students to leave the halls by 9:00am. Around 200 resident students, mostly Islami Chhatra Shibir (ICS) activists, left

the halls by the deadline. Provosts will start checking IDs from 9:00am today to let only the genuine resident students in their respective halls

Meanwhile, the university reopens tomorrow after eight month's stand off. The deadlock ended after the BCL's CU chapter called off its siege programme following a meeting with the uni-

versitv authorities on Tuesday. About 100 more police personnel were deployed on the campus

All 23 accused in ex-KCC mayor **Bablu murder**

All the 23 accused in ex-KCC deputy mayor Ikhtiaruddin Bablu murder case were acquitted by the Additional District and Sessions Judge's Cour here yesterday.

After examining records and witnesses, Judge Mirza Mohammad Abdur Rouf acquitted the accused as he found them not guilty of murder.

Bablu was gunned down on August 22, 1997 near his residence at Banargati under Sonadanga thana.

A case was recorded the same day naming 22 persons and 25 unidentified others as accused by complainant Jahanara Begum, wife of slain Bablu.

The chargesheet was submitted to CMM's Court on December 31, 1997 accusing 24 persons.

One of 24 chargesheeted accused, identified as Manu Shaikh was killed last year also in Banargat area.

Manu Sheikh was one of the masterminds behind the murder as learnt from the complainant. Twelve prosecution witnesses were crossexamined during the trial

Nineteen accused were present in the court when judgement was delivered. Four accused were tried in absentia. They are notorious terrorists Asaduzzaman Litu, Mushfegur Rahman Hirok, Shah Alam and Rezaul Karim

Mushfequr Rahman are also accused in Janakantha journalist Shamsur Rahman murder case.

Other accused are Elu. Dollar. Motaleb, Asad, Halim, Abul Kashem Alamgir, Harun-ar-Rashid, Rafique, Enamul, Lipu, Mastan Farid, Azhar, Shahadat, Nasiruddin Babu, Delwar, Rahim, ATM Arif and Moin.

# AL again calls for CEC's quit

Awami League Central Working Committee (ALCWC) in an emergency meeting yesterday once again demanded immediate resignation of the Chief Election Commissioner (CEC) MASyed.

Held at party central office in the city with AL president Sheikh Hasina in the chair, the meeting resolved not to participate in any elections under the current CEC as "he had lost his credibility" during the October 1, 2001 polls

The resolution also warned the government against killings, coups, repression and conflict.

The decision came at a time when the Election Commission is planning to announce schedules for election to three city corporations in Dhaka, Rajshahi and Khulna, and also amidst growing concern over nighttime surveillance around Sheikh Hasina's Dhanmondi residence and raids on the houses of her

The meeting decided that AL central leaders would embark upon a cross-country organisational tour

programme throughout March to build up public resistance against "unabated oppression and terrorism in the country." Hasina would initiate the tour programme by visiting some northern districts including Rajshahi and Rangpur from March 2 through 5.

Due to prolonged Eid vacationing, many of the 67 ALCWC members however could not come to the meeting that began at around 4:30pm and continued till 8:30pm, party sources said.

Issues about joining the parliament and the forthcoming city corporation election were however not discussed, party general secretary Zillur Rahman told reporters

Referring to yesterday's arrest of Bahauddin Nasim, a political aide to Sheikh Hasina, the AL chief's Political Secretary Saber Hossain Chowdhury said the government had shifted its focus from the countryside to Dhaka, oppressing AL leaders and workers at the central level now.
