Govt considers exchange of electricity among SAARC states, JS told

BSS, Dhaka
 The government is considering a plan for exchange of electricity among the SAARC countries, State Minister for Power, Energy and Mineral Resources (Power Division) Iqbal Hasan Mahmud said in the city yesterday.
 Replying to a question from Prof Shahidul Islam of BNP from Kushtia in the Jatiya Sangsad yesterday, said the government was also examining matters relating to exchange of electricity between Bangladesh and India. "There is a proposal from India to set up an electricity plant at Bheramara in Kushtia under joint venture, so that surplus electricity can be exported," he told the questioner.
 Prof Shahidul Islam raised the question on behalf of Md Mahirul Huq Chowdhury of BNP from Comilla.
 However, on another supplementary from Moazzem Hossain Alal of BNP from Barisal, the state minister said Bangladesh might import electricity from Nepal and Bhutan on the basis of discussion with them. "We will take decision on this matter only through discussion with our neighbours," he told another questioner Mia Golam Parwar (Jamaat-Khulna).
 On a question from Golam Mohammad Siraj of BNP from Bogra, Mahmud said the Power Development Board (PDB) had already formulated the six five-year plan for a permanent solution of electricity crisis in the country.
 "The highest demand for electricity in 2002 will be 3,659 MW while it will shoot up to 6,071 MW in 2007," he said. According to this five-year plan, he said, an additional 3,919 MW would have to be included in the current power generation system.
 Mahmud said this additional generation would require a huge cost.
 On supplementaries raised by BNP and Jamaat legislators Kazi Alauddin, Jamaat Habid Dulal, Principal Sohrabuddin and Hafizuddin Ahmed, he said, the government would provide electricity to all areas of the country after availability of funds.

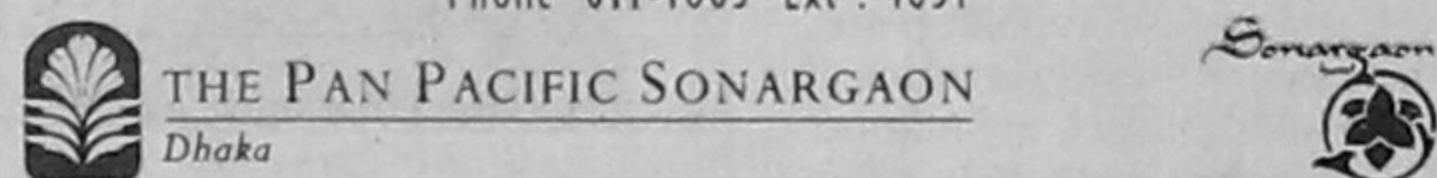

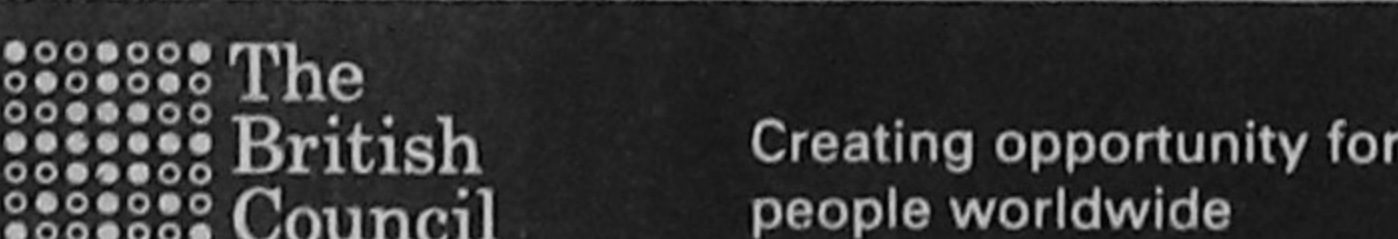
