Development and hindrances in small and medium enterprises

N an impoverished country like Bangladesh, poverty alleviation through industrial growth as well as large-scale employment generation is heavily dependent on the development and expansion of small and medium scale enterprises (SMEs). Available evidence suggests that during 1980s SMEs alone were responsible for giving birth to 59 percent of new industrial enterprises in Bangladesh, Moreover, current share of SMEs stands at around five percent of the total industrial sector contribution. 11 percent of the value addition to GDP. This sub-sector now accounts for 82 percent of the total industrial labour force and generates 45 to 50 percent of the manufacturing value added. By and large, therefore, the role of SMEs in industrial employment and value added is quite substantial. Nevertheless, this critically important economic component in Bangladesh is shambling with numerous operational constraints resulting from lack of appropriate policy support and resource availability. Thus, immediate need for various financial concessions along with the formulation and implementation of innovative poliand sustainability of SMEs have become imperative.

Especially, necessity of providing the SMEs with adequate policy support in Bandladesh increased with the introduction of the structural adjustment programme. under the open and liberalized market economy regime the SMEs have been exposed to a much greater competitive environment both in the domestic and international markets

In the subsequent sections, we would try to address the major policy constraints to the development of SMEs in Bangladesh. Besides, in the end, we would provide a brief outline of the steps necessary to ameliorate the policy environment.

Finance: Till today financing remains the major problem for the SMEs in Bangladesh. According to the industrial policy (IP) 1991, the term SME refers to the undertaking engaged either in manufacturing, processing or service activity whose total fixed investment excluding the value of land is limited to Taka 30 million. The enterprises within this range of capital investment neither have the access to the equity market nor to the insecure institutional credit, in generally available to larger firms. Apart from certain forms of institutional credit accessible options for finance to the SMEs are family and informal credit, which understandably are insufficient to opment of SMEs. Furthermore, the institutional

credit offers hard choice to the SMEs by putting difficult prerequisites, which include expensive collateral like real-state (land and buildings), complex documentation, unusual delays in processing, transaction cost etc, and in addition, high interest rates (which vary from 14 per cent of 22 percent or more). In fact, all these adverse factors together makes the effective interest rate much higher and in turn, reduce the net expected return of doing business on institutional credit. However, a recent study of a sample of 47 enterprises selected from different parts of Bangladesh reconfirmed the observation that SMEs severely restricted access to institutional credit

Regulatory and Legal frameworks: The present regulatory and legal frameworks for SMEs are inadequate and in some cases counter productive. Particularly legal measures often appear as ambiguous and incomplete. Consequently these raise the risk of institutional lenders and delimit their credit

the sole authority for regulatory and legal operations, discriminatory treatment, bureaucratic delays and inefficiency are considered as other bottlenecks of the sector.

Skill Development Policy Support: SMEs in Bangladesh often lack skills related to modern management and entrepreneurship as well as in developed financial and business planning including legal affairs. Which alone in many cases are responsible for inefficient business and credit negotiations, improper handling of legal aspects and eventual sickness or bankruptcy of SMEs. Co-ordinated policy measures to overcome skill deficiencies are yet to be in place.

Policy on Access to Information Timely and transparent flow of information relating to scopes, opportunities, procedures and changes occur and exist in the institutional framework for SMEs are severely distorted and limited. which also contributes as a deterrent to the growth potentials of this sector. No effective policy framework is formulated up to now to this

Non-implementation of Policy Measures: It has come out as a disappointing observation that most of the policy measures take in several occasions including in the IPs of 91 and 97 as the reformative efforts conducive to the SMEs are remained ineffective and unimplemented

Recommendations: To improve credit availability to the SMEs major reform in institutional credit system is inevitable Among others, real state collateral can be singled out to deal with separately as it poses basic hurdles in getting credit from banks and nonbanking financial institutions. In this case non-real state possessions should be considered as an effective alternative.

Drastic restructuring of the institutional frameworks of regulatory and legal systems has become over due. Gradual shifting of overall SME promotion and regulatory responsibilities from centralized Government agencies to suitable private agencies warrant serious consideration. Anomalous, incomplete and equivocal legal measures should also be corrected. In addition, to accommodate innovative financing

To develop entrepreneurial and managerial skills in SMEs, steps to formulate an appropriate package of capacity building raining and counseling through collaborative consultation of concerned agencies from Govt (BSCIC, BOI etc), non-Govt (WB, JOBS, GTZ, NGOs) and private sector (Chambers) should be taken. Furthermore, effective implementation along with subsequent impact follow-up of the same by appropriate partner organizations should be ensured.

To ensure transparency and flow of information, appropriate policy measures should be formulated Moreover, an organization should be established by taking representatives from partner agencies which will be entrusted with building-up of a national data-base exclusively for SME sector where one stop information service for interested parties will be ensured.

An apex watch-dog umbrella forum should be developed by including representatives from concerned Govt, non-Govt (WB, JOBS, GTZ, NGOs), and private sectors (chambers) to monitor effective implementation of measures formulated for the growth of SMEs in industrial policies, as well as in other documentation, whatso-

Resurgence of Islam in America Mohammad Amjad Hossain

N the wake of horrendous cowardly attacks by so-called terrorists on twin towers of the World trade center in New York and Department of Defence: Pentagon in Washington the Muslims without cogent reasons have been subjected to harassment. deportation and confinement in jail The recent bill enacting setting up of military tribunals authorizing the trial of suspected terrorists, particularly foreign origin of Americans has evoked sharp reaction from liberal Americans, including former President Jimmy Carter and the United Nations Human Rights Chief Mary Robinson. The law is contrary to the rights and privilege enjoyed by Americans. It also negates the independent and impartial nature of American judiciary. The former American President retorted by saying that it defies the basic principles on which the United States is founded. Jimmy Carter said at a conference at the University of San Diego that every one of those principles is missing in the present existing order issued by the White House concerning uniform and concerning military trials. Jimmy Carter further added, 'I

am deeply concerned by some of

Attorney General.' The United

Nations High Commissioner for

Human Rights Mary Robinson

criticized the United States action

for the formation of military tribunals

and said the United States was

defving its own system of checks

and balances, including the right to

fair trial. Following the September 11 terror attacks on the United States more than six hundred people were detained without any charge for interrogation. This secretive detention also came under attack from the former President, Search warrants have been issued for hunting down Muslim students who are not attending classes on a regular basis have student visa. Possibly their stay order would likely to be dispensed with if they are found not as a regular

Actually pro-Israeli lobbyists in the United States have sought to undermine the spread of Islam and stem the increasing political significance of Muslim organization in the United States. Pro-Israeli Jewish Organizations are flooding nerican media with information allegedly linking Muslims organizations with terrorists. Muslim Organizations and activists are arguing that terrorism is the outcome of Israeli atrocities against Palestinians and the foreign policy of the United States in the Middle Fast, which is tilted toward Israel. Muslims in America tend to hold the opinion that Israelis may have committed the attacks on September 11. American Muslims are being, by and large, treated as suspects by Bush Administration and the additional attacks from their cousins [Jews and Muslims are biblical cousins from the two sons of Prophet Abraham, Sm.] are making in fact, matter worse.

The word Jihad particularly drew attention of the non-Muslim Community in America. Jihad has been presented as holy war to kill all 'infidels.' This notion of Jihad is a false distortion of the fact. The word Jihad has got wide circulation because of the disproportionate media coverage of fanatics, such as. Osama bin Laden, who report-

edly called on all Muslims to wage a Jihad against all infidels. Jihad literally means struggle, not holy war. Osama bin Laden was made hero by widest possible coverage by the media in America. In Quran, it is known as qital. Jihad in fact encompasses broad which is meant struggle to obey Allah's commandments Jihad al nafs is struggle against one self. Therefore, the word Jihad is related to prayers five times a day, fasting, Zakah, the Hajj and Imama

The most frequently quoted Hadith in this context is this that the Prophet Muhammad (peace be upon him) upon returning from the battle field remarked to his companions that they were returning from the 'lesser Jihad' of fighting to the 'Greater Jihad' of struggling against the evil temptation of the soul.

Allah permits to fight for cause of Allah who fight against you but do not transgress limits; for Allah loveth not transgressors. (Verse 190, sura Baqarah). In Islam, war is permissible in self-defense and that too is governed by strict rules. If the enemy even slightly indicates towards peace, Muslims are commanded to make peace. Islam teaches to be kind towards orphans. widows and parents. No political or religious cause could ever justify the horrible crimes perpetrated by terrorists on 11 September against the United States.

Perhaps the Bush administration has realized anti-Islam trend in America as can be seen by Mrs Dick Cheney's comments at the anti-Defamation League dinner in Chicago 12 November wherein she expressed the opinion that Muslims should not be blamed for the actions of a fanatic few. It was followed by President George W. Bush. who condemned anti-Muslim and anti-

Islamic Xenophobia. The President told Americans that Islam's teachings are good and peaceful. He said, the terrorists practice a fringe form of Islamic extremism that has been rejected by Muslim Scholars and the vast majority of Muslim clerics. For the first time an American President hosted Ramadam fast breaking meal for Ambassadors from Muslim countries at the White House. He visited an Islamic school and invited Muslim Leaders to the White House while Franklin Graham, son of Rev Billy Graham, who gave the benediction at Bush's Presidential inauguration last January castigated Islam as inherently evil. Franklin Graham is the priest at Christian evangelist's movement which provided political and financial support to Bush during his Presidential campaign.

With some six million Muslims in the United States Islam is said to be the nation's fastest growing religion as a result of influx of immigration high birth rate and widespread conversion. After 11 September American witnessed large segments of non-Muslims, particularly Hispanic, which constitutes 12.5 per cent of the population of America, embraced Islam as their faith. The process of acceptance of Islam by non-Muslim Americans has begur in America and it will continue. One expert estimates that 25,000 people a year become Muslims in America. Some clerics say they have seen conversion rates quadruple since 11 September.
