# Bid to make Unocal pay for Magurchhara mess

Nearly six years after the Magurchhara blow-out, Petrobangla is getting ready to officially claim around US\$ 600 million in compensation from US oil company Unocal for damaging the gas structure in the 1997 mess.

According to a well-placed source, the board of directors of Petrobandla will sit within a week or two to decide the exact nature of the compensation

It is likely to ask Unocal to compensate for damaging 240 billion cubic fee (bcf) of gas of the Magurchhara gas structure, the source added.

The exact financial figure is yet to be worked out, but Petrobangla sources said it could be around \$2.6 for per unit (thousand cubic feet or tcf) of gas, the price at which Unocal sells gas to Petrobangla from the Jalalabad

Such calculation puts the total claim figure at \$600 million. "However, there might be other ideas about compensation figure. That's

why, the Petrobangla board would discuss it," said the source. Earlier, the Ministry of Environment claimed Tk 612 crore in environmen-

The planned compensation claim is based on findings and assessments of a probe committee report prepared after the Magurchhara blowout.

The whole process is going too slow," observed an official. "and it seems that we did not actually suffer any loss in the Magurchhara blow-out."

Though the incident took place back in June 14, 1997, Petrobandla could not demand the gas damage compensation as the past Awami League (AL) government shelved the official probe report on the Magurchhara blow-out and kept it as a 'classified' document.

Moreover, the AL government adopted a policy to let US oil company Occidental, found responsible for the blow out, operate in the country without being penalised.

The terminated production sharing contract (PSC) with the Occidental was extended in 1998, allowing it to work in Bangladesh and sell off its concerns in Bangladesh to Unocal before packing up in 1999.

In late 2000, the Parliamentary Standing Committee on Energy raised the issue of the report of Magurchhara probe committee formed with energy ministry and Petrobangla officials. A tug of war followed between the then energy secretary Toufiq-e-Elahi Chowdhury and standing committee head

The political activists have been remanded for five days yesterday in a case filed with the Demra Police Station while the rest were sent to the Dhaka Central Jail.

They arrested are: Shani Datt. city unit joint secretary of AL; Moktar Hossain, an activist of BCL; Abu Bakar Siddique, Dhania unit of BCL general secretary; another BCL leader Monirul Alam, Mohammad Ashraf, Kajal Chandra Sarkar, Liton. Krishna, Uttam, Hamid, Arif, Shah Alam, Reaz, Jahirul, Abul Hossain, Anwar Hossain, Hanif, Amin, Moselm, Shah Alam, Abu Shahid and Manurul.

### 22 including AL, 8 die as bus skids off **Dhaka-Ctg highway**

Eight people, including a female joint district judge, were killed and over 25 others injured when a bus skidded off the Dhaka-Chittagong Highway into a ditch at Tribardi in Sonargaon upazila yesterday

Sabrina Ahmed, 40, joint district judge of the Comilla Judge's Court, was the youngest daughter of late justice Hasibuddin Ahmed.

The fatal accident left Rehana Sultana, 30, killed on the spot and her husband Ataur Rahman, joint secretary of the Civil Aviation Authority of Bangladesh, and their son Sabnan Fayaz critically injured.

Three of the dead are Bazlur Rahmn 38, son of Ali Akber of Baghmara in Comilla, Abul Hossain, 40, a jawan of Comilla Cantonment and son of Abdul Jabber, and Farhad Chowdhury, 50, an employee of ICDDR, B in Dhaka.

The identity of the rest -- a woman, aged about 35, and two men, aged between 35 and 45, could not be known till last night.

Critically injured, Ataur and his ten-year-old son Fayaz, Abdur Rab Mohammad Mamun, Yasin and Faruk were rushed to a hospital in the capital. The rest of the injured were admitted to the Sonargaon Upazila Heath Complex.

The 52-seater Comilla-bound bus (Tisha) from Dhaka plunged into the roadside ditch at Tribardi near Daudkandi bus stand, as one of its rear wheels deflated at about 10.00am.

Five passengers died on the
