Bangladesh Shilpa Rin Sangstha (BSRS) has earned a profit of Tk 10.81 crore before tax during the fiscal year 2000-2001 which is 62 per cent higher than that of the previous year, says a press release. Out of the profit, Tk 87.50 lakh will

be paid to the government as dividend. The above information was

disclosed while approving the audited accounts of BSRS for the fiscal year 2000-2001 at a meeting of the Board of Directors of BSRS held at the head office of the Sangstha on Sunday. The Board expressed its satis-

Japan to take US steel tariffs to WTO this week AFP, Tokyo

Japan's trade minister said Monday Tokyo would lodge a protest with the World Trade Organization (WTO) this week against a US decision to slap tariffs on steel imports, a news report said

"Immediately after (the United States) takes measures, we will appeal to the WTO," Takeo Hiranuma, Japan's trade and economic and industry minister, told Japanese reporters, according to Jiji Press news agency.

Washington announced on March 5 it would impose tariffs of up to 30 per cent on certain imported steel. The measures are due to come into effect on Wednesday.

Japan lodged an initial complaint in early March with the global trade body against the US action, but no official request has been filed yet by Tokyo for the WTO to launch a procedure over the planned US steel tariffs

The European Union has launched a double counter-attack seeking consultations under the safeguard agreement and a case to be started in the dispute settlement



Workshop calls for uniform public procurement system

A uniform public procurement system should be introduced for all public procurement agencies to curb graft as well as to eliminate ambiguity in the process, a workshop in the city observed yesterday.

Discussants and participants in the workshop on 'Public Procurement' also stressed the need for constitution of a separate body for overseeing lapses in the public procurement process.

Dhaka Chamber of Commerce and Industry (DCCI) organised the seminar in cooperation with Center for International Private Enterprise (CIPE), an affiliate of the US Chamber of Commerce. International Chamber of Commerce (ICC), Bangladesh chapter President Mahbubur Rahmanm chaired the seminar where AN Wahid, former economic minister in Bangladesh Embassy in Beijing, presented the keynote

paper Among others, DCCI President Matiur Rahman, Director of Department of Supply and Inspection (DSI) SMA Gofran Gazi and Chief Executive Officer of Energypac Power Generation Ltd Humayun Rashid also spoke in the seminar

In his presentation, AN Wahid said presently public procurement

They keynote paper says at least five sets of procurement procedures are being used by the agencies concerned. AN Wahid specifically mentioned out of 14 big organisations, five including Bangladesh Power Development Board (BPDB) do not have even procurement manual. In 2000-2001, Tk 1008.16 crore was allocated for the BPDB for its development expenditure. The BPDB was among the top three organisations in terms of getting development allocation in the year.

ICC, Bangladesh President Mahbubur Rahman said in different international forums, Bangladesh is mentioned as one of the countries, where bribery and corruption are quite widespread in the case of procurement. There should be guidelines to stop bribery and corruption in the procurement process, he observed.

DSI Director Gofran Gazi said public procurement involves not only public money but also involves public interest. "There should be an uniform guideline for all procurement agencies", he said

Privatisation is belatedly gathering pace in Asia, offering opportunities for investors regaining an appetite for risk, but fancy political footwork will be needed to turn what is now a ripple into a wave

Sceptics say they have heard the story before and remain to be convinced that governments are ready to take on powerful vested interests and translate fine intentions into practice

Even optimists concede that, with the notable exception of South Korea, progress is maddeningly slow.

Still, nearly five years after Asia's financial crisis saddled governments with huge debts and added an array of failed banks and firms to an already bloated inventory of stateowned assets, they say the news flow is turning positive.

From India to Indonesia, Bangkok to Beijing, governments are responding to pressure to plug holes in their budgets by putting more assets on the block.

Thai think-tank sees modest 2002 recovery

Thailand's troubled economy expanded faster than expected in the last quarter of 2001 despite a painful global slowdown but will only grow two to three per cent this year, Thailand's state economic think tank said Monday.

The National Economic and Social Development Board (NESDB), which compiles official aross domestic product (GDP) figures, said the economy grew 1.8 per cent last year, above the previous forecast of 1.5 per cent. The NESDB's prediction of 2002

growth was well below the government forecast of 3.4 per cent.

Most market forecasts also expect stronger growth this year. Merrill Lynch recently raised its prediction to three per cent from two per cent, while Citibank lifted its forecast to 3.6 per cent from 2.5 per cent.

The NESDB said it expected exports to rise 2.3 per cent in 2002 after a 6.9 per cent drop in 2001 Imports were forecast to grow 4.6 per cent after falling 2.8 per cent last vear.

The think tank's trade forecasts were more bullish than those of the government, which despite predictng higher GDP growth expected exports to drop 1.5 per cent and mports off 1.3 per cent.

Different currency exchange rates are one reason for the discrepancy. The government says a stable level for the baht this year is 43.5 to the dollar, while the NESDB said its forecasts were based on an average baht rate of 44.5. The baht has gained strongly against the dollar this year and was trading at around 43.30 per dollar on Monday morn-

Khosru seeks free market access to China UNB, Dhaka

Renewing Bangladesh's keen interest to raise its export volume to China, Commerce Minister Amir Khosru Mahmud Chowdhury has

sought cooperation of China for tax and quota-free access of Bangladesh goods to its market.

He made the call when a sixmember team of Chinese Association for International

There is a provision in the WTO rules to give a least developed country tax and quota-free access to other countries under bilateral trade, he said adding Bangladesh expected such advantage from China as Bangladesh was already enjoying such facilities from most EU countries

Wang Gouxian assured the minister that positive steps would be taken so that Bangladesh could increase its export volume to China. 'Bangladesh has potentials to export quality goods at competitive prices," he said.
