

# PDB in personnel crisis

## Shortage of technical manpower tells on power generation

With the country's rickety power infrastructure under strains to meet a 10 per cent annualised demand growth, manpower shortage, especially at technical positions, is serving a double blow to Power Development Board (PDB) activities.

The board is running short of at least 170 officials, including some top and technical ones.

Even the six-member PDB board, which covers different technical and commercial aspects of the sector, is operating at half its strength.

Overall, more than 6,000 posts lie vacant at present and the number is on the rise as recruitment remains extremely slow, sources said.

The post of member (generation) has remained vacant for more than 20 months since SM Shamsul Islam went on leave prior to retirement (LPR) on August 2000.

With demand for power growing and the sector undergoing thorough reforms, the post is very important, said one PDB official.

The post of member (transmission) lies vacant for five months and member (planning and designing) for more than a month.

The PDB is also short of 167 engineers and, insiders say, shortage of technical manpower has told upon the quality of the country's power supply scenario over the last few years.

According to the government-approved organogram, the PDB should

have 28,077 officials and employees. However, at present, there are 21,909 people on its payroll.

The personnel shortage has led to various complications in PDB operations, sources said, adding that some officials and employees have to carry out additional responsibilities.

Even the PDB chairman has to bear additional burden. Syed Abdul Mayeed has been filling in for member (generation) and member (planning and designing).

Meanwhile, Rahmatul Bari, who is member (distribution), has been discharging the duties of member (transmission).

In a letter to the prime minister on March 14 this year, the Institution of Engineers, Bangladesh (IEB) expressed concern over the vacant posts on the PDB Board, calling for immediate steps to fill these in with eligible engineers, sources said.

The government approved the current PDB setup in the early 1980s.

Over the last two decades, new plants, and transmission and distribution lines have been installed to meet an increasing demand for power.

However, according to sources, the authorities remain reluctant about fresh recruitment.

"You cannot expect a better service when you are operating with inadequate manpower."

## Find alternative to hartal, Hasina asks shopowners

Opposition Leader and Awami League President Sheikh Hasina yesterday asked for alternatives to hartal in protesting 'repression' by the government.

Responding to a plea of shop owners not to call hartal anymore, Hasina said, "We don't want people to suffer. That's why we opted for peaceful programmes like hunger strike. But they (the government) barred us from doing that as well."

The Dhaka Metropolitan Shop Owners' Association leaders met Hasina at her Dhanmondi residence yesterday evening and urged her not to call hartal anymore.

Referring to the government's crackdown on meetings, processions and use of loud speakers, the AL president said, "As they (the government) repeatedly denied us the right to stage peaceful programmes, people wanted us to call hartal for two or three days at a stretch. But we only called a one-day hartal."

She recalled her earlier promise not to call hartal and said, "When I made the promise, the then opposi-

## Jubo Dal leader murder: Abu Taher, 15 others chargesheeted

Laxmipur Awami League leader and Municipal Chairman Abu Taher and 15 others have been chargesheeted in Juba Dal leader Kamal Hossain murder case.

Officer-in-charge (OC) of Laxmipur sadar thana and investigation officer of the case Kamal Hossain submitted the charge sheet to the court yesterday.

Mohammad Kamal Hossain, son of Alaudin and leader of town unit of Juba Dal, was kidnapped from his South Majupur residence on August 31, 2000.

The miscreants took Kamal to the house of Abu Taher, beat him with hammer and then sent him to Laxmipur Sadar Hospital, where he succumbed to his injuries after few days.

Kamal's father lodged the case accusing 16 persons with Sadar thana police on October 25 in 2001.

## Dengue back again

Dengue is back again. And a number of city hospitals and private clinics have reported receiving dengue patients in the past one month.

With the onset of seasonal rains, the mosquito borne disease, which claimed 93 lives in the country in 2000, has reemerged and experts fear it would be equally fatal this season like the previous years. More than 5000 people were infected with the viral disease last year.

Al-Raji hospital at Farmgate reported receiving two dengue patients this past week. Both the patients were diagnosed with clinical dengue infection. They were however released after recovery.

Samorita Hospital at Panthapath received five patients since early March. "All the patients had classical dengue," said a doctor yesterday.

Nivedita Child Hospital at Dhanmondi received 12 children with dengue since mid-March. Two patients are still under treatment there.

The Central Hospital also received two dengue patients, who got cured after seven days of high fever.

The Dhaka Medical College Hospital and the Shishu Hospital also received three patients each in last one month.

Meanwhile, some city diagnostic centres also found dengue virus in a



number of blood tests. Most of the centres used the alisa method to confirm the presence of the antibody.

Lab-Aid received more than 20 suspected blood samples in the last two weeks and found dengue virus in three.

Popular Diagnostic also diagnosed dengue in eight samples in the last two weeks.

Dengue has become a major international public health concern. Bangladesh is the latest among about hundred other countries that experienced the deadly disease in three.

## Armed youths ransack cyber cafe

Some armed youths allegedly belonging to Jatiyatabadi Chhatra Dal (JCD) ransacked a cyber café at Sukrabad in the city's Mohammadpur area yesterday.

A gang of six youths identifying themselves as 'men of JCD leader Eileen' entered Pace Cyber Café in the evening and asked employees to call its owner. When told that he went to hospital to see a relative, the elements forced an employee to come out.

Then they gave him a mobile phone and made him talk with their leader 'Eileen.' At this time, they pulled out their revolvers apparently to terrify those around. One of the gang members then talked with their 'leader.'

"The armed gang then entered the café again, threatened customers to leave immediately to avoid any attack on them and ransacked it," an eye witness said.

## Terrorists set afire shoe factory in city

A gang of terrorists set fire to a shoe factory at Nawabganj in the city yesterday.

Police and locals said the terrorists attacked the workers of the factory at Abdul Aziz Lane at about 6 am blaming them for helping police arrest their ring leader.

The terrorists set fire to the factory after locking it from outside.

Hearing screams of the workers, local people rushed to the spot and rescued Iqbal, 29, and Imon, 20, employees of the factory, by breaking open the door.

Police and fire officials sent the two injured employees to Dhaka Medical College Hospital (DMCH).

Local people said Lalbagh police recently arrested an identified terrorist, Shafique, for his alleged involvement in various crimes.

Accomplices of Shafique suspected that police arrested him on the basis of information given by the workers of the shoe factory.

## Khaleda invited to co-chair microcredit summit in NY

## A year after batamul carnage Chhayanaut prepares for programme at the same venue

The spirit of the Bangla New Year will remain indomitable this year round despite a gory carnage at the last year's Pahela Baishakh celebration and the police's negligence to bring the terrorists to book.

Against all odds, Chhayanaut, which has been organising the Pahela Baishakh celebration in the Ramna Park for the last 45 years, will hold the annual function at the same venue this year too.

Chhayanaut has sought permission from the authorities concerned to hold the annual cultural programme. "We have sought permission from the authorities and started rehearsing for the programme," an official of Chhayanaut said.

For the first time in the 45 years history of the traditional cultural function, the Public Works Department (PWD), the custodian of the Ramna Park, has demanded Tk 3,000 in fees for the space, he said.

Chhayanaut officials recently met the inspector general of police (IGP) seeking adequate security.

"We hope the people will not avoid the function," the official told The Daily Star on condition of anonymity when asked whether this year's celebration would be in a glum mood.

Even one year after the Ramna Batamul carnage that left ten people killed and scores injured, the police made little headway in their investigation.

Police did not frame the chargesheet on the case as the pace of the investigation snapped after the government formed a judicial investigation committee later last year.

Headed by the former justice of the High Court and two joint secretaries, the committee was formed to probe into all sensational bomb incidents,

## New incentive package for loan recovery

The Bangladesh Bank (BB) yesterday announced a uniform incentive package for recovery of classified loans for four NCBs.

This uniform incentive package would be applicable to staff of branches and different offices of Agrani, Rupali, Sonali and Janata banks. Till September last year, total classified loans of the banks stood at Tk 24,116 crore, of which the NCBs have Tk 12,412 crores.

The incentive package, an NCB staff will pocket seven per cent of the loan for helping the bank recover it, which remained unrealised for seven years or more and has already been labelled as bad debt.

In case of recovery of bad debts that remained unrealised for three to seven years, the staff would get six per cent of the amount, while he or she will receive five per cent of the amount as incentive for realising other bad loans.

Besides, a bank staff would get four per cent in case of realisation of

doubtful loans. The incentive would be given on yearly basis upon closure of a loan account, the BB circular said.

This uniform incentive package would be applicable to staff of branches and different offices of Agrani, Rupali, Sonali and Janata banks. Till September last year, total classified loans of the banks stood at Tk 24,116 crore, of which the NCBs have Tk 12,412 crores.

The incentive will come into play only for loans that have been categorised as classified on December 31, 2001. Besides, a staff has to work for six months at a stretch at a branch or office to be eligible for receiving the incentive.

The previous arrangements of incentives for bank staff will also exist, the BB circular added.
