Delhi allows duty-free access to 40 items

Most of Dhaka's preferred items crossed off the list

India has finally offered duty-free access to 40 Bangladesh products at the end of a three-day trade talks yesterday

Dhaka, in return, said it will consider the Indian demand for lifting the ban on import of yarn and sugar through land ports. It will discuss the issue with the National Board of Revenue (NBR).

The much debated transit issue, which led to multiple walkouts during the mind-wrenching talks, has been passed on to the Joint Economic Commission (JEC). The JEC will meet soon on the matter, it was decided.

However, most of the 40 items that India agreed to allow free access are not produced by Bangladesh. Moreover, many of them were not on the Dhaka's list. The list of items handed over to Dhaka minutes before the signing of a joint press statement also includes products that the country produces in insufficient quantity to meet domestic demand.

The joint press statement capping the talks said, "India agreed to provide duty-free access to 40 tariff lines under 16 categories of Bangladesh products immediately. These include products in which Bangladesh has export capabili-

The Ministry of Environment will hold a meeting with Unocal next Tuesday over unresolved compensation issues related to environmental damages caused by the Magurchhara blowout in June 14, 1997, official sources said.

This would be the first meeting between the US oil company and the ministry after the change of government through the October 1 In 1998 the environment ministry

Khaleda attacks AL for 'planting' Review story

Prime Minister Khaleda Zia yesterday launched a scathing attack on the main opposition Awami League (AL), accusing it of sponsoring the Hong Kong-based Far Eastern Economic Review's cover story titled "Beware of Bangladesh" to make Bangladesh friendless.

Speaking in the Jatiya Sangsad, the prime minister alleged the AL had brought the Review reporter to the country to have the story published under a blueprint to tarnish Bangladesh's international image as a moderate Muslim country.

She said if they continued sponsoring 'information terrorism' the people would start saying, 'Beware of Awami League'. "Because, they are enemies of the country and betrayers," Khaleda told the House.

Rounding up the general discussion on the presidential address to the House, Khaleda categorically said there are no Taliban or fundamentalists in the country

We Bangladeshis are moderate," she said, lashing out at the Review that reported on the alleged Taliban training centre and rising fundamentalism in the country.

Khaleda, who heads the BNP, said the main opposition party lacks patriotism and democratic belief as it had continued acting against the interests of the country and its people

Terming the AL a detracked party, she said it has become isolated from the people since its debacle in the last general election. "Its misrule in the past five years had brought the number of party's seats in the parliament down to 58 now from 146. I prefer not to say what the number will be in the next parliament."

She further alleged that losing the polls the opposition party has been trying to destabilise peace and stability in the country by sponsoring terrorism. It also attempted to disturb communal harmony by claiming repression on the religious minorities, she added. "But SEE PAGE 11 COL 1

Suicide bombing kills 10 Europarliament for trade ban on Israel

At least 10 Israelis were killed and some 15 others injured in a bus explosion at Yagur junction, near Israel's northern city of Haifa yesterday morning, Israel Radio reported.

The explosion occurred at about 7:20 a.m. local time, when the bus was driving from Haifa to Jerusalem. Some passing vehicles were reportedly also hit by the explosion.

It was the fourth suicide bombing since Israel began its massive military offensive, "Defensive Shield," on March 29 to wipe out Palestinian militants. "There was a huge bang. I saw the man exploding near the front" of the

bus, said Gal Maron, a 20-year-old soldier being treated at a Haifa hospital for cuts on his chest. "I went flying and landed on the steps of the back door. I staggered out and managed to walk a couple of steps. I even phoned my father so that he wouldn't worry -- he knew I was on the bus.

Rami Solomon, who works in an office near the scene and arrived soon after the blast, said bodies had been blown out of the bus. "There were body parts scattered on the road with legs blown off, shoes and army boots lying around, ambulances with sirens wailing," Solomon said

The Islamic Hamas militant group claimed responsibility for the attack. "To (Israeli Prime Minister Ariel) Sharon and his ministers and generals, we

have shown that there is no 'Defensive Shield'," the site announcement said. Sources in Hamas identified the bomber as Ayman Abu Haija, 22, from
