### Danes yet to respond to Bangladesh protest

Bangladesh is still awaiting a response from Denmark to its protest note handed to the Danish ambassador in the city on Wednesday about the graft charge slapped on Shipping Minister Akbar Hossain by the Danish foreign ministry under-secretary.

Foreign Secretary Shamser M Chowdhury Wednesday summoned the Danish Ambassador Niels Severin Munk to the foreign office and handed an aide-memoire to him, reminding the Danish government that Danish Under-secretary Peter Lysholt Hansen's approach "is a clear breach of long established diplomatic traditions and practice".

This is the second time the Danish envoy was summoned to the foreign office after the graft charge was aired.

Earlier, Dhaka also asked Copenhagen to provide evidence in support of its allegation.

Hansen made the charge at a press conference on April 13, saying the minister had "serious intention of corruption" in the process of floating tender for rehabilitation of four ferries with Danish grant.

Sources said Arman and his friends, Rafig and Jamal, lived at 423, North Ibrahimpur.

Arman had left the house vesterday morning, telling his friends to stay put while he was gone for a few hours. But on his return, he found that the door of the house was locked and his friends were nowhere around.

As he didn't have the keys with him, he had to break the door open and found that some of his valuables were missing. Suspecting that Rafig and Jamal had stolen his belongings, Arman started looking for the two.

An earthquake measuring 3.38 in the Richter scale rocked the port city and its adjacent areas in the early hours of yesterday. No reports of damage or causal-

BST) and lasted 16 seconds. The epicentre of the quake was 141 kilometers off the Chittagong Port. However, the lone seismic observatory centre located in the port city could not measure its

The intensity of the tremor was minor, met office added.

# Royal homecoming

Zahir Shah's 29-year exile ends

Deposed Afghan monarch Monammed Zahir Shah returned home after 29 years in exile yester-day to a red-carpet ceremony fit for a king as his former subjects took to the streets in celebration.

A grey Italian airforce plane touched down shortly before 11:30 am (0700 GMT) at the Kabul international airport, the wreckage of planes from more than two decades of conflict much in evidence.

Interim leader Hamid Karzai, who had travelled to Rome to pick up the 87-year-old, made sure he stepped out of the plane behind Zahir Shah who was then greeted with a bouquet of flowers by waiting children.

He made his way slowly down the red carpet where he was greeted by officials, many of whom were still at school at the time of his ouster, before stepping into a wait-

### Patients at Suhrawardy Hospital referred to private facilities for tests

Some doctors at the city's Suhrawardy Hospital allegedly spin off extra money by sending their patients to nearby diagnostic centres for pathological tests.

According to sources, most doctors of the emergency wing at the 300-bed hospital have links with few private pathological laboratories in the area and send patients there for tests that are both 'unnecessary and

Although the hospital has a full-fledged pathology unit, at least 70 per cent of the treatment seekers are referred to these private facilities for common blood

In return, these doctors get 40 to 45 per cent of the profit the diagnostic centres make. Payments are made at the end of the day and a doctor earns up to Tk 1.50 lakh a month through such malpractice, sources

Despite several complaints lodged by patients, the

hospital administration is yet to take any action, they

tal, fell prey to the illegal practice. The housewife, Rahima, went to the ticket counter where patients have to register their names and other details. Out came a broker and took her to Dr Misbah-

## Biodiversity strategy to reap TRIPS benefit Seminar in city told

Experts at a dialogue vesterday underscored the need for setting up a national strategy and proper documentation of traditional knowledge regarding bio-diversity to derive benefits from the Trade-Related Aspects of Intellectual Property Rights (TRIPS).

They suggested formation of a national body on intellectual property rights and modernising the patent system of the country. Experts also stressed the need

for formation of a single authority in the country to handle intellectual property rights issues since multiple bodies create problem.

The international dialogue on Trade, Biological Resources and Intellectual Property Rights was jointly organised by the Centre for

International Centre for Trade and Sustainable Development (ICTSD). Geneva, in collaboration with Bangladesh Environmental Lawyers' Association (BELA) and the Quaker United Nations Office in Geneva (QUNO) at CIRDAP auditorium in the city. Foreign Minister M Morshed

Policy Dialogue (CPD), the

Khan, who attended the dialogue as chief quest, observed that many countries were now enacting new laws or amending the existing ones to conform to TRIPS. He, however, said the issue of intellectual property rights is undergoing constant changes, making it difficult for many developing countries to keep pace

Among the basic objectives of TRIPS is to consider the mutual benefits of the producers and users

of technological knowledge and to balance their rights and obligations. In implementing IPR regulations. members could adopt measures necessary to protect human health and nutrition, and to promote public interest in sectors of vital importance for their socio-economic and technical development, he said. He said the government is aware

of the recent problems with HIV/AIDS and Africa's needs that effectively led to the Doha Declaration on TRIPS and public

"It is vital to affirm that TRIPS provides for measures necessary to rotect public health," Khan said.
