Notice for Admission to BEd Course

Academic Year: 2002-2003

- Applications are invited from only Bangladeshi citizens interested for admission to BEd Course during 2002-2003 academic year at the undermentioned Teachers' Training Colleges:
A) Teachers' Training College, Dhaka; B) Teachers' Training College, Mymensingh; C) Teachers' Training College (Women's), Mymensingh (only for women); D) Teachers' Training College, Comilla; E) Teachers' Training College, Khulna; F) Teachers' Training College, Rajshahi; G) Teachers' Training College, Jessore; H) Teachers' Training College, Rangpur; I) Teachers' Training College, Feni; J) Teachers' Training College, Chittagong; K) Shahid Abdur Rab Serinabat Teachers' Training College, Barisal.
- Eligibility of applicant:**
Working teachers at private educational institution can apply in teachers' category and those not is teaching profession can apply in non-teachers' category.
(A) Teachers' category: Those presently engaged in teaching profession need training with a view to enhancing professional skill. For this the undermentioned category teachers will be generously considered for providing admission opportunity.
(1) Working MPO teachers at any private educational institution.
(2) Working teachers at such educational institutions established/run by govt/semi-govt organisations as do not receive MPO fund.
(3) Teachers appointed under govt. project.
(B) Non-teachers' category: With a view to preparing persons interested to be engaged in teaching profession in future as efficient teachers through training, the non-teacher persons are imparted training. Any Bangladeshi citizen with prescribed qualification can apply for admission.
(C) 70% of the total seats of any college will be prescribed for teachers' category and 30% for non-teachers' category applicants. But to prevent deprivation of teachers' category applicants, the non-teachers' category quota may be reduced to admit teachers' category applicants to the seats. On the other hand, if the 70% seats are not filled in by the teachers' category applicants, then non-teacher candidates will be admitted to that vacant seats.
- Educational qualification of applicant:**
(A) In case of teachers' category: Should possess minimum graduation degree in branch of humanities, science, commerce, agriculture or home economics from any recognised university and minimum second division/class in any one of SSC on ward examination. This condition is relaxable in case of teachers who have completed 10 years service.
(B) In case of non-teachers' category: Should possess minimum graduation degree in any branch of humanities, science, commerce, agriculture or home economics and minimum second division/class in all examinations SSC onward.
(C) All educational qualification certificates.
- Age:** Maximum 40 (forty) years. But in case of teachers, the undersigned may relax the age limit of candidate in view of recommendation by principal of respective TT College. Age limit of any candidate in non-teachers' category is not relaxable.
- Rules of application:**
(A) Application should be as per the attached proforma.
(B) Candidate can send/submit application by post or personally to the Principal of Teachers' Training College in tending to be admitted to. But application must reach the principal of the college concerned by 4th May 2002.
(C) The undermentioned paper must accompany the application:
(1) Two copies passport size photo (attested by Gazetted Officer/Headmaster/Headmistress of Secondary School) and a self-addressed envelope with requisite postage stamp.
(2) In case of teachers, copy of decision by respective School/Madrassah managing committee to the effect that the incumbent will be granted leave during training period (i.e. 01-07-2002 to 30-04-2003), attested photocopy of his/her MPO & experience certificate.
(3) All educational qualification certificates.
- Candidate selection system:**
(A) Teachers' category: Candidates whose applications may be found correct after scrutiny will be considered/invited for admission. They need not participate in any selection test. Their admission process will be completed by 8 & 9 June 2002. Original copy of all certificates should be produced/deposited at the time of admission.
(B) Non-teachers' category: Candidates whose applications may be found correct after provisional scrutiny shall have to take part in written test of 100 marks on 12 June, 2002. Admission will be made on the basis of this test result and the scores secured in examinations SSC onward (first division-3, second division-2).
In the above process, if the qualification of two candidates happens to be the same, the postgraduate degree holder candidate will get preference. At this stage, if more than one candidate happens to be of equal qualification, preference will be given to senior candidate.
(C) Within 03 (three) days of holding examination a list of candidates selected for admission as per rules stated in sub-para (B) above as well as a waiting list of candidates will be published. Admission process of selected candidates will be completed by 22 June, 2002. To the vacant seats of those failing to get admitted by this date, candidates from waiting list will be admitted as per merit. Original certificates of examinations passed should be submitted and dues for the whole session of college paid at the time of admission. Headwise statement of total dues for the whole session to be paid at the time of admission will be written in invitation/interview card.
(D) Only the candidates invited for examination should deposit examination fee of Tk 50/- (fifty) only per head to the respective principal. BEd programme will start from 1st July, 2002 and will continue up to 30th April of 2003. But in the wake of reasonable circumstance this timetable may be changed.
- A number of stipends will be offered to private teacher & non-teacher trainees studying in BEd course on the basis of merit.
- If necessary, the principal of the respective Teachers' Training College may be contacted for detailed description.
