
A university is meant to impart education. When it plunges into moneymaking schemes, the result is a mess as in the case of the Dhaka University (DU).

### Govt to snap water, power connections, if found guilty

Industrial units polluting the environment will soon find their power and water connections snapped.

Besides, the government will also crack down on other polluters to check environmental pollution in the country

Encouraged by the recent success in banning use of polythene, Environment and Forest Minister Shajahan Siraj yesterday announced a series of programmes to check environmental pollution.

"Within next one or two months we will start issuing notices to all industrial units found guilty of polluting the environment. If they fail to take corrective measures, their power and water supply connections will be snapped", he said.

All 15 passport offices in the country have run out of passport books causing immense public suffering. According to sources, the headquarters in Agargaon in the city and

its 14 regional offices (RPO) have run out of stocks since early March. People who need international passport urgently have been kept waiting till fresh consignment

arrives which, according to the passport office, is not expected before late July. The yearly requirement of pass-

ports in the country is about 10 lakh. Two foreign printers were learnt to have so far printed and supplied the passport books, but the government recently cancelled the contract with them and signed a fresh agreement with another foreign contractor for a fresh supply.

"This has created serious problem. Neither the supplier's delivery is being shipped nor the government is able to take delivery of books from another party due to legal bindings," said one source in

### **US** plans big invasion next year to topple Saddam

The Bush administration's military strategy for toppling Irani President Saddam Hussein includes a major air campaign and ground invasion early next year, using between 70,000 and 250,000 troops, the New York Times reported vesterday.

The administration is focusing on military action against Irag, the Times reported, after determining that a coup would be unlikely to succeed, and a proxy battle there using local forces insufficient to bring a change in

"There have been at least six coup attempts in the 1990s, and they consistently fail," an administration official told the newspaper

In each instance, this official said, dissident Iraqi military officers "sent signals to us, 'We're ready for a coup,' and the next thing you know these guys are murdered or it fails or people have cold feet at the end and leave the country.

"It's a horrific police state." the official added. "Nobody trusts anyone, so how can you pull off a coup?" However, senior US officials told the daily that any offensive would probably be delayed until early next year, allowing time to create the right military, economic and diplomatic conditions.

These include avoiding summer combat in bulky chemical suits, preparing for a global oil price shock and waiting until there is progress toward ending the Israeli-Palestinian conflict, the Times reports.

The Times reported that planning for the campaign included possible extensive use of bases for American forces in Turkey and Kuwait, with Qatar as the replacement for the sophisticated air operations centre in Saudi Arabia, and with Oman and Bahrain playing important

The military is planning a more traditional campaign than the one waged in Afghanistan, according to the newspaper, with an approach resembling the Persian Gulf war in style, and which would be fought with even more modern weapons and more dynamic tactics.

"The president has not made any decisions." a senior Defence Department official told the daily. "But any efforts against Irag will not look like what we did in

## PDB sets condition to take uncertified equipment

The Power Development Board (PDB) is likely to conditionally agree to accept 1400 tonnes of non-guaranteed and uncertified power plant equipment from a Russian company, the TPE, under pressure from the energy ministry.

These equipment have been lying at the Mongla port for over a

The PDB has proposed some amendments to the suppliers' credit contract with the TPE (Technopromexport) for the rehabilitation of the 30-year-old Ghorashal 1 and 2 power plants. The power division of the energy ministry will meet later this week to decide on the amendments.

The TPE brought the equipment in an unsolicited manner to Bangladesh early last year. But the PDB refused to accept them as the contract with the Russian company was not made effective and also because the TPE did not seek the PDB's prior permission for import.
