White Paper II today

Frigate purchase, novo-theatre, Swadhinata Stambha, appointments on the list

The second part of a white paper on alleged corruption, irregularities and abuse of office during the five-year rule of the Awami League comes out

Political Secretary to the Prime Minister Haris Chowdhury will formally release the white paper at a press briefing at the Prime Minister's Office (PMO) in the afternoon, official sources said.

A special cell at the PMO headed by retired bureaucrat Mohammad Moniruzzaman has prepared the

The BNP-led coalition government published the first part of the white paper in two volumes on January 23, bringing some 40 allegations of graft, financial irregularities and abuse of power against former Prime Minister Sheikh Hasina and many of her cabinet colleagues in previous Awami

According to the officials, the latest white paper includes some 20 allegations of corruption, irregularities and abuse of power

Former premier Sheikh Hasina, former finance minister Shah AMS Kibria, ex-labour minister MA Mannan, former law minister Abdul Matin Kashru, ex-environment and forest minister Syeda Sajeda Chowdhury, ex-food minister Amir Hossain Amu and former LGRD minister Zillur Rahman along with a number of retired and serving civil and defence officials, businessmen have been charged with such allegations in the white paper.

Charges have been slapped on them in the purchase of the navv frigate, irregularities in the appointment of government employees through the Public Service Commission (PSC), irregularities in the Bangladesh Red Crescent Society, the Bureau of Manpower,

Employment and Training (BMET); and finance, law and food ministries; corruption and irregularities in the allotment of industrial and commercial plots, and construction of Bangabandhu Novo Theatre and Swadhinata Stambha.

The "irregularities" in the purchase of Tk 550 crore much-talked about South Korean company Daewoo-built navy frigate feature prominently in the white paper. Economy won't be run on 'fancied' donor prescription, says Saifur

Finance and Planning Minister Saifur Rahman yesterday asserted that the economy would be run on the basis of its necessity not on the "fancied" guidelines of donor agencies like ESCAP, World Bank and

"They (donors) publish reports with their imaginary views," he told a press conference after a meeting of the National Economic Council (NEC) that approved an ADP (Annual Development Programme) cut of Tk 3.000 crore for the current fiscal vear.

Chaired by Prime Minister Khaleda Zia, the meeting approved the revised development budget for the fiscal 2001-2002, bringing down the development expenditure to Tk 16,000 crore from the original outlay of Tk 19,000 crore.

Besides, three officers of the rank of brigadier general have been promoted to the rank of major general raising the number of major generals in the active list to 26.

Maior General Ekramul Haq who has been serving as the divisional commander (Jessore) is becoming the new Chief of General Staff (CGS), replacing Major General Najmul Ahsan Amin whose services has been transferred to the Ministry of Foreign Affairs, the sources said.

The newly appointed CGS is an infantry corps officer and served as defence advisor at the Bangladesh mission in New Delhi before taking command of the Jessore Division.

Brig General ANM Moniruzzaman, an artillerv officer and commander of the Artillery Centre, Chittagong is being made the new GOC of Jessore Division as major general.



Siege on Arafat ends Shooting rocks Church of Nativity again

Yasser Arafat stepped out into freedom yesterday, blasting the Israelis, vowing to rebuild his shattered Palestinian Authority and demanding an end to violence around Bethlehem's Church of the

He emerged from a 34-day Israeli siege facing some tough choices, with the militant Palestinian group Hamas vowing to launch new anti-Israeli attacks and Israel again threatening to keep him in exile if he travels abroad

About 100 cheering supporters greeted Arafat as the Palestinian chief, squinting into the sunlight, left his offices after the Israeli blockade was lifted Wednesday night under a US-brokered deal.

Looking haggard but smiling, the keffiyeh-clad Arafat flashed the "V" sign and made his way through the adoring throng to an armoured car for a 3-1/2 hour tour of devastation

wrought by the Israelis in Ramallah. "It is racism, it is fascism," he told reporters as he visited the local chamber of commerce, a cemetery,
