Third part of white paper on 20 more cases

Tk 2711 cr public funds misused during AL rule

The BNP-led coalition government has released the third part of a white paper on alleged grafts and malpractices that caused the public exchequer a loss of Tk 2710.54 crore during the five-year rule of Awami League.

It listed 20 cases of alleged graft, irregularity and abuse of power by the immediate past AL government.

Political Secretary to the Prime Minister Haris Chowdhury released the white paper at a press briefing at the Prime Minister's Office (PMO) yesterday afternoon.

"This white paper is only a sample of the large-scale graft committed by them (AL men). It is not possible to project all those in such a limited purview," Haris said.

Special funds for five top army officers

Chief of Army Staff Lt Gen Harunor-Rashid, former army chief Lt Gen Mustafizur Rahman and three other top army officers were given Tk 80 lakh as special allocations from the Upazila Parishad Development Assistance Fund during the immediate past rule of Awami League.

The then Speaker, 18 cabinet ministers and advisors, 20 state ministers and whips, 72 ruling party lawmakers and 31 others also got special allocations from the fund, according to the third part of the 'white paper' released by the government yesterday.

White paper mum on men behind frigate purchase

Purchase of a naval frigate was designed to benefit DAEWOO Corporation, supplier of the warship, the third part of the 'white paper' said.

The white paper mentioned three vital irregularities in the defence purchase. These are: flaws in the process of purchase contract, negligence in supervision during construction of the warship and hasty sailing for handing it over to the Bangladesh government.

The first chapter of yesterday's white paper containing the irregularities however did not specify names of the people responsible for this purchase. But it is widely known that Abdul Awal Mintoo, a leading businessman who joined BNP last year, was involved in the purchase.

The work, which began more than two years ago and was scheduled for completion by June this year, has remained suspended since August 25 last year and there is little possibility that it would begin

anytime soon. According to sources, in November 1999, a local company roped in an Indonesian company, formed a joint venture and won the contract with blessings from some shipping ministry high-ups. The company quoted Tk 44.09 crore for

venture company, were raised when the agreement was signed in February 2000 and they were proved right soon.

A few months into the work, the Indonesian company lost interest in the job and withdrew its experts and equipment, leaving its local counterpart high and dry.

The Basic Engineering Construction, the local company in the joint venture, is yet to either procure or arrange for a trailing suction hopper dredger to resume dredging in the channel.

Some BNP men out to 'suppress' Jamal murder case

A section of ruling party men are out to 'suppress' the case regarding the murder of brilliant college student Jamaluddin Fakir allegedly while in custody of Kapasia police on April 19.

Local people alleged that BNP leader Obaidullah and some other local leaders and activists of the party and its student front Jatiyatabadi Chhatra Dal (JCD) have resorted to various tactics including 'false propaganda' to suppress the murder case. "They have already damaged evidences of the murder and are openly

intimidating eyewitnesses to the incident," said an elderly man at Kapasia Bazar on Thursday. Obaidullah, who joined BNP from Jatiya Party before the October 1

parliamentary election, has set up an 'office' in front of Kapasia police station and is 'controlling' activities at the thana and in Kapasia upazila, locals alleged

Backed by an influential BNP leader from the area who failed to win the last two general elections, Obaidullah is running an 'unofficial administration' in the area since the present government took over. He is getting active support from Kazi Aftab, who also joined BNP from JP and is now president of Kapasia unit of JCD, and other JCD leaders including Halim, Mesbah and Ripon. Aftab sits at Obaidullah's 'office' everyday and 'handles' affairs at the

Mongla Port workers on strike
