Use 'SPA detention clause cautiously'

Law Commission suggests the government follow the Supreme Court verdicts and directives

The Law Commission in a report to the Ministry of Law has observed that framing of a new law retaining the repressive detention clause of the Special Powers Act (SPA) would not improve the country's human rights

The report also observed that it was meaningless to promulgate such a law keeping in place the controversial clause. Rather, the commission suggested, the government better follow the verdicts and directives of the Supreme Court on the cautious use of the SPA and putting a stop to its misuse in case of detention, according to sources.

The report says while approving a detention order the Ministry of Home

must be satisfied beyond any doubt with the rationale and evidence justifyng a detention order issued by the district magistrate. The detained person must immediately be informed about the reason for the detention.

The commission also suggested that the government should promptly respond to the High Court Division's rule on the writ on a detention order.

The Law Commission submitted its report on the SPA to the law ministry on May 15 with regard to the proposed scrapping of the SPA and introduction of a similar law retaining the repressive detention clause. The government also suggested incorporating other SPA clauses into the Bangladesh Penal

These proposals were sent to the commission on January 1.

On flags, bandanas and baseball caps, East Timorese wore their national colours wherever they could fit them yesterday as they celebrated their nation's independ-

Tens of thousands gathered at a field close to the national capital Dili to witness their homeland becoming the world's newest nation on the stroke of midnight last night.

VIPs from around the world -among them UN Secretary General Kofi Annan, former US President Bill Clinton, Portuguese President Jorge Sampaio and Australian Prime Minister John Howard -watched the show from a covered stand made from bamboo.

The locals -- parents with young children playing at their feet, students and old men and women in village dress -- sat cross-legged on

40 IU students hurt in clash with transport workers

At least 40 students were injured in a series of clashes between the students of Islamic University (IU) and local transport workers on Saturday night.

The clash erupted when a bus driver of ASB Transport was beaten up by the students in front of the main gate of the university on the Kushtia-Khulna Highway.

As the news spread, transport workers assaulted 10 students, including a girl, who were returning to the campus.

Immediately after the incident the agitated students damaged at least 13 buses and trucks near the

university main gate The transport workers then stopped plying vehicles and started beating up campus-bound teachers

and students on the highway. Clashes between angry students and transport workers soon spread to Kushtia and Jhenidah bus sta-

tions, where 30 students were injured. The injured students were admitted to different clinics in both towns. Abdul Alim, a second year law stu

Apparel exporters go for hunger strike June 3

The apparel exporters will observe a token hunger strike on June 3 and will form a human chain on June 5 to protest the government's coldshouldering their demand for export

They will also hold five rallies in the readymade garment (RMG) industrial belts in Dhaka, Chittagong and Narayanganj from May 26 to June 2 to press home their six-point

The apparel exporters' demand includes 15 per cent cash incentive for woven, knit and terry towel items. They said the incentive could be eliminated in three years with five per cent reduction every year.

They also sought assurance for supply of quality yarn at international prices from local sources,

otherwise the ban on yarn import through land ports be lifted. Also they demanded disbursement of all pending cash incentives by May 30.

The exporters said the SAARC regional cumulation benefit offered by the European Union should be immediately implemented and the permission to set up a central bonded warehouse in the private

sector be granted. "Amidst export slump, we have been pursuing the government for policy support. But we have not received any till today and the RMG exporters are getting frustrated," Kutubuddin Ahmed, president of the Bangladesh Garment Manufacturers and Exporters Association (BGMEA), said while declaring the protest programme at a press conference at the BGMEA

office yesterday.

However, he was still optimistic about a positive decision from the policymakers to save the industry from difficulties arising out of tough competition and slump in price and

Kutubuddibn also said they have sought appointments with Finance and Planning Minister M Saifur Rahman to discuss the demands. The BGMEA chief dished out

some dismal figures of RMG exports to the US market. During the January-March period, the total RMG import by the

US declined by nearly six per cent in volume and 11.36 per cent in value. Kutubuddin said the country's apparel exports to the US dropped by 9.33 per cent and 14 per cent in

terms of volume and value respec-

Doubly disabled



Look of desperation... a disabled orphan, blind and paralysed from polio, begs on the city streets. Neither the government nor any non-governmental organisation has come forward for rehabilitation of such children.

Fifteen-year old Majid is blind and orphan. Twelve-year old Raushan is paralysed from polio. Both beg on the streets of Dhaka.

There are over five lakh disabled and marginalised children like them in the country but neither the government nor any NGO has any programme for them, according to a study by the Centre for Services and Information on Disability (CSID), a local NGO.

Bangladesh, as a signatory to the Declaration of the Asian and Pacific Decade of Disabled Persons, 1993-2002, is committed to undertake programmes for such disabled people

The Social Welfare Directorate has a limited programme for street children but not for those with

The meagre resources coming from donors and UN agencies for the disabled are mostly directed for the benefit of adult and educated disabled people who have a better chance of survival

The United Nations Children's Fund (Unicef) also has no programme for the disabled children on streets "The street children with dis-

ability are in many ways invisible in the society. They are mostly considered incompetent because of physical defect. The negative attitudes they are exposed to is a greater problem for them than the disability itself," Herluf G Madsen, Resident Representative of Save the Children Sweden told The

Teachers' strike closes school for the disabled

A school for the intellectually disabled has been closed indefinitely because of the teachers' strike.

Striking teachers of the school run by the Society for Welfare of Intellectually Disabled (SWID) in the city's Eskaton area have been abstaining from classes since May 14 demanding withdrawal of termination letters served on a teacher and two support staff.

The authorities declared closure of the school on Saturday. In protest at the indefinite closure of the school, the teachers staged a sit-in yesterday

The looming uncertainty has landed parents of the 235 intellectually disabled students at the SWID School (Ramna branch) in deep frustration The social welfare ministry

provides 60 per cent of the salaries for the teachers in 40 SWID-run schools home to 6,000 intellectually disabled children. The Ramna branch is the oldest among all. The SWID, a voluntary organisation, was founded in 1977 President of SWID Dr Lutfar

Rahman told The Daily Star yesterday that the Ramna branch authorities were forced to close the school indefinitely, as the teachers pushed

ahead with their move for withdrawal of termination letters and for abstention from classes President of the Ramna branch

governing body Sajeda H Kabir alleged that the striking teachers tried to halt a scheduled training programme for some teachers of other SWID-run schools yesterday. "We decided on Saturday to

keep the school closed until further notice. We (school committee) will meet the parents and decide on the next course of action," said Sajeda. Last Thursday, Sajeda told The

Daily Star, "As teachers protested terminations of one teacher and two support staff, we assured them of reconsideration of the cases of the support staff but not the teacher in question because there was a charge of misconduct against him." President of the Association of

Teachers and Employees of Schools for the Disabled Kazi Bilkis Begum claimed that three colleagues were terminated on April 30, 2002 for reasons best known to the authorities. Following the authorities' refusal

to have talks with the teachers on the termination issue, the teachers went for a 'peaceful' work abstention
