- The tenderer must quote their rate of item including the cost of all laboratory tests, cost of mobilization, materials, equipment's construction of temporary shed at site, demobilization and clearing the work site etc. No separate items will be entertained for such nature of work.
- No separate rate should be quoted for shoring, de-watering ring bund and artificial island but cost of the same should be include the item of earth work.
- No additional work will be allowed.
- If the contractor fails to start the work within 10 (ten) days of issuance of work order, action will be taken for cancellation of work order.
- Any case of sub-letting and syndicating by any contractor/firm will cause their pre-qualification to be cancelled.
