Defence to go to higher court, seek transfer of case

COURT CORRESPONDENT

The Third Additional Metropolitan Sessions Judge's Court, Dhaka yesterday adjourned the hearing of the Shipu Murder Case.

Judge Molla Mostafa Kamal adjourned the hearing till May 30 following a time petition by the defence lawyers.

Moving the petition Advocate Syed Shamim Ahsan Habib stated that Additional Metropolitan PP Golam Mostafa Khan obstructed him (Shamim) to cross-examine the 4th prosecution witness Rezaul Karim in a legal process. Moreover, the learned judge himself directed him (Shamim) to be careful to ask questions to the witness. He felt apprehension to get justice from the court. As a result, he (lawyer) was not desirable to conduct the case in such court and he would go to the higher court to seek transfer of the

Pro-BNP teachers have expressed their regret over the split and blamed the pro-Jamaat teachers for not supporting their candi-

They said the Jamaat-leaning teachers have already established their supremacy in all the councils of the university with the support of pro-BNP teachers. But despite that the pro-Jamaat

teachers have put up their own candidate in the dean election against the white panel.

This has angered the pro-BNP reachers of CU and they are now very much annoyed with Jamaatleaning teachers for their 'betrayal', the sources added.




