Oklahoma bridge collapses as barge hits it: 24 killed

US investigators in eastern Oklahoma were seeking answers yesterday to why a 180-meter section of a busy highway bridge crumbled when struck by a barge, claiming as many as two dozen

The National Transportation Safety Board (NTSB) said it has dispatched a 14-member team of highway and marine investigators to

"We will be looking into every aspect of the accident," NTSB spokesman George Black said, after arriving in Oklahoma late

The barge knocked a huge wedge out of the interstate highway span in eastern Oklahoma, sending 10 or so vehicles plunging into the Arkansas river.

Several people were rescued and taken to hospital, but perhaps a dozen others perished in the accident, authorities said. The vehicles are submerged in about 3.5 meters

Efforts to recover bodies and vehicles was to resume at daybreak SEE PAGE 11 COL 4

Pakistan won't start war but ready for it: Musharraf

Pakistan President Pervez Musharraf said yesterday his nuclear-armed nation would not start a war with India, but was ready to respond with full force if attacked. In a toughly worded speech broadcast live on television, he insisted there was no infiltration taking place across the line of control that divides Pakistan- and Indian-ruled Kashmir.

India accuses Pakistan of arming and training Islamic militants in Kashmir, and attacks across the border have brought the neighbors to the brink of war.

"We do not want war. But if war is thrust upon us, we would respond with full might, and give a befitting reply." Musharraf said as interna-

tional pressure mounted on both sides to avert conflict. "Pakistan will not be the one to initiate war." "We are faced with a grave

situation and we are standing at the crossroads of history." Musharraf said after a weekend when Pakistan tested two ballistic missiles thought capable of delivering nuclear warheads.

"The danger of war is not yet

The two sides have massed about a million men along their border since a December attack on India's parliament that New Delhi blamed on Pakistan-based Kashmiri militants.

Tension soared again after an attack by suspected Islamic militants on an Indian army camp in

Kashmir on May 14, prompting Indian Prime Minister Atal Behari Vaipayee to tell his front-line troops to prepare for a "decisive fight."

Musharraf repeated his condemnation of both incidents, which he described as "terrorist attacks" also aimed at destabilizing Pakistan. His speech was preceded by a

recitation from the Koran that called upon Muslims to prepare themselves for war but to embrace peace if the enemy is also ready for peace -- a sentiment which was echoed in the president's address.

The speech balanced angry rhetoric about "atrocities" being committed by "Hindu extremists and terrorists" against Muslims in SEE PAGE 11 COL 3

Govt has lost

Opposition leader Sheikh Hasina yesterday said the alliance government lost the moral right to hang on to power due to its "inability" to half political persecution, rape, murder and other criminal acts in its seven-

month rule. "When a government is compelled to admit in parliament that 10 people were murdered daily over the last seven months for political and other reasons, when a government fails to nab declared top terrors, obviously that government loses its moral right to be in power, she said in support of her viewpoint.

Although Hasina did not straightaway seek resignation of Prime Minister Khaleda Zia's government, she issued a long statement depicting how her party men were allegedly killed and harassed across the country and how people became helpless under this government's

She alleged that criminals belonging to the coalition government were killing leaders and workers of Awami League and its front organisations, religious minorities as well as carrying out political repression, loot, rape and murder.

Next budget will be reviewed mid-term

Saifur promises expenditure review commission

The government will go for a mid-term review of the budget in the next fiscal and will also constitute an expenditure review commission

"I will take up the issue with the prime minister after she returns from the USA. I want a special session of the parliament for mid-term review and will also set up a public expenditure review commission." Finance and Planning Minister M Saifur Rahman said vesterday.

Earlier, the immediate past finance minister, SAMS Kibria, in his last budget speech in June 2001 said the government would set up such a commission, which was however not formed.

Saifur was speaking as chief guest at a workshop on 'budget and budget reporting' jointly organised by the Economic Reporters' Forum (ERF) and Parliament Journalists Association (PJA) sponsored by Citibank NA

Former finance advisor of the caretaker government Professor Wahiduddin Mahmud, former secretary Dr Moshiur Rahman, journalist Ataus Samad, Editor of The Financial Express Moazzem Hossain, former additional secretary to the Parliament secretariat Khondokar Abdul Haque, CEO of the Citibank NA David E Rees, ERF President Shamsul Huq Zahid and PJA President Shafiqur Rahman spoke on the occasion.

Saifur said through the mid-term review of the budget the lawmakers will get the chance to discuss the prog-The minister also said he would form another bank

Earlier, the Awami League government also formed a bank reform committee headed by Dr Wahiduddin Mahmud. The committee submitted its report to the

reform committee to overhaul the ailing banking system.

Talking on the next budget, Saifur indicated that revenue expenditure would be higher like in the previ-

"We haven't taken any noticeable reform measures to bridle revenue expenditure for the next fiscal," he

The minister said the next budget will focus on the rural economy, agro-based industries, infrastructure building and job creation. Talking on the annual development programme

(ADP), Dr Mahmud said there should not be too many projects in the development programme. He stressed the need for a way of knowing how much benefit the nation gets from each penny spent on the ADP.

He termed pervasive corruption the major problem in project implementation.

He observed that the country's interest payment obligation is still low. "I do not think Bangladesh has reached as bad a situation as Argentina has," he said.

Dr Mahmud also said India spends about 40 per cent of its revenue expenditure for servicing domestic interest payment while Bangladesh's overall interest payment (domestic and foreign borrowing) obligation is about 21 per cent of revenue expenditure.
