

AL leader Reazuddin Ahmed dead

Mohammad Reazuddin Ahmed, a close associate of Bangabandhu Sheikh Mujibur Rahman and Vice President of the City Awami League, died of cardiac arrest at Suhrawardy hospital at 9:30 am yesterday at the age of 65.

He was admitted to the hospital after he complained of chest pain at 4 in the morning.

Late Reazuddin Ahmed left behind his wife, four sons and a host of relatives and admirers to mourn his death.

His body will be taken after Asr prayers to Bangabandhu Museum where the first namaj-e-janaza will be held. He will be buried at the Azampur graveyard after a second namaj-e-janaza at Azad Office playground in Bakshibazar after Magreb prayers.

A born Awami Leaguer, Reazuddin Ahmed led the party at different times, particularly after the assassination of Bangabandhu Sheikh Mujibur Rahman in 1975 and during the Liberation War.

Meanwhile, Leader of the Opposition in Parliament Sheikh Hasina expressed deep shock at the death of Reazuddin Ahmed.

In a message of condolence she said the nation lost a patriotic leader and social worker at the death of Reazuddin, a close associate of Bangabandhu Sheikh Mujibur Rahman.

She prayed for salvation of the departed soul and conveyed sympathy to the members of the bereaved family.

Hasina also visited the house of late Reazuddin and paid last respect to him. She spent some time with the members of bereaved family and consoled them.

TI SA Regional Meet begins today

A three-day long South Asian Regional Meeting, 2002 organised by the Transparency International, Bangladesh (TI B) begins in the city today.

Different issues on the current political instability in the region will be discussed in the meeting.

Donors and delegates from the TI Secretariat along with repre-

sentatives from four regional chapters of India, Nepal, Pakistan and Sri Lanka will attend the meeting.

At the meeting, the TI India will give a presentation on the projects titled 'Tackling Micro-Level Corruption in Government Departments in Delhi' and 'Survey on Citizen Charters in India'. The TI Nepal will present projects on 'Local Governance'.

The status report and preliminary results of the national surveys and the regional corruption survey will be presented on the second day. Later, a brainstorming session on its action plan will be held.

The issue of future cooperation in the region will come up at the meeting on the third day. And a talk on the theme of 'Anti-corruption action plan for Asia' will also be held.

Graft case against Nasim, 3 others Hearing on acceptance of charge sheet Aug 28

The Metropolitan Sessions Judge's Court, Dhaka yesterday fixed August 28 for hearing on acceptance of the charge sheet in connection with a graft case against former home minister Mohammad Nasim and three others.

Judge Ahmed Jamil Mostafa passed the order after the case file was placed before the court for its acceptance.

In the case filed with Ramna thana it has been alleged that Nasim ignored the opinion of the tender committee and gave the work for supply of 10 lakh passport books to a bidder that caused the public exchequer a loss of Tk 81 lakh.

Mohammad Jalal Uddin Ahmed, Inspector of the Bureau of Anti-Corruption (BAC) filed the case on December 11 last year, accusing six persons, including Nasim.
