PM calls for rooting out unfair means during exams

Prime Minister Khaleda Zia yester day urged teachers, guardians and all others concerned to take a resolute stand to eradicate unfair means from all public examinations for rearing students as competent

She stressed the importance of improving standard of education in classrooms to help check the tendency to copy at exams and to encourage tenderhearted students to cherish self-respect.

"Adopting unfair means in examinations is not desirable; students do not intend to suffer from this disgrace." she said talking with the chairmen of country's nine education boards after this year's SSC exam results were published.

The chairmen called on the prime minister at her office in the afternoon and presented to her the statistics of the Secondary School Certificate (SSC) Examination 2002 and Dakhil Examination 2002 of their respective boards.

During the presentation of the exam statistics, the Education Minister informed the PM that various measures taken by the Ministry and all other concerned organizations before this year's examinations helped significantly reduce the propensity for adopting unfair

Funds being set aside to contest public property cases

The Ministry of Housing and Public Works is creating a separate fund to engage 'specialised lawyers' to defend cases involving public properties which may run into hundreds of crores of taka, sources in the ministry

The move to have a separate fund for engaging high-priced lawyers was reached as the ministry kept losing legal battles, while defending public interest in the court of justice.

The ministry has already sough permission from the Ministry of Finance to create the fund.

Sources in the housing and public works ministry said, over the years, it has engaged petty lawyers, who have 'deliberately misrepresented' the cases in connivance with a 'vicious circle' eager to grab public properties

An official source said, since 1985 the government has hardly won a case in the courts. This has lead to a loss of public properties of an astronomical value

'Whenever we tried to defend a case, important documents would go missing or the lawyers would deliberately withhold vital evidence which could lead to our victory,' said the

Canadian, British envoys meet Hasina

Govt, opposition urged to exercise restraint

Two leading western diplomats have strongly pleaded that the government and the opposition parties exercise restraint for the sake of social security and economic development

They hoped that the two sides, again at loggerheads, would find a common ground to improve law and order. ensure security and make parliament effective for economic interest and improving the image of Bangladesh.

Canadian High Commissioner David Preston and British High Commissioner Dr David Carter made the remarks after a long meeting with Leader of the Opposition in Parliament Sheikh Hasina at her Dhanmondi residence yesterday.

Nearly two hours of parley from 10:00am focussed on issues like the opposition's joining the parliament and making it fully functional, repression on Awami League, law and order and human rights situation in the country, party sources said.

"We discussed a range of issues, we heard concerns from the leader of the opposition...we certainly welcome the return of Awami League to parliament and we encouraged them to pursue in parliament the issues that concern them," David Preston told UNB.

Asked if they discussed any issue precisely, the envoy said law and order and the opposition's interest in getting fair opportunity to speak in parliament came up

British High Commissioner Dr David Carter said they encouraged both sides to exercise restraint and find a common ground in national interest on economic sues, law and order and security

Both the diplomats, belonging to the so-called Tuesday Group formed before October 1 election representing USA, Canada, Britain and European Union, remarked that all parties should play their part in making the parliament fully functional, which is important for Bangladesh's image abroad and encouraging its development partners.

They observed that parliament could be made a meaningful forum with honest efforts and mutual cooperation of all political parties and people, and thus the aw and order situation could be tackled.

"Everybody and all sides look for an improvement in law and order and it is possible, in my view, if everybody cooperates and all Bangladeshis pull together to improve the situation and promote democracy in the

Asked if they had any discussion on political developnents following resignation of Prof. AQM Badruddoza Chowdhury from the presidency last month, David Preston declined to make any comment, saying it is an

The High Commission of India yesterday said it has received Bangladesh's list of 25-category products for duty-free access to the Indian market from an official of the commerce ministry in August 1999.

The high commission issued a press release just a day after the country's Commerce Secretary Suhel Ahmed at a press briefing said he could not trace any document regarding Bangladesh's list of 25catogory products. But, he said he heard that a businessman had prepared the list.

However, the Indian High Commission said, "We would like to clarify that the above mentioned list of 25 categories of items was received by this High Commission along with a forwarding letter dated August 18, 1999 signed by Mr. MN Nabi, the then joint secretary, Ministry of Commerce, Government of the People's Republic of Bangladesh.'

"The clarification is being issued to put the record straight and to remove any misgivings in a matter concerning India-Bangladesh trade relations," the release added

Heavy rain in July, flooding forecast

Heavy rains are expected during July, which may trigger flooding in the Ganges-Padma, Brahmaputra-Jamuna and Meghna river basins, said the meteorology department in a long range forecast.

It said in its forecast that there will be a 10 to 20 per cent above average rainfall during the current month and three to four times higher spells of rains that may lead to the flooding. This level of flooding is normal, however

The national average fall in July, the peak month during the monsoon, is 480 mm. The higher than average rainfall had been continuing since March, which was 24.5 per cent above average, department sources said.

The trend towards the flooding was noticed last month when higher rainfall had occurred in the Northeastern Indian states of Assam, Meghalaya and Bihar. The rush of water from the hilly areas caused flash floods in northeastern Bangladesh.

After a review of the recent weather pattern, the forecast noted that in June there had been more rains than normal in the country barring Chittagong and Sylhet divisions. The reason behind more SEE PAGE 11 COL 8
