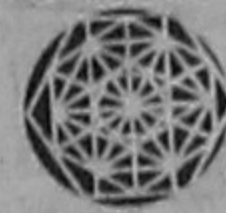

This request for expressions of interest follows the general procurement notice for this project that appeared in Development Business No. 580 of April 16, 2002.

The People's Republic of Bangladesh has applied for a credit from the International Development Association (IDA) toward the cost of the Rural Electrification and Renewable Energy Development Project and intends to apply part of the proceeds of this credit to payments under the contract to carry out socio-economic monitoring and impact evaluation services for the rural electrification and renewable energy program in Bangladesh.

The services include providing technical guidance to Socio-Economic Evaluation and Monitoring Cell (SEEMC), REB in developing a comprehensive monitoring and impact evaluation framework and methodology for evaluating socio-economic and gender-related impact of rural electrification and renewable energy and to adapt this methodology to the project.

The Rural Electrification Board, Bangladesh now invites eligible consulting firms and individual consultants to indicate their interest in providing the services. Interested consulting firms must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consulting firms may associate to enhance their qualifications, but should mention whether the association is in the form of "joint-venture" or of "sub-consultancy". In the case of an association, all members of such "association" should have real and well-defined inputs to the assignments and it is preferable to limit the total number of firms including the associates to a maximum of four.

A consulting firm will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers, January 1997 (Revised September 1997, January 1999 and May 2002).
