BNP leader chopped to death

A local BNP leader and village headman was chopped to death by unknown miscreants at village Mohimar char in Belkuchi upazila on Friday night

The victim was identified as Nuru Matobbor, 52, of Mohimar char village in Belkuchi upazila. Police sources said when he was returning home from mosque after 'Esha prayer at about 8:30pm a gang of unknown miscreants numbering about 8/9 chopped

He was critically injured and admitted to Belkuchi Health Complex. Later his condition was deteriorated and he was rushed to Sirajganj General Hospital where the on-duty doctor declared him death. The autopsy was done at Sirajganj General Hospital. A case was lodged with Belkuchi police station.

Teenage boy killed in Sunamganj

A teenage boy was killed and five people, including two women, were injured in a clash at Sania village in Doarabazaar upazila Tuesday.

Police said the clash took place following a quarrel between two little boys Monday leaving six people injured. Of them, Suzon Mia, 19, died on way to hospital. Five others were admitted to Doara Hospital. Police arrested six people in connection with the

12 killed in Magura in 6 months

Twelve people were killed in Magura in last six months till June, according to police

Of the deaths, four were reported from Sadar, three each from Shalikha and Sreepur and two from Mohammadpur upazilas. Besides, eight women and little girls were raped and 20 people were abducted in Magura during the period.

Election to Kamalganj Municipality in Moulvibazar will be held on July

After submission of nomination papers candidates for the posts of chairman and commissioner have started wooing the general voters. The voters in general are showing keen interest as Kamalganj is a new municipality where the municipal election isgoing to be held for the

According to the Returning Officer who is also the Upazila Nirbahi Officer (UNO) of Kamalganj upazila, a total of nine candidates for the post of chairman and 49 candidates for the post of commissioners have submitted their nomination papers. But during scrutiny two nomination papers of the candidates for the post of commissioners have been cancelled due to legal grounds.

The Returning Officer further informed that three candidates for the post of chairman and six ward commissioner candidates have withdrawn their nomination papers on the last date of withdrawal of nomination on July 1.

The chairman candidates who are now in the final race are Md Muhibur Rahman Chashi (BNP), Hasan Afroz Chowdhury (BNP), Prof Rafiqur Rahman of Awami League (AL), Abdul Muneen Tarafder (AL), Advocate Azadur Rahman (AL) and Advocate Amirul Islam Ponki (AL).

The ward commissioner candidates are: Ward No 1: Hazi Md Abu Bakar, Gouranga Kumer Deb, Mono Ranjan Ghose and Mainul Islam Khan. Ward No 2: Md Mushaheed

Ali, Md Jahirul Islam, Hazi Md Motiur Rahman, Sawkat Hussain, Hasan Sarwar Chowdhury, Md Abul Hussain and Md Held Miah. Ward No 3: Nayeb Subeder (retd) Arshad Miah, Rushan Miah, Jahirul Hasan Chowdhury, Syed Anwar Uddin and Abdul Matin. Seat No-2 (Ward No-4,5,6) Mumtaz Begum, Parul Bala Roy, Dilara Begum and Pukhshana Begum. Seat No-3 (Ward No-7,8,9) Chhjanda Begum, Anwara Begum and Salma Begum.

More than one candidate from two major political parties Bangladesh Nationalist Party (BNP) and Awami Legue (AL) have submitted nomination papers for the post of chairman of Kamalgonj

Kamalganj is a stronghold of AL. Kamalganj Municipality is under the constituency of Vice Principal Md Abdus Shaheed, Chief Whip of the opposition in parliament. Of the total six chairman candidates of this municipality, four of them are actively involved with AL.

Kamalganj upazila AL has given support to Prof Rafiqur Rahman who was the upazila chairman of Kamalgani in 1989-90. The upazila AL Committee requested other three candidates to withdraw their nomination papers, but they refused to comply with.

According to observation AL supporter voters are divided on the issue of the party chairman candida-

On the other hand two BNP leaders have submitted nomination papers for the post of chairman. In the final race they will contest against each other.

Kamalganj upazila BNP led fourparty alliance has nominated Md Muhibur Rahman Chashi as their candidate. Chashi is the existing chairman of Kamalganj Union Parishad (UP)

However, the voters in general say that a tough contest will be held between AL leader Prof Rafigur Rahma and BNP leader Muhibur Rahman Chashi for the post of

All the ward commissioner candidates are contesting independently and two major parties have no headache with the commissioner candidates

The total area of Kamalganj Municipality is 9.83 square kilometre and the total number of voters are eight thousand nine hundred

Allotment of *khas* land suspended in hill dists

Chittagong Hill Tracts Affairs Ministry and Land Ministry have asked the Deputy Commissioners of Bandarban, Khagrachhari and Rangamati to stop allotment of khas land in the region.

The decision came following allotment of hundred of acres of land

to an influential group for 100 years by the district administration under an old law in the name of rubber cultivation and horticulture without permission from the district coun-

As per the Local Government Council Act 1989, the district councils are responsible for handling all kinds of land activities.

But the councils refrained from giving any decision to land-related activities leaving some 13,000 cases pending.

Miscreants killed one youth Manik Akon, 25, at Jamirtala village in Bhandaria upazila of Pirojpur on June 24 by a sharp weapon, when he was returning home at night, police said.

Separate cases have been filed in connection with the incidents. But police is yet to take any action to round up the criminals.

The accused miscreants, on the other hand, have been threatening the victims to withdraw their cases. As a result, the affected people have now-a-days taken shelter in hidden places due to fear of the criminals.
